RE: SB 5505 – Support for OSCIM and SRGP

Co-Chair Girod, Co-Chair Holvey and members of the Subcommittee:

On behalf of COSA's 2300+ statewide members, I submitted the list of K-12 projects that will be funded (pending a few final local elections results) as a result of your investments in the Oregon School Capital Improvement Matching Program (OSCIM), which is housed at the Oregon Department of Education, and the Seismic Rehabilitation Grant Program (SRGP), which is housed at Business Oregon.

Over 130 K-12 seismic rehabilitation projects are or will be in process as a result of your \$175 million dollar investment in SRGP during the 2015-17 biennium. And as many as 30+ districts will receive a bond matching grant through the OSCIM program as a result of the \$125 million dollar investment you made during the 2015-17 biennium (pending the May 16 election results.)

These investments have begun to make a serious dent in the facilities needs of our K-12 schools and have made an immeasurably positive impact across the state for students and local communities. But there is still a significant need for further investments.

We urge your support for the SB 5505 to continue these investments. We want to be able to report back in two years another list of schools made seismically safe for students and communities that were able to pass a bond as a result of state matching funds. The bond funds in SB 5505 are critical to that effort.
