## How to Improve foster care system?

- Mediate before foster kiddo gets into home house rules, expectations, etc
- Consistency in mental health moving psychiatrists
- First 24 hours of care getting supplies that you need (enough formula to last a full evening). Initial supply at least last 24 hours
- Agency inconsistency quality and frequency different, some lack services and skills training
- Shelda Information on medical needs for children diagnosis, medications. Data base for primary care providers
- Parent meeting with foster parents and parents within one week of placement mediation, partnership
- Linda Training 24 hours of foundation training not enough, trauma-informed
- Day care at training
- Therapeutic foster care can't place siblings together, don't have access to case notes
- Trainings are not personalized, appropriate to your individual child
- Mentor parenting from other foster families, especially for medically intensive cases for newborns
- Christine Brown mentoring, consistency in knowing what resources are available
- Linn Travis program director CASA mult/clack training for relative foster parents
- Kenneth Wisare transition services training
- Sean Suv Director New Avenues for Youth prevent homelessness, flexibility in funding so we can developmentally assess where we are
- Angie ILP, can't use stipend to assist
- Phylis relative adoption rights
- Teen case worker Expectations for case workers to have a plan for foster youth prior to turning 18 and 19
- Matt Rasmuson central DHS how many parents are consistently invited to case worker/parent meetings
- Matthew Marion county case worker do you have foster parent support groups, helpful?
- Kenneth overturn of case workers
- Susan Seken Clackamas foster parent support group helpful
- Clatsop foster parent support group once a month, would like to see solution based discussions and mentoring what are your issues this week, what do you need
- Cherish Ferguson grace coordinator Deschutes finding and paying for child care providers, average babysitters can't handle
- Embrace Oregon customer service from agency, prompt communication, active participant and ally instead of adversary for asking questions
- Linda Carpenter from Gresham more time with caseworker and foster parent
- Debbie Albright receiving placement papers, notified of court hearings and family meetings, so many expectations on foster parents but not valued as part of team
- Jay Scalese lack of respect for foster parents, lack of funding for the system, can't get in touch with anyone
- Jillian Mckinny compensation for extremely high medical needs affects the ability to adopt my kids, adoption assistance
- Separate CANS from compensation makes it sound like you are trying to get more money, instead of more assistance for kids

- Prudent parenting federal law?
- Matthew Marion county branch DHS wellbeing team liaison researches need of children and shares with entire team
- Jennette Cook foster parent of 3. Worry about foster parents who do it for income. Compensation can't be too high. He was a dollar sign
- Shelda every mother should be paid
- Lisa foster youth connection creating prudent parent training standard
- Chip poor social work in transition, collectively negotiate with DHS
- Collectively negotiate with private agencies too
- Better communication to build better relationships between DHS and foster parent

## What could the Oregon Foster Parent Association do?

- Jenelle Moser consider the other kids in the foster parent family and consider impacts before moving
- Kristin better match kids and parents
- Sara WA county DHS case load too high, funding for statewide recruitment of foster parents,
- No low-income housing in Multnomah county, get services if they become homeless
- Charlie Schimmels bad retention rates for foster parents, less expensive to retain then replace and train. Respect, inclusiveness
- Ben Sand, foster parent Embrace Oregon recruited 160 families in last 2 years. Figure out what a collective voice looks like. Not going to happen from DHS.
- Shelda DHS needs to ask for input from OFPA, exit interview assessments. DHS provide OFPA with list to do exit interview
- Debbie Foster parents own ombudsman in Gov's office to uphold foster parent bill of rights
- Laura training for relative foster parents, how to avoid allegations
- Mckinny Protocol or accountability when case workers don't follow procedures. Enforcement
- Notification when visits are cancelled, pressure to be perfect when bio parent and DHS don't have to be perfect
- CASA director curry county communication to foster parents

## What would make you join OFPA?

- Learn about other states, not reinvent wheel, waiting list for foster kids in New Jersey
- Ferguson what can other agencies do or contract out of DHS? contract for services to do the certification
- Working with Embrace Oregon to get day care at trainings, some smaller goals to show progress
- Jenelle, foster parent WA county need more people saying the same thing, not sure I will be heard, tired of being told no
- Jeanette automatically enrolled in OMSI, children theater play therapy

- Chip Reduced price for legal services for members

- Respite care needed at reduced price. Needing DHS funding for respite care
- Jim WA county look at other models, day care program connected to child welfare office that foster parents don't have to pay for, so they can drop them off while foster parent has respite or errands
