TERM: Three-year terms: July 1, 2017 – June 30, 2020

STATUTORY QUALIFICATIONS: **ORS 675.100**

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Nine members appointed by the Governor to three year terms commencing July 1:
 - Six residents of Oregon with doctoral or master's degrees with primary emphasis in psychology and properly licensed (**BJORKQUIST, GROVER, JENKINS, JOHANNSEN, NISHI-STRATTNER, SMITH**)
 - Three public members who are Oregon residents (**MELLON, SALINAS, WEINER**)
- All members must be residents of the state, be geographically and ethnically diverse
- A board member shall be removed immediately if the member is not a resident of the state, has been absent from three consecutive board meetings, without at least one excused absence, and not licensed and good standing at time of retirement
- Members required to subscribe to oath of office
- One consecutive reappointment only
- Members serve at the pleasure of the Governor

DUTIES AND AUTHORITY: **ORS 675.110, 675.130, 675.150**

- Regulate practice of psychology through qualification of applicants, granting or denial of renewals, and disciplinary proceedings, including the ability to issue civil penalties
- Formulate code of conduct
- Establish standards for training and continuing education
- Collect license fees
- Maintain register of all living psychologists licensed under ORS 675.010 to 675.150
- May institute injunction proceedings to enjoin unlawful practice of psychology in Oregon
- Elect chairperson
