SUMMARY

Limits, for purposes of personal income taxation, availability of itemized deductions.

Applies to tax years beginning on or after January 1, 2018.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

1
2 Relating to itemized deductions; creating new provisions; amending ORS
3 316.695; and prescribing an effective date.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 316.695 is amended to read:

6 316.695. (1) In addition to the modifications to federal taxable income
7 contained in this chapter, there shall be added to or subtracted from federal
8 taxable income:

9 (a) If, in computing federal income tax for a tax year, the taxpayer de-
10 ducted itemized deductions, as defined in section 63(d) of the Internal Reve-
11 nue Code, the taxpayer shall add the amount of itemized deductions deducted
12 (the itemized deductions less an amount, if any, by which the itemized de-
13 ductions are reduced under section 68 of the Internal Revenue Code).

14 (b) If, in computing federal income tax for a tax year, the taxpayer de-
15 ducted the standard deduction, as defined in section 63(c) of the Internal
16 Revenue Code, the taxpayer shall add the amount of the standard deduction
17 deducted.

18 (c)(A) From federal taxable income there shall be subtracted the larger
19 of (i) the taxpayer's itemized deductions, **reduced as provided in paragraph**
20 **(d) of this subsection**, or (ii) a standard deduction. Except as provided in

1 subsection (8) of this section, for purposes of this subparagraph, “standard
2 deduction” means the sum of the basic standard deduction and the additional
3 standard deduction.

4 (B) For purposes of subparagraph (A) of this paragraph, the basic stand-
5 ard deduction is:

- 6 (i) \$3,280, in the case of joint return filers or a surviving spouse;
- 7 (ii) \$1,640, in the case of an individual who is not a married individual
8 and is not a surviving spouse;
- 9 (iii) \$1,640, in the case of a married individual who files a separate return;
10 or
- 11 (iv) \$2,640, in the case of a head of household.

12 (C)(i) For purposes of subparagraph (A) of this paragraph for tax years
13 beginning on or after January 1, 2003, the Department of Revenue shall an-
14 nually recompute the basic standard deduction for each category of return
15 filer listed under subparagraph (B) of this paragraph. The basic standard
16 deduction shall be computed by dividing the monthly averaged U.S. City
17 Average Consumer Price Index for the 12 consecutive months ending August
18 31 of the prior calendar year by the average U.S. City Average Consumer
19 Price Index for the second quarter of 2002, then multiplying that quotient
20 by the amount listed under subparagraph (B) of this paragraph for each
21 category of return filer.

22 (ii) If any change in the maximum household income determined under
23 this subparagraph is not a multiple of \$5, the increase shall be rounded to
24 the next lower multiple of \$5.

25 (iii) As used in this subparagraph, “U.S. City Average Consumer Price
26 Index” means the U.S. City Average Consumer Price Index for All Urban
27 Consumers (All Items) as published by the Bureau of Labor Statistics of the
28 United States Department of Labor.

29 (D) For purposes of subparagraph (A) of this paragraph, the additional
30 standard deduction is the sum of each additional amount to which the tax-
31 payer is entitled under subsection (7) of this section.

1 (E) As used in subparagraph (B) of this paragraph, “surviving spouse” and
2 “head of household” have the meanings given those terms in section 2 of the
3 Internal Revenue Code.

4 (F) In the case of the following, the standard deduction referred to in
5 subparagraph (A) of this paragraph shall be zero:

6 (i) One of the spouses in a marriage filing a separate return where the
7 other spouse has claimed itemized deductions under subparagraph (A) of this
8 paragraph;

9 (ii) A nonresident alien individual;

10 (iii) An individual making a return for a period of less than 12 months
11 on account of a change in the individual’s annual accounting period;

12 (iv) An estate or trust;

13 (v) A common trust fund; or

14 (vi) A partnership.

15 (d) For the purposes of paragraph (c)(A) of this subsection, the taxpayer’s
16 itemized deductions are the amount of the taxpayer’s itemized deductions as
17 defined in section 63(d) of the Internal Revenue Code (reduced, if applicable,
18 as described under section 68 of the Internal Revenue Code) minus the de-
19 duction for Oregon income tax (reduced, if applicable, by the proportion that
20 the reduction in federal itemized deductions resulting from section 68 of the
21 Internal Revenue Code bears to the amount of federal itemized deductions
22 as defined for purposes of section 68 of the Internal Revenue Code), **but may**
23 **not exceed 95 percent of the amount allowed on the taxpayer’s federal**
24 **income tax return.**

25 (2)(a) There shall be subtracted from federal taxable income any portion
26 of the distribution of a pension, profit-sharing, stock bonus or other retire-
27 ment plan, representing that portion of contributions which were taxed by
28 the State of Oregon but not taxed by the federal government under laws in
29 effect for tax years beginning prior to January 1, 1969, or for any subsequent
30 year in which the amount that was contributed to the plan under the Inter-
31 nal Revenue Code was greater than the amount allowed under this chapter.

1 (b) Interest or other earnings on any excess contributions of a pension,
2 profit-sharing, stock bonus or other retirement plan not permitted to be de-
3 ducted under paragraph (a) of this subsection may not be added to federal
4 taxable income in the year earned by the plan and may not be subtracted
5 from federal taxable income in the year received by the taxpayer.

6 (3)(a) Except as provided in subsection (4) of this section, there shall be
7 added to federal taxable income the amount of any federal income taxes in
8 excess of the amount provided in paragraphs (b) to (d) of this subsection,
9 accrued by the taxpayer during the tax year as described in ORS 316.685, less
10 the amount of any refund of federal taxes previously accrued for which a tax
11 benefit was received.

12 (b) The limits applicable to this subsection are:

13 (A) \$5,500, if the federal adjusted gross income of the taxpayer for the tax
14 year is less than \$125,000, or, if reported on a joint return, less than \$250,000.

15 (B) \$4,400, if the federal adjusted gross income of the taxpayer for the tax
16 year is \$125,000 or more and less than \$130,000, or, if reported on a joint
17 return, \$250,000 or more and less than \$260,000.

18 (C) \$3,300, if the federal adjusted gross income of the taxpayer for the tax
19 year is \$130,000 or more and less than \$135,000, or, if reported on a joint
20 return, \$260,000 or more and less than \$270,000.

21 (D) \$2,200, if the federal adjusted gross income of the taxpayer for the tax
22 year is \$135,000 or more and less than \$140,000, or, if reported on a joint
23 return, \$270,000 or more and less than \$280,000.

24 (E) \$1,100, if the federal adjusted gross income of the taxpayer for the tax
25 year is \$140,000 or more and less than \$145,000, or, if reported on a joint
26 return, \$280,000 or more and less than \$290,000.

27 (c) If the federal adjusted gross income of the taxpayer is \$145,000 or more
28 for the tax year, or, if reported on a joint return, \$290,000 or more, the limit
29 is zero and the taxpayer is not allowed a subtraction for federal income taxes
30 under ORS 316.680 (1) for the tax year.

31 (d) In the case of spouses in a marriage filing separate tax returns, the

1 amount added shall be in the amount of any federal income taxes in excess
2 of 50 percent of the amount provided for individual taxpayers under para-
3 graphs (a) to (c) of this subsection, less the amount of any refund of federal
4 taxes previously accrued for which a tax benefit was received.

5 (e) For purposes of this subsection, the limits applicable to a joint return
6 shall apply to a head of household or a surviving spouse, as defined in sec-
7 tion 2(a) and (b) of the Internal Revenue Code.

8 (f)(A) For a calendar year beginning on or after January 1, 2008, the De-
9 partment of Revenue shall make a cost-of-living adjustment to the federal
10 income tax threshold amounts described in paragraphs (b) and (d) of this
11 subsection.

12 (B) The cost-of-living adjustment for a calendar year is the percentage by
13 which the monthly averaged U.S. City Average Consumer Price Index for the
14 12 consecutive months ending August 31 of the prior calendar year exceeds
15 the monthly averaged index for the period beginning September 1, 2005, and
16 ending August 31, 2006.

17 (C) As used in this paragraph, "U.S. City Average Consumer Price
18 Index" means the U.S. City Average Consumer Price Index for All Urban
19 Consumers (All Items) as published by the Bureau of Labor Statistics of the
20 United States Department of Labor.

21 (D) If any adjustment determined under subparagraph (B) of this para-
22 graph is not a multiple of \$50, the adjustment shall be rounded to the next
23 lower multiple of \$50.

24 (E) The adjustment shall apply to all tax years beginning in the calendar
25 year for which the adjustment is made.

26 (4)(a) In addition to the adjustments required by ORS 316.130, a full-year
27 nonresident individual shall add to taxable income a proportion of any ac-
28 crued federal income taxes as computed under ORS 316.685 in excess of the
29 amount provided in subsection (3) of this section in the proportion provided
30 in ORS 316.117.

31 (b) In the case of spouses in a marriage filing separate tax returns, the

1 amount added under this subsection shall be computed in a manner consist-
2 ent with the computation of the amount to be added in the case of spouses
3 in a marriage filing separate returns under subsection (3) of this section. The
4 method of computation shall be determined by the Department of Revenue
5 by rule.

6 (5) Subsections (3)(d) and (4)(b) of this section shall not apply to married
7 individuals living apart as defined in section 7703(b) of the Internal Revenue
8 Code.

9 (6)(a) For tax years beginning on or after January 1, 1981, and prior to
10 January 1, 1983, income or loss taken into account in determining federal
11 taxable income by a shareholder of an S corporation pursuant to sections
12 1373 to 1375 of the Internal Revenue Code shall be adjusted for purposes of
13 determining Oregon taxable income, to the extent that as income or loss of
14 the S corporation, they were required to be adjusted under the provisions
15 of ORS chapter 317.

16 (b) For tax years beginning on or after January 1, 1983, items of income,
17 loss or deduction taken into account in determining federal taxable income
18 by a shareholder of an S corporation pursuant to sections 1366 to 1368 of the
19 Internal Revenue Code shall be adjusted for purposes of determining Oregon
20 taxable income, to the extent that as items of income, loss or deduction of
21 the shareholder the items are required to be adjusted under the provisions
22 of this chapter.

23 (c) The tax years referred to in paragraphs (a) and (b) of this subsection
24 are those of the S corporation.

25 (d) As used in paragraph (a) of this subsection, an S corporation refers
26 to an electing small business corporation.

27 (7)(a) The taxpayer shall be entitled to an additional amount, as referred
28 to in subsection (1)(c)(A) and (D) of this section, of \$1,000:

29 (A) For the taxpayer if the taxpayer has attained age 65 before the close
30 of the taxpayer's tax year; and

31 (B) For the spouse of the taxpayer if the spouse has attained age 65 before

1 the close of the tax year and an additional exemption is allowable to the
2 taxpayer for such spouse for federal income tax purposes under section 151(b)
3 of the Internal Revenue Code.

4 (b) The taxpayer shall be entitled to an additional amount, as referred to
5 in subsection (1)(c)(A) and (D) of this section, of \$1,000:

6 (A) For the taxpayer if the taxpayer is blind at the close of the tax year;
7 and

8 (B) For the spouse of the taxpayer if the spouse is blind as of the close
9 of the tax year and an additional exemption is allowable to the taxpayer for
10 such spouse for federal income tax purposes under section 151(b) of the
11 Internal Revenue Code. For purposes of this subparagraph, if the spouse dies
12 during the tax year, the determination of whether such spouse is blind shall
13 be made immediately prior to death.

14 (c) In the case of an individual who is not married and is not a surviving
15 spouse, paragraphs (a) and (b) of this subsection shall be applied by substi-
16 tuting "\$1,200" for "\$1,000."

17 (d) For purposes of this subsection, an individual is blind only if the
18 individual's central visual acuity does not exceed 20/200 in the better eye
19 with correcting lenses, or if the individual's visual acuity is greater than
20 20/200 but is accompanied by a limitation in the fields of vision such that
21 the widest diameter of the visual field subtends an angle no greater than 20
22 degrees.

23 (8) In the case of an individual with respect to whom a deduction under
24 section 151 of the Internal Revenue Code is allowable for federal income tax
25 purposes to another taxpayer for a tax year beginning in the calendar year
26 in which the individual's tax year begins, the basic standard deduction (re-
27 ferred to in subsection (1)(c)(B) of this section) applicable to such individual
28 for such individual's tax year shall equal the lesser of:

29 (a) The amount allowed to the individual under section 63(c)(5) of the
30 Internal Revenue Code for federal income tax purposes for the tax year for
31 which the deduction is being claimed; or

1 (b) The amount determined under subsection (1)(c)(B) of this section.

2 **SECTION 2. The amendments to ORS 316.695 by section 1 of this**
3 **2017 Act apply to tax years beginning on or after January 1, 2018.**

4 **SECTION 3. This 2017 Act takes effect on the 91st day after the date**
5 **on which the 2017 regular session of the Seventy-ninth Legislative**
6 **Assembly adjourns sine die.**
