Department of Revenue

Major tax programs:

- Income programs—personal and corporate.
- Property tax administration.
- Cigarette and other tobacco.
- Marijuana.
- Other taxes (estate transfer, state lodging, 9-1-1, etc.).
- Other Agency Accounts (OAA) and other partnerships.
- Assistance programs (senior and disabled deferral, non-profit homes property tax exemption).



Revenue's major tax programs

Income taxes—personal, corporate

- Education
- Assistance

Property tax

- County support, assistance, and oversight.
- Industrial and centrally assessed property valuation.

Cigarette and other tobacco taxes

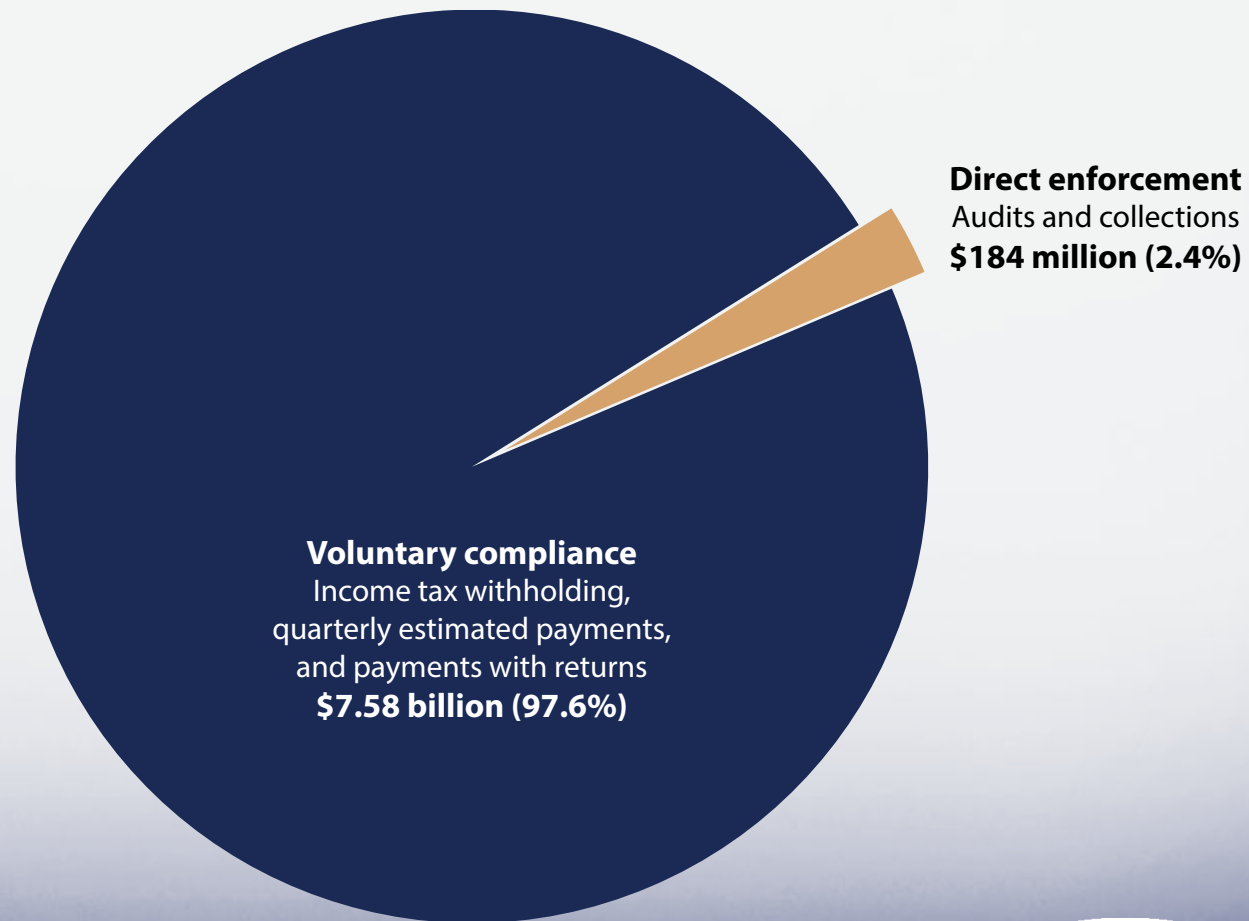
- Distributor, wholesaler, retailer, consumer compliance.

Personal income tax revenues

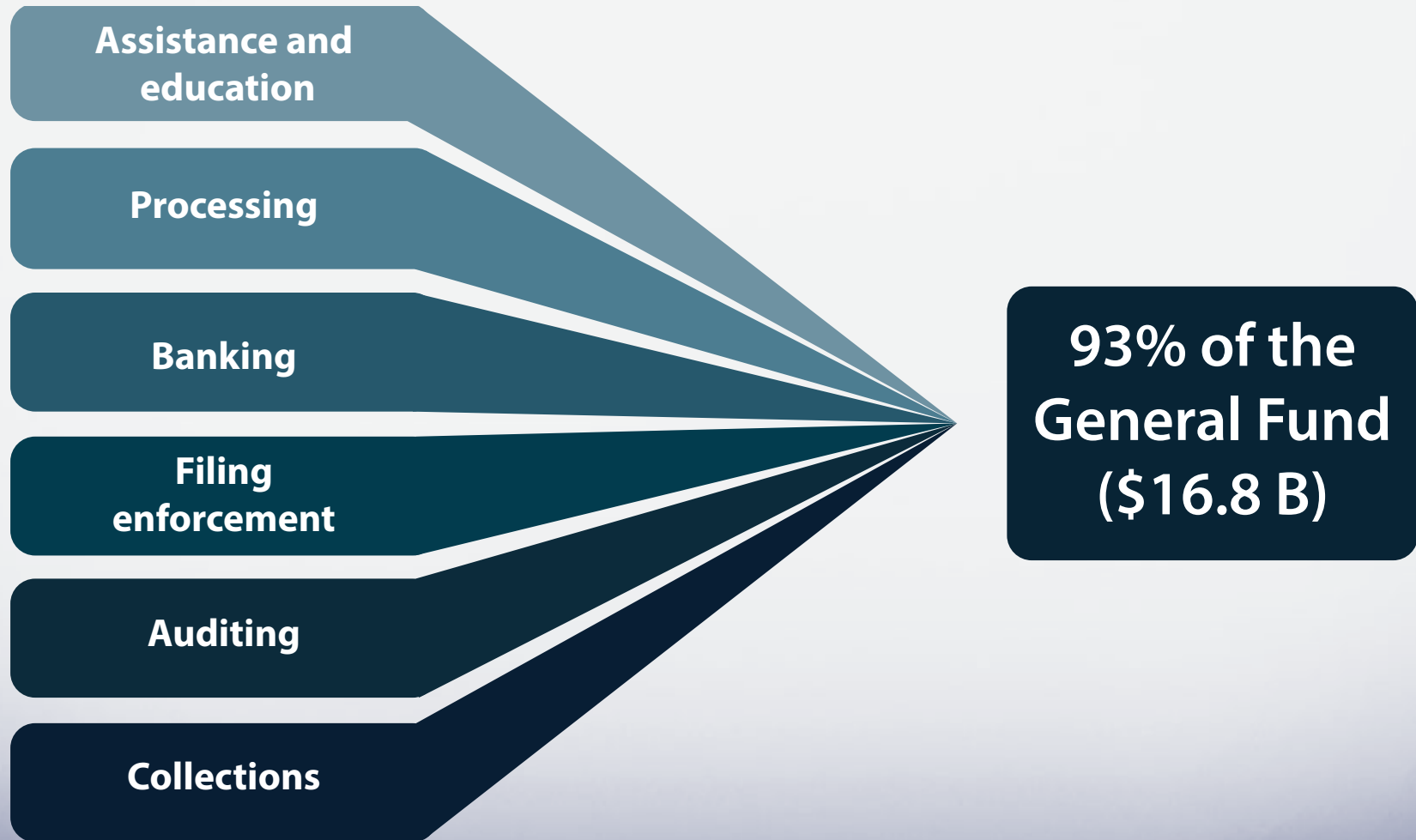
How they're paid

Income tax programs' revenue

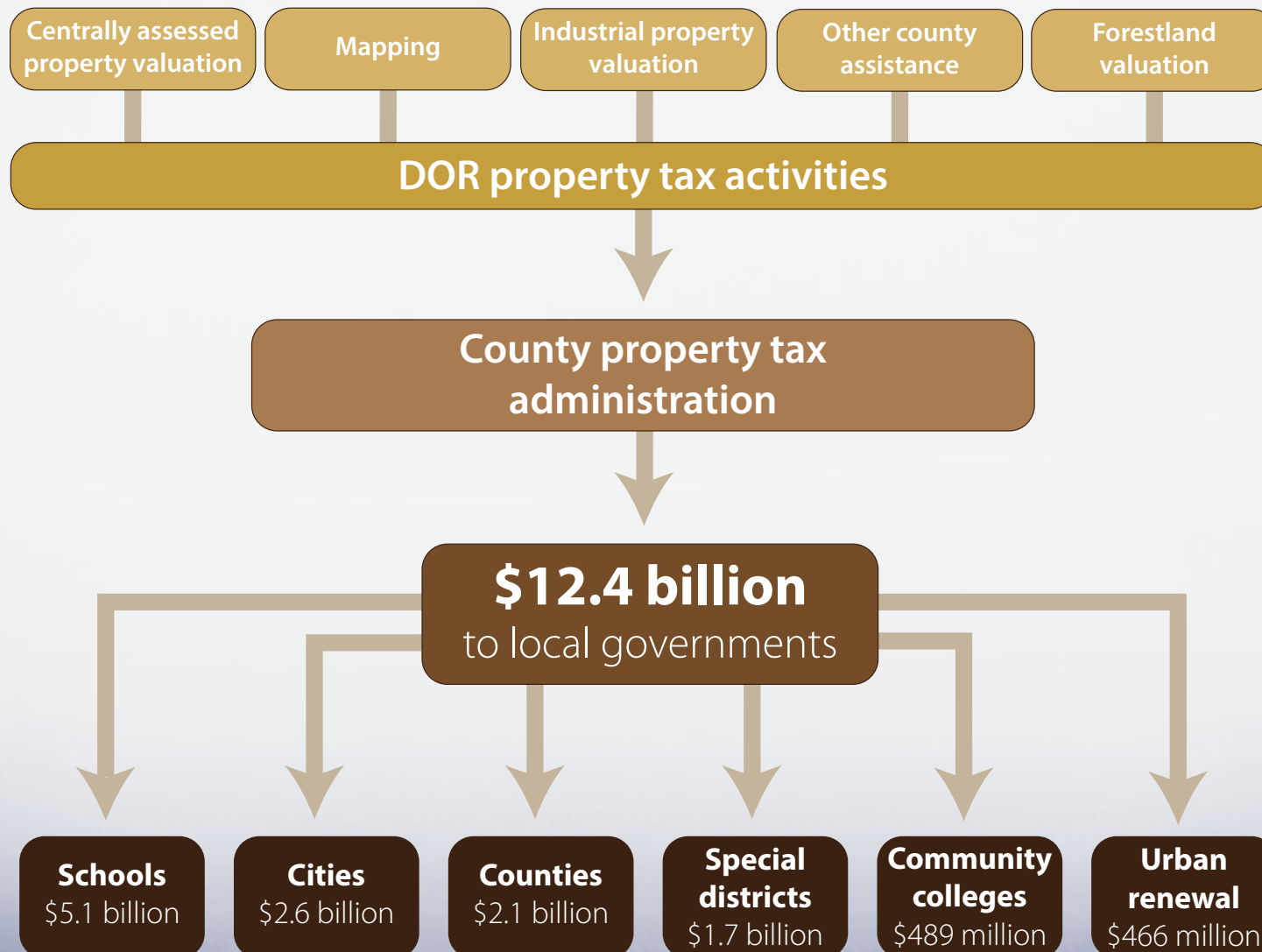

- Primary administration of all aspects of the system.

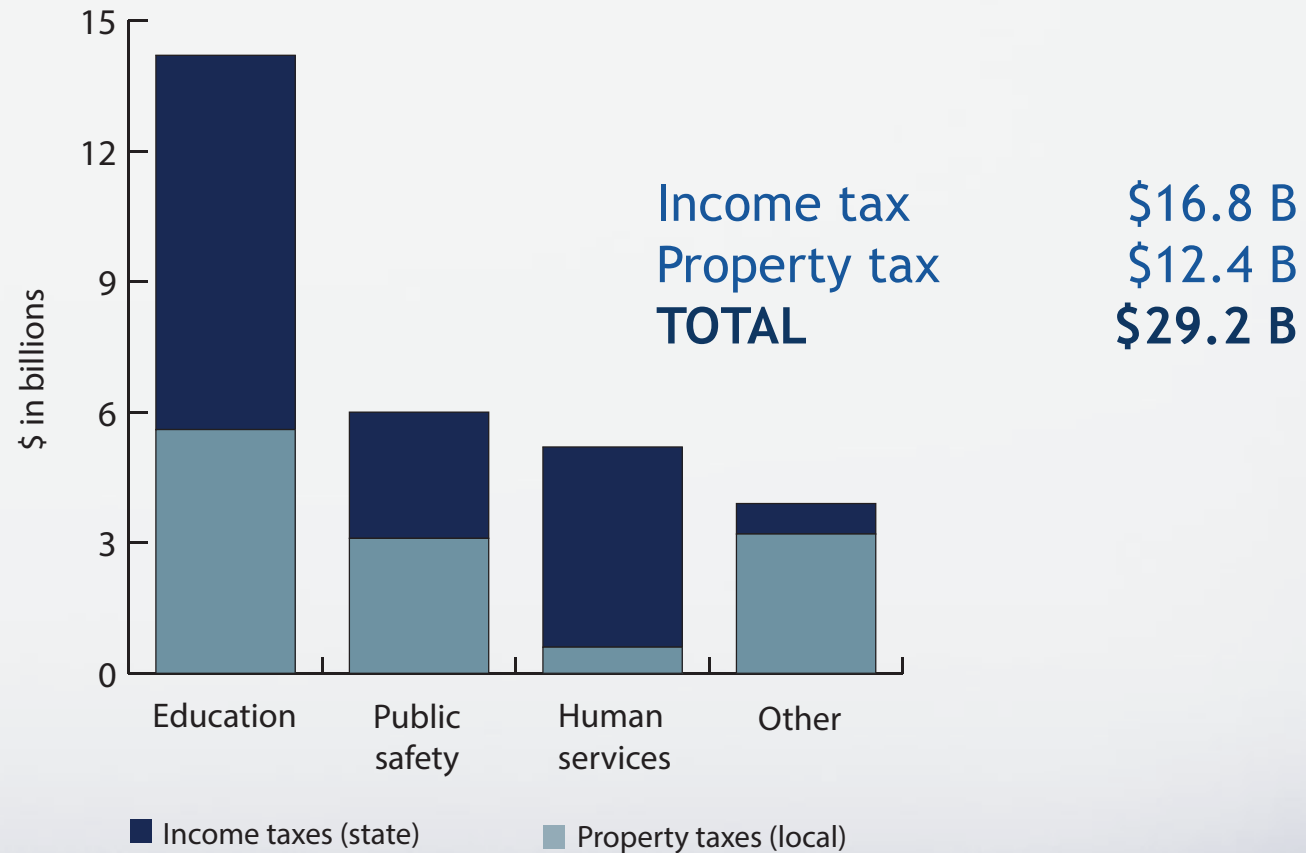
Role of Department of Revenue.

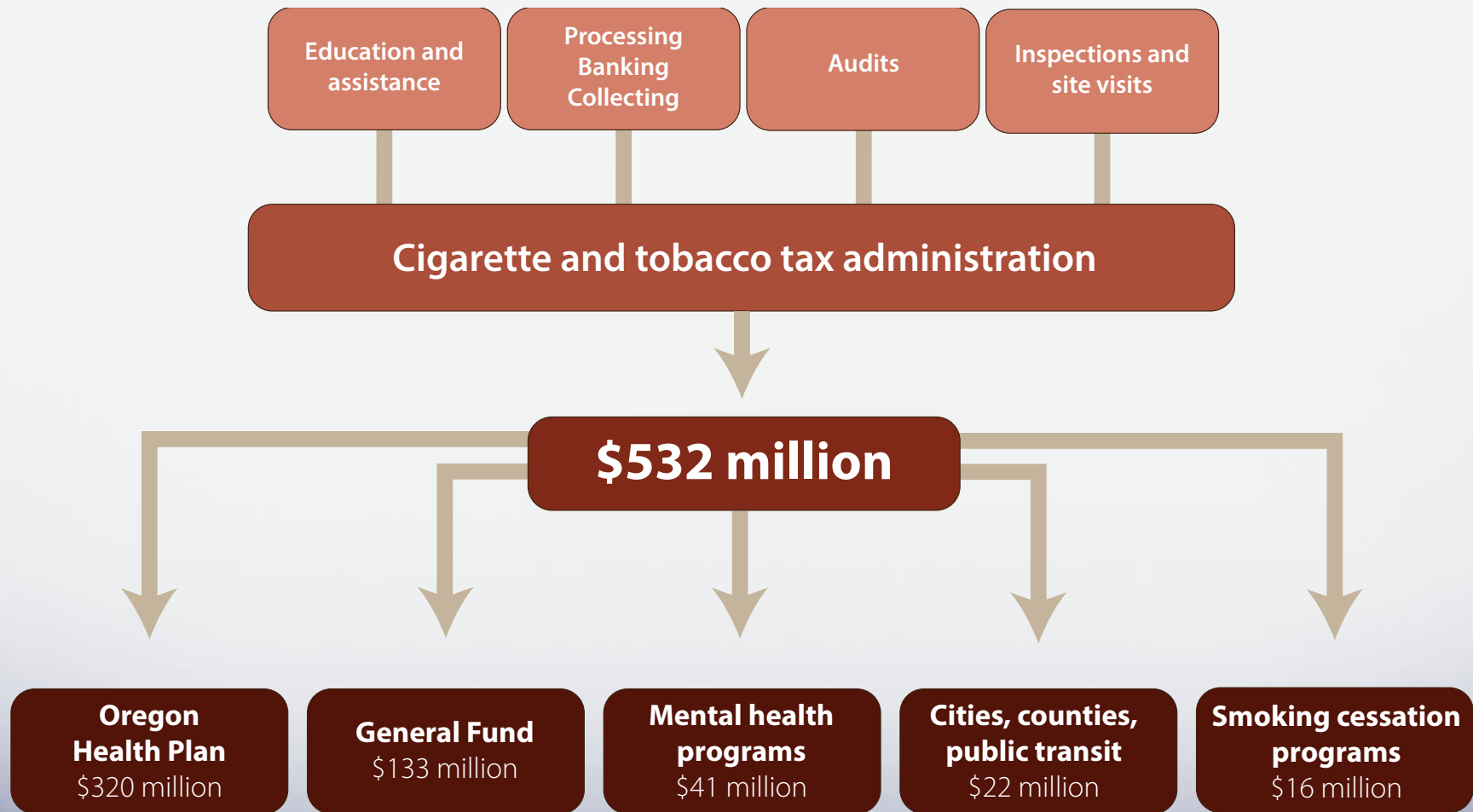

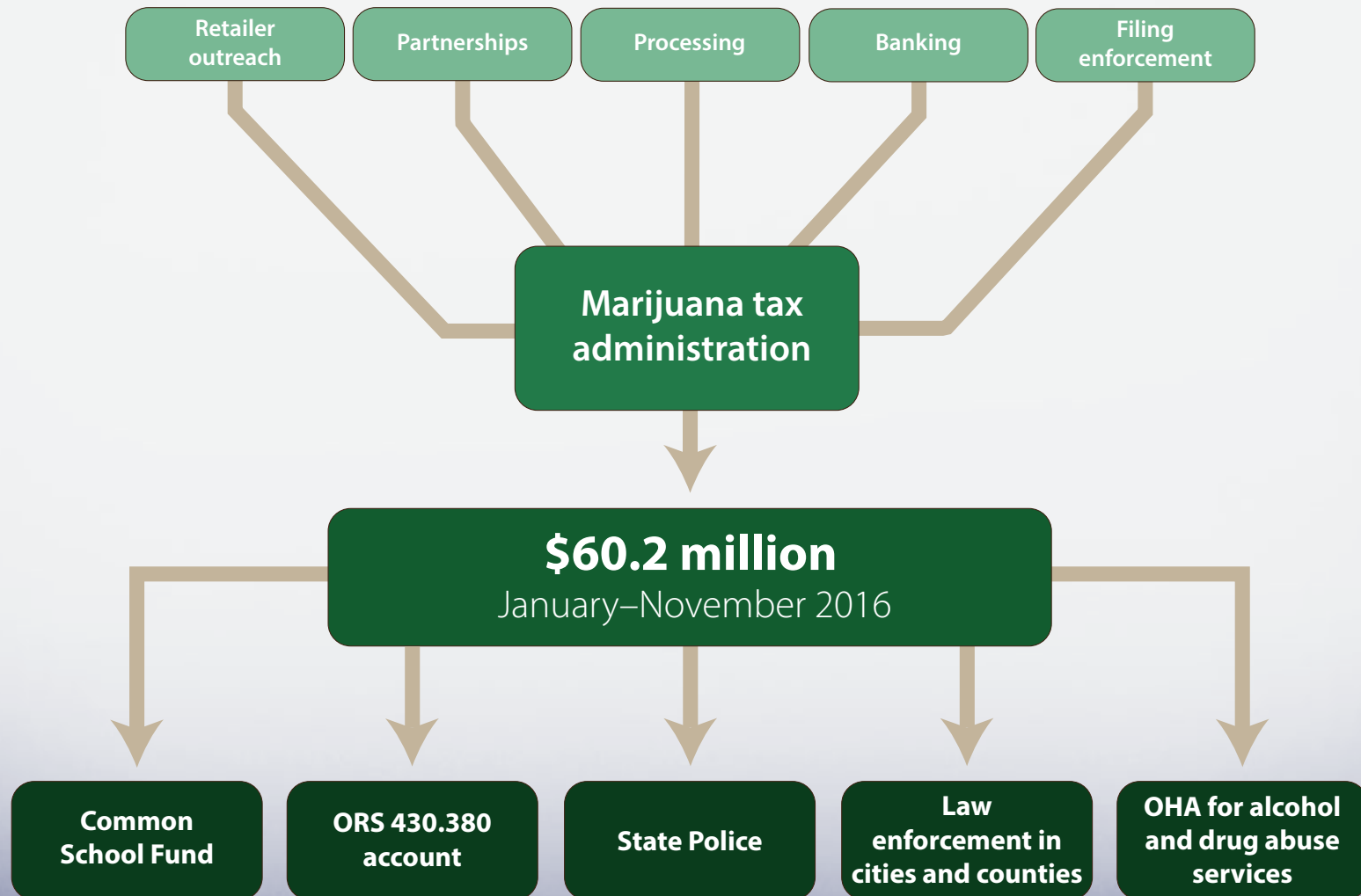

Core Systems Replacement

Four phase IT project to replace systems that service our core functions.

2014—Corporate, Cigarette, and Other Tobacco products.

2015—Personal Income tax, transit self-employment, property tax deferral, E-911, partnership returns, pass-through entity returns, Fiduciary/Estate.

2016—Withholding tax, transit payroll, Other Agency Accounts, Marijuana tax, State Lodging tax, petroleum load fee, hazardous substances fee.

2017—CAFFA, Forest Products Harvest Tax, small tract forestland severance tax, private rail car, court fines and assessments, among other small programs.

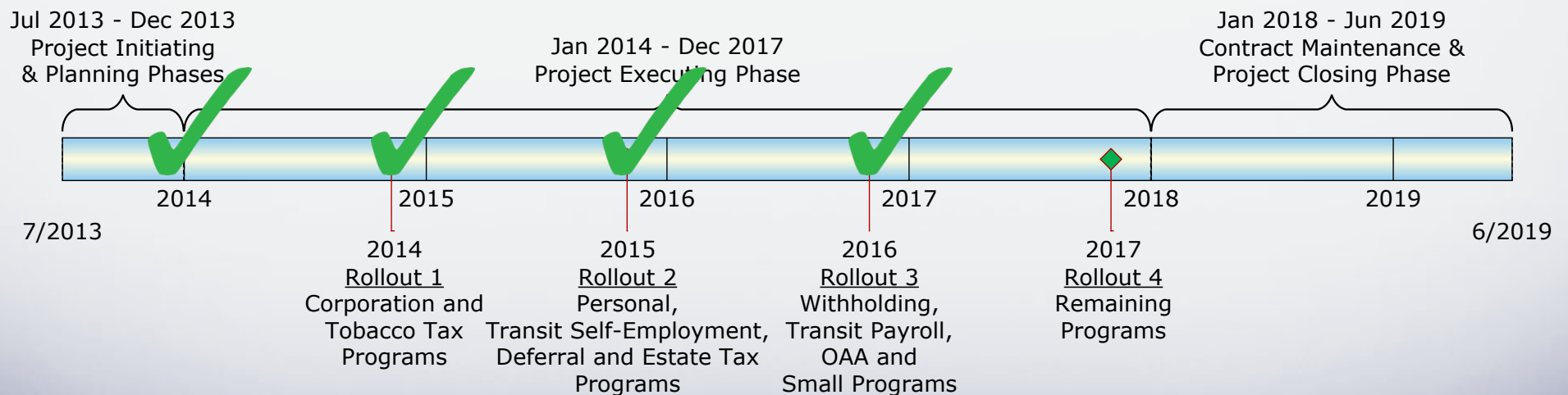


Project overview

Business case:

- Avoid risk and improve performance.
- Commercial off-the-shelf solution (COTS).

Effects of GenTax

In addition to our existing requirements, GenTax allows additional functionality, including:

- Real time processing.
- Risk scoring (refund review).
- View exact copy of correspondence.
- Enhanced online services.
- Drill down features from multiple screens.
- View original and amended returns.

System is complex which requires us to do some work differently (e.g. exporting data out of GenTax).



PVS project overview

A computer-assisted mass appraisal (CAMA) system will:

- Integrate our appraisal functions into one system.
- Allow for electronic communication with taxpayers and counties.
- Provide data analytic capabilities.
- Reduce reliance on paper documents and manual data entry.
- Provide a stable, long-term information technology platform for the department's valuation functions.



PVS current status

Vendor Selection

- Round three (of five) of the selection process.

Staffing

- Project co-directors—Revenue staff.
- IT business analyst—Revenue staff.
- Project managers (PM)—Third-party.
- Quality assurance (QA)—Third-party.

Stage Gate

- Stage Gate 1—Approved February 17, 2016.
- Stage Gate 2—Approved July 26, 2016.



Governor's 2017-19 budget

Proposed revenue increases administered by Department of Revenue:

- Increase cigarette tax by \$.85 per pack (\$21.5 million).
- Other Tobacco Products tax increases (\$13.7 million).
 - Cigars—increase by \$0.50 each.
 - Moist snuff—increase by \$0.89 per ounce.
 - All others—increase by \$0.10.
- Eliminate partnership pass-through (\$177 million).
- Eliminate IC-DISC dividend subtraction (\$6 million).



Governor's 2017-19 budget

Revenue increases administered by:

Oregon Liquor Control Commission (OLCC)

- Increase surcharge on distilled spirits by \$0.50 (\$33.8 million).
- Increase alcohol licensing fees by 100 percent (\$5.3 million).
 - No increase to server permits.
 - Licensing fees range from \$100 to \$500.

Oregon Health Authority

- Provider assessment—workgroup developing options.



Governor's 2017-19 budget

Tax expenditures recommended for extension:

- Film production labor rebate.
- Transportation projects.
- Fish screening devices.
- Fire insurance.
- Rural medical practice.
- Livestock killed by wolves.
- Long-term rural enterprise zone facilities.
- Reservation enterprise zone.
- Electronic commerce enterprise zone.
- Alternative energy system*

* Property tax expenditure (all others income tax expenditures).
