## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Removes requirement that Higher Education Coordinating Commission's annual evaluation of public universities include annual evaluation of each university. Requires that each university be evaluated by commission once every two years.

Removes April 1 deadline for public universities to submit biennial funding request to commission.

**Requires commission to submit budget request including funding for any activities public universities are allowed or required by law to perform.**

**Permits public universities to disclose student Social Security number if required by law to do so.**

**Requires public university governing boards to meet four times per year rather than quarterly.**

**Permits Governor to stagger terms of members of public university governing boards.**

**Removes statutory references to both universities with governing boards and universities without governing boards.**

8 55, chapter 117, Oregon Laws 2016, is amended to read:

11 (2) The Higher Education Coordinating Commission shall be guided by the legislative findings

28 350.095. (1) The Higher Education Coordinating Commission is authorized to:

29 (a) Request, as part of the funding request under ORS 350.090, appropriations for budgetary  
30 items, including but not limited to education and general operations, statewide public services, state  
31 funded debt service, capital improvements, deferred maintenance, special initiatives and investments  
32 **or any other purpose listed under ORS 350.075 (3)(e);** and

33 (b) Allocate moneys, from funds appropriated to the commission and other available moneys, to  
34 public universities listed in ORS 352.002.

35 (2) The commission shall certify to the Legislative Assembly, in any funding request pursuant  
36 to subsection (1)(a) of this section for state bonds under Article XI-F(1) of the Oregon Constitution  
37 for the benefit of a public university listed in ORS 352.002, its evaluation of the revenue sufficiency,  
38 as defined in ORS 286A.830, of the public university that will receive the proceeds of any Article  
39 XI-F(1) bonds approved by the Legislative Assembly.

40 **SECTION 4.** ORS 350.090, as amended by section 57, chapter 117, Oregon Laws 2016, is  
41 amended to read:

42 350.090. *[(1)(a) On or before April 1 of each even-numbered year, each public university listed in*  
43 *ORS 352.002 must submit to an office designated by the Higher Education Coordinating Commission*  
44 *as being responsible for university coordination a funding request applicable to the biennium beginning*  
45 *on July 1 of the following year; and]*

1        *[(b) On or before May 1 of each even-numbered year, the office designated under paragraph (a) of*  
2 *this subsection shall consolidate the funding requests from public universities listed in ORS 352.002*  
3 *and submit the consolidated funding requests to the Higher Education Coordinating Commission.]*

4        [(2)] (1) On or before September 1 of each even-numbered year, the Higher Education Coordi-

16 **sities listed in ORS 352.002. Each public university must be evaluated in the manner required**  
17 **by this section once every two years. As part of the evaluation submitted to the Legislative**  
18 **Assembly,** the commission may make recommendations *[to the Legislative Assembly]* regarding the  
19 ability of the university to meet academic goals and fulfill its fiduciary responsibilities.

20        (2) The evaluation must include:

21        (a) A report on the university's achievement of outcomes, measures of progress, goals and tar-

33 curity number:

34        (a) At the request of a law enforcement agency or an agency providing support enforcement  
35 services under ORS 25.080;

36        (b) After obtaining written permission for the disclosure from the student to whom the number  
37 refers;

38        (c) In the payment of wages or benefits;

39        (d) In the payment or collection of taxes or of a debt owed by the student to whom the number  
40 refers; *[or]*

41        (e) For purposes of statistical analysis[.]; **or**

42        **(f) As otherwise required by law.**

43        **SECTION 7.** ORS 352.025 is amended to read:

44        352.025. (1) The Legislative Assembly finds that the State of Oregon will benefit from having  
45 public universities with governing boards that:

1 (a) Provide transparency, public accountability and support for the university.

2 (b) Are close to and closely focused on the individual university.

3 [(c) *Do not negatively impact public universities that do not have governing boards.*]

4 [(d)] (c) Lead to greater access and affordability for Oregon residents and do not disadvantage  
5 Oregon students relative to out-of-state students.

6 [(e)] (d) Act in the best interests of both the university and the State of Oregon as a whole.

7 [(f)] (e) Promote the academic success of students in support of the mission of all education be-  
8 yond high school as described in ORS 350.014.

9 (2) The Legislative Assembly also finds that:

10 (a) Even with universities with governing boards, there are economy-of-scale benefits to having  
11 a coordinated university system.

12 (b) Even with universities with governing boards, shared services may continue to be shared  
13 among universities.

14 (c) Legal title to all real property, whether acquired before or after the creation of a governing  
15 board, through state funding, revenue bonds or philanthropy, shall be taken and held in the name  
16 of the State of Oregon, acting by and through the governing board.

17 (d) The Legislative Assembly has a responsibility to monitor the success of governing boards  
18 at fulfilling their missions, their compacts and the principles stated in this section.

19 **SECTION 8.** ORS 352.027 is amended to read:

20 352.027. Chapter 768, Oregon Laws 2013, is intended to preserve the autonomy of the **public**  
21 universities listed in ORS 352.002 [*whether they are governed by a university governing board or a*  
22 *university consortium board*].

23 **SECTION 9.** ORS 352.029 is amended to read:

24 352.029. As used in ORS 352.025 to 352.146 and 352.388 to 352.415:

25 (1) "Governing board" means a governing board of a public university listed in ORS 352.002 that  
26 manages the affairs of the university by exercising and carrying out all of the powers, rights and  
27 duties that are expressly conferred upon the governing board by law, or that are implied by law or  
28 are incident to such powers, rights and duties.

29 (2) "State bonds" means "bonds" as defined in ORS 286A.001 that are issued by the State  
30 Treasurer.

36 **SECTION 19.** ORS 352.113 is amended to read:

37 352.113. (1) Legal title to all real property acquired by a **public university listed in ORS 352.002**  
38 [*with a governing board*] must be taken and held in the name of the State of Oregon, acting by and  
39 through the governing board of **the public university**. Legal title to all real property conveyed to  
40 a **public university** [*with a governing board*] is considered to be conveyed to and vested in the State  
41 of Oregon, acting by and through the governing board. Authorized conveyances of all real property,  
42 other than university lands, acquired by or vested in the State of Oregon for the use or benefit of  
43 the university must be executed in the name of the State of Oregon, acting by and through the  
44 governing board, by the chairperson of the governing board.

 11 held in the name of the State of Oregon, acting by and through the governing board. The governing  
 12 board has custody and control of the personal property and shall care for the personal property  
 13 owned by the State of Oregon. When the Article XI-Q bonds are no longer outstanding, legal title  
 14 to the personal property automatically by operation of law transfers to and vests in the **public**  
 15 university [*with a governing board*] for whose benefit the Article XI-Q bonds were issued.

16 (4) Unless the State Treasurer has granted prior consent, real or personal property held in the  
 17 name of the State of Oregon, or in which the State of Oregon has an ownership or other legal in-

 4 lender may sublease the real property to third parties and apply any rents to payments scheduled  
 5 to be made under the operative documents.

6 (b) May not mortgage, pledge or grant a security interest in, or otherwise encumber, real or  
 7 personal property that has been pledged or leased to provide security for, or acquired, constructed,  
 8 improved with, or otherwise directly benefited by, the proceeds of outstanding state bonds, except  
 9 as provided in ORS 352.113 (4).

10 (5) Revenue bonds and other obligations authorized by this section:

11 (a) Are revenue bonds or obligations of a political subdivision of the State of Oregon.

12 (b) Are not an indebtedness or obligation of the State of Oregon and are not a charge upon re-  
 13 venue or property of the State of Oregon, except as provided in subsection (4) of this section.

14 (c) Are not a charge upon any revenue or property of a **public university listed in ORS 352.002**  
 15 [*with a governing board*] unless the revenue or property is pledged to secure the revenue bonds or  
 16 other obligations.

17 (d) Are not payable from, and may not be secured by a pledge of or lien on, any amounts a  
 18 **public university [*with a governing board*]** is required to:

19 (A) Deposit with the State Treasurer pursuant to ORS 352.135 (2); or

20 (B) Pay to the State Treasurer pursuant to a schedule described in ORS 352.415.

21 **SECTION 30.** ORS 352.415 is amended to read:

22 352.415. (1) ORS 352.388 to 352.415 do not impair the obligations, as defined in ORS 286A.100,  
 23 or agreements of the State of Oregon or the State Board of Higher Education with respect to state  
 24 bonds issued before August 14, 2013, for the benefit of a **public university [*with a governing board*]**  
 25 **listed in ORS 352.002.**

26 (2) A **public university listed in ORS 352.002 [*with a governing board*]** shall take all actions  
 27 necessary to ensure full compliance with the operative documents executed with respect to state  
 28 bonds issued before, on or after August 14, 2013, by the State Treasurer for the benefit of the **public**  
 29 university [*with a governing board*].

30 (3) The State Treasurer, in consultation with the Oregon Department of Administrative Services,  
 31 shall at least annually provide a **public university listed in ORS 352.002 [*with a governing board*]**  
 32 a schedule of outstanding state bonds and other obligations for which the university must pay, in-  
 33 cluding the payment dates and amounts, or methods for determining the amounts. To prepare the  
 34 schedule, the State Treasurer may request and rely upon information produced by one or more uni-  
 35 versities with a governing board or a shared services enterprise of the universities that provides  
 36 services related to debt management. The schedule must include amounts sufficient to pay principal,  
 37 interest and premium, if any, on the state bonds, and to pay administrative and other costs of the  
 38 State of Oregon that are related to the state bonds or other obligations. If the State Treasurer issues  
 39 state bonds for the benefit of a **public university [*with a governing board*]** on or after August 14,  
 40 2013, that are intended to be repaid in whole or in part by university revenues or other moneys  
 41 under the control of the university, the schedule shall be amended to include such state bonds and  
 42 the amounts to be paid by the university. In the absence of manifest error, the schedule provided  
 43 by the State Treasurer to a **public university [*with a governing board*]** is binding on the university.  
 44 The **public university [*with a governing board*]** shall pay the amounts specified in the schedule pro-  
 45 vided by the State Treasurer on or before the dates specified in the schedule from the legally

1 available revenue of the university and on a pari passu basis with the payment of any revenue bonds  
2 of the university issued pursuant to ORS 352.408.

3 (4) At the request of the State Treasurer, a **public university listed in ORS 352.002** [*with a*  
4 *governing board*] shall provide the State Treasurer with periodic cash flow projections and other  
5 information that allow the State Treasurer to review and approve the sufficiency of the university's  
6 cash flow to pay amounts specified in the schedule described in subsection (3) of this section and  
7 to pay amounts owed under loans from state agencies that were funded with the proceeds of state  
8 bonds.

9 (5) Moneys deposited with the State Treasurer or the Oregon Department of Administrative  
10 Services in a debt service reserve account or otherwise for the portion of the debt service associated  
11 with obligations entered into before August 14, 2013, for the benefit of a **public university listed in**  
12 **ORS 352.002** [*with a governing board*] must remain with the State Treasurer or the Oregon Depart-  
13 ment of Administrative Services until the obligations have been retired or defeased. Earnings on  
14 moneys described in this subsection must be credited to the account or fund in which the moneys  
15 are held.

16 (6) The principal, interest, premium, if any, and any issuance costs of state bonds issued before,  
17 on or after August 14, 2013, for the benefit of a **public university listed in ORS 352.002** [*with a*  
18 *governing board*], and any related credit enhancement device or interest rate exchange agreement,  
19 shall be paid from the sources identified in the laws and operative documents authorizing the state  
20 bonds. The **public university** [*with a governing board*] for which the state bonds were issued shall  
21 pay any other expenses and liabilities, including, but not limited to, legal expenses arising from an  
22 inquiry, audit or other action by a federal or state regulatory body, unless the expense or liability  
23 results solely from the negligence or willful misconduct of a state agency.

24 (7) Pursuant to ORS chapter 180, on behalf of the State Treasurer or any other state agency,  
25 the Attorney General shall appear, commence, prosecute or defend any action, suit, matter, cause  
26 or proceeding arising from any state bond issued for the benefit of a **public university listed in ORS**  
27 **352.002** [*with a governing board*] and any related credit enhancement device or interest rate ex-  
28 change agreement. As soon as practicable after a governing board is established by a **public**  
29 university pursuant to ORS 352.054, the university [*with a governing board*] and the State Treasurer  
30 shall enter into an agreement that addresses reimbursement of reasonable costs and expenses asso-  
31 ciated with the legal representation of the State Treasurer in connection with state bonds issued for  
32 the benefit of the **public university** [*with a governing board*] before, on or after August 14, 2013, and  
33 any other topic necessary for the Department of Justice to provide legal representation to the State  
34 Treasurer in connection with state bonds issued for the benefit of the **public university** [*with a*  
35 *governing board*] and to provide representation related to funds and accounts or services provided  
36 under ORS 352.135.

37 (8) A **public university listed in ORS 352.002** [*with a governing board*] shall assume responsi-  
38 bility for the indemnity and defense of university officers, agents and employees with regard to, as  
39 applicable, claims asserted and actions commenced in connection with state bonds issued for the  
40 benefit of the **public university** [*with a governing board*].

41 **SECTION 31.** ORS 352.442 is amended to read:

42 352.442. A **public university listed in ORS 352.002** [*with a governing board*] may, in its dis-  
43 cretion, accept financial assistance and grants, either in the form of money or labor, from the United  
44 States or any of its agencies, subject to the terms and conditions thereof, regardless of any laws of  
45 this state in conflict with the regulations of the federal government with respect thereto, and may

1 also accept from others any donation or grant of land, to be taken and held in the name of the State  
2 of Oregon, acting by and through the governing board, or gift of money or other valuable gift or  
3 thing, for any of the purposes contemplated by Article XI-F(1) and Article XI-G of the Oregon Con-  
4 stitution and ORS 352.157 to 352.171. Unless enjoined by the terms or conditions of any such gift  
5 or grant, the governing board may convert the same, or any of them, into money, through sale or  
6 disposal thereof.

7 **SECTION 32.** ORS 352.450 is amended to read:

8 352.450. (1) The Public University Fund is established in the State Treasury, separate and dis-  
9 tinct from the General Fund. Any interest or other investment income derived from moneys in the  
10 Public University Fund is credited to the fund.

11 (2) Except for moneys otherwise designated by statute or federal law, the governing board of  
12 any public university listed in ORS 352.002 may place any or all moneys received by it into the  
13 Public University Fund. Once deposited in the fund, the moneys of a public university shall be  
14 commingled with other moneys in the fund and are fungible, except to the extent they may be sep-  
15 arately accounted for by the public university designated under subsection (3)(a) of this section.

16 (3)(a) Public universities listed in ORS 352.002 that choose to participate in the Public Univer-  
17 sity Fund shall, by agreement or other structure authorized by law, designate the participating  
18 public university responsible for the Public University Fund and identify any and all obligations  
19 necessary for a participating public university listed in ORS 352.002 to serve as the designated re-  
20 sponsible party under this subsection.

21 (b) The participating public universities shall inform the State Treasurer of the designated pub-  
22 lic university responsible for the Public University Fund. The participating public universities may  
23 change which participating public university is responsible for the Public University Fund.

24 (c) The State Treasurer may conclusively rely on a written instruction from the public univer-  
25 sities as to the designated public university responsible for the fund.

26 (d) The designated public university shall inform the State Treasurer of the personnel authorized  
27 to provide instructions to the State Treasurer with respect to moneys in the fund. The State  
28 Treasurer may rely on instructions from the authorized personnel of the designated public university  
29 related to the deposit, withdrawal, investment, transfer, borrowing or lending of moneys in the fund.  
30 The State Treasurer is not responsible for or liable to the public universities for any error or  
31 omission in the instructions the State Treasurer receives from the designated public university.

32 (4) All moneys in the Public University Fund are continuously appropriated to the public uni-  
33 versity responsible for the Public University Fund, to be used only in a manner consistent with the  
34 agreement or other structure authorized by law as described in subsection (3) of this section.

35 (5) The moneys in the Public University Fund may be invested as provided in ORS 293.701 to  
36 293.857.

37 (6) Public universities that participate in the Public University Fund may, by agreement or other  
38 structure authorized by law, direct the public university designated under subsection (3)(a) of this  
39 section to establish accounts and subaccounts within the fund when the participating public uni-  
40 versities determine that accounts or subaccounts are necessary or desirable. Except when otherwise  
41 specified by a statute establishing an account, the participating public universities or, as appropri-  
42 ate, the designated public university, may credit any interest or income derived from moneys in the  
43 fund to any account or subaccount within the fund.

44 (7) Public universities that participate in the Public University Fund or, as appropriate, the  
45 public university designated under subsection (3)(a) of this section, shall keep a record of all moneys

1 deposited into the fund. The record shall indicate by separate cumulative accounts and subaccounts  
 2 the sources from which the moneys are derived and the individual activity or program against which  
 3 each withdrawal is charged.

4 (8) Notwithstanding any other provision of law, public universities that participate in the Public  
 5 University Fund or, as appropriate, the public university designated under subsection (3)(a) of this  
 6 section, may transfer or lend the moneys in the fund to other participating public universities listed  
 7 in ORS 352.002. The Public University Fund may be a borrowing fund for purposes of ORS 293.205  
 8 to 293.225 and may borrow from the Oregon Short Term Fund established in ORS 293.728 or other  
 9 state funds. Subject to the limitations of Article XI, section 7, of the Oregon Constitution, the  
 10 Public University Fund may be a lending fund for purposes of ORS 293.205 to 293.225 and may lend  
 11 moneys to other state funds. The public university designated under subsection (3)(a) of this section  
 12 shall be the relevant state agency or department for whom the State Treasurer may transfer funds  
 13 or with whom the State Treasurer may enter into an agreement pursuant to ORS 293.205 to 293.225.

14 (9) Notwithstanding any other provision of law, ORS 293.169, 293.171, 293.353, 293.406, 293.450,  
 15 293.455, 293.460 and 293.465 to 293.485 apply to moneys in the Public University Fund and to checks,  
 16 warrants or electronic funds transfers from or to the fund. For purposes of ORS 293.169, 293.171,  
 17 293.353, 293.406, 293.450, 293.455, 293.460 and 293.465 to 293.485:

18 (a) The public university designated under subsection (3)(a) of this section is the relevant state  
 19 agency or department; and

20 (b) The personnel of the designated public university authorized to provide instructions to the  
 21 State Treasurer are the relevant state officers.

22 (10)(a) The State Treasurer may establish separate or commingled funds, or establish separate  
 23 or commingled accounts within funds established under this subsection. The State Treasurer may  
 24 establish separate or commingled accounts within other funds in the State Treasury to receive, hold,  
 25 keep, manage or invest moneys of a **public university listed in ORS 352.002** [*with a governing*  
 26 *board*] pursuant to any agreements entered into by the State Treasurer and the university under  
 27 ORS 352.135. The moneys in a fund or account established under this subsection may be invested  
 28 as provided in ORS 293.701 to 293.857 and any interest or other investment income derived from the  
 29 fund or account shall be credited to the fund or account. All moneys held in a fund or account es-  
 30 tablished under this subsection are continuously appropriated to the relevant **public** university [*with*  
 31 *a governing board*] that has entered into an agreement with the State Treasurer under ORS 352.135  
 32 for the purpose of carrying out the powers and duties of the **public** university [*with a governing*  
 33 *board*] or the purposes for which the moneys were donated.

34 (b) Except for moneys held to provide for the payment of state bonds and other state obligations  
 35 described in ORS 352.089 (4), a **public university listed in ORS 352.002** [*with a governing board*]  
 36 may transfer or lend the moneys held in the State Treasury pursuant to any agreements entered into  
 37 under ORS 352.135 to other public universities listed in ORS 352.002. A fund or account in the State  
 38 Treasury that holds moneys of a **public** university [*with a governing board*] pursuant to an agree-  
 39 ment entered into under ORS 352.135 may be a borrowing fund for purposes of ORS 293.205 to  
 40 293.225 and may borrow from the Oregon Short Term Fund established in ORS 293.728 or other state  
 41 funds. Subject to the limitations of Article XI, section 7, of the Oregon Constitution, a fund or ac-  
 42 count in the State Treasury that holds moneys of a **public** university [*with a governing board*] pur-  
 43 suant to an agreement entered into under ORS 352.135 may be a lending fund for purposes of ORS  
 44 293.205 to 293.225 and may lend moneys to other state funds. The **public** university [*with a governing*  
 45 *board*] that has entered into an agreement with the State Treasurer under ORS 352.135 is the rele-

1 vant state agency or department for whom the State Treasurer may transfer funds or with whom the  
2 State Treasurer may enter into an agreement pursuant to ORS 293.205 to 293.225.

3 (c) Notwithstanding any other provision of law, ORS 293.169, 293.171, 293.353, 293.406, 293.450,  
4 293.455, 293.460 and 293.465 to 293.485 apply to moneys received, held, kept, managed or invested  
5 by the State Treasurer for a **public** university **listed in ORS 352.002** [*with a governing board*] pur-  
6 suant to an agreement entered into under ORS 352.135 and to checks, warrants or electronic funds  
7 transfers from or to any funds or accounts established pursuant to this subsection. For purposes of  
8 ORS 293.169, 293.171, 293.353, 293.406, 293.450, 293.455, 293.460 and 293.465 to 293.485:

9 (A) The **public** university [*with a governing board*] that has entered into an agreement with the  
10 State Treasurer under ORS 352.135 is the relevant state agency or department; and

11 (B) The personnel of the **public** university [*with a governing board*] authorized to provide in-  
12 structions to the State Treasurer are the relevant state officers.
