SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Increases amount of lottery bonds authorized to be issued for Oregon Business Development Department and Housing and Community Services Department.

Authorizes issuance of various other lottery bonds.

Establishes funds, or provides for deposit of moneys into existing funds, and appropriates moneys for projects financed.

Modifies descriptions of projects previously approved for funding from lottery bond revenue.

Declares emergency, effective July 1, 2017.

2 Relating to lottery bonds; creating new provisions; amending ORS 285B.551 and section 4, chapter
3 906, Oregon Laws 2009, sections 3, 6 and 18, chapter 786, Oregon Laws 2013, and sections 23
4 and 28a, chapter 812, Oregon Laws 2015; and declaring an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 285B.551 is amended to read:

7 285B.551. (1) Pursuant to ORS 286A.560 to 286A.585, at the request of the Oregon Department
8 of Administrative Services, after the department consults with the Oregon Business Development
9 Department, the State Treasurer is authorized to issue lottery bonds:

10 (a) To provide financial and other assistance, including but not limited to loans and grants, to
11 municipalities, ports and other persons and entities in accordance with the laws governing use of
12 moneys in the Special Public Works Fund created by ORS 285B.455, the Water Fund created by ORS
13 285B.563, the Safe Drinking Water Revolving Loan Fund created by ORS 285A.213, the Oregon Port
14 Revolving Fund created by ORS 285A.708, the Brownfields Redevelopment Fund created by ORS
15 285A.188, the Oregon Business Development Fund created by ORS 285B.092 and the Marine Navi-
16 gation Improvement Fund created by ORS 777.267.

17 (b) To fund Oregon's share of the costs of the Columbia River channel deepening project.

18 (c) To fund Oregon's share of the costs of studies and ecosystem restoration projects in the
19 lower Columbia River estuary designed to improve habitat for listed endangered or threatened spe-
20 cies of Columbia River anadromous salmonids.

21 (2) The use of lottery bond proceeds is authorized based on the following findings:

22 (a) The financial and other assistance to municipalities, ports and other persons and entities
23 will assist in the establishment and expansion of businesses in Oregon and in the construction, im-

1 improvement and expansion of infrastructure, community and port facilities and other facilities that
2 comprise the physical foundation for industrial and commercial activity and provide the basic
3 framework for continued and expanded economic opportunities and quality communities throughout
4 Oregon.

5 (b) The Columbia River channel deepening project is necessary to allow newer, larger
6 steamships access to Oregon and Washington deep draft ports. A deeper shipping channel will allow
7 the Columbia River to continue as a world leader in agricultural exports and as a key trade corridor
8 for farms and businesses throughout Oregon and the region.

9 (c) Such financial and other assistance to municipalities, ports and other persons and entities
10 and the deepening of the Columbia River channel will therefore promote economic development
11 within this state, and thus the use of net proceeds derived from the operation of the Oregon State
12 Lottery to pay debt service on lottery bonds issued under this section to provide such financial and
13 other assistance to municipalities, ports and other persons and entities and to pay a portion of the
14 costs of deepening the Columbia River channel is an authorized use of state lottery funds under
15 section 4, Article XV of the Oregon Constitution, and ORS 461.510.

16 (d) The current lower Columbia River estuary habitat for listed endangered or threatened spe-
17 cies of Columbia River anadromous salmonids could be improved through ecosystem restoration
18 projects. The use of the Oregon State Lottery to pay debt service on lottery bonds issued under this
19 section to pay for studying how the estuary could be improved and to pay for ecosystem restoration
20 projects are authorized uses of state lottery funds.

21 (3)(a) The aggregate principal amount of lottery bonds issued pursuant to subsection (1)(a) of
22 this section for financial and other assistance to municipalities, ports and other persons and entities
23 may not exceed the sum of [~~\$306,226,252~~] **\$336,226,252** and an additional amount estimated by the
24 State Treasurer to be necessary to pay bond-related costs. The aggregate principal amount of lottery
25 bonds issued pursuant to subsection (1)(b) of this section for the Columbia River channel deepening
26 project may not exceed the sum of \$17.7 million and an additional amount estimated by the State
27 Treasurer to be necessary to pay bond-related costs.

28 (b) The Oregon Department of Administrative Services may not request the issuance of lottery
29 bonds under subsection (1)(b) of this section until the Director of the Oregon Business Development
30 Department determines that a final environmental impact statement has been issued and a record
31 of decisions has been submitted to Congress by the United States Army Corps of Engineers, Con-
32 gress has authorized the Columbia River channel deepening project, and the Washington sponsors'
33 shares of the costs of the Columbia River channel deepening project have been committed.

34 (4) The net proceeds of lottery bonds issued pursuant to subsection (1)(a) and (b) of this section
35 shall be deposited in the Economic Infrastructure Project Fund, which is hereby established in the
36 State Treasury separate and distinct from the General Fund. Interest earned by the Economic
37 Infrastructure Project Fund shall be credited to the fund. All moneys in the Economic Infrastructure
38 Project Fund are continuously appropriated to the Oregon Business Development Department for
39 any purpose for which moneys in the Special Public Works Fund created by ORS 285B.455 may be
40 used, any purpose for which moneys in the Water Fund created by ORS 285B.563 may be used, any
41 purpose for which moneys in the Safe Drinking Water Revolving Loan Fund created by ORS
42 285A.213 may be used, any purpose for which moneys in the Oregon Port Revolving Fund created
43 by ORS 285A.708 may be used, any purpose for which moneys in the Brownfields Redevelopment
44 Fund created by ORS 285A.188 may be used, any purpose for which moneys in the Oregon Business
45 Development Fund created by ORS 285B.092 may be used and any purpose for which moneys in the

1 Marine Navigation Improvement Fund created by ORS 777.267 may be used. The Director of the
 2 Oregon Business Development Department shall allocate the moneys deposited in the Economic
 3 Infrastructure Project Fund for the purposes described in this subsection in accordance with the
 4 priorities developed by the Oregon Business Development Commission in accordance with ORS
 5 285A.020. However, the director shall transfer from the Economic Infrastructure Project Fund and
 6 deposit into the Channel Deepening Account of the Marine Navigation Improvement Fund the pro-
 7 ceeds of any lottery bonds sold to finance a portion of the costs of the Columbia River channel
 8 deepening project. Upon determining the relative allocation of moneys deposited in the Economic
 9 Infrastructure Project Fund among the purposes described in this subsection, the director shall
 10 transfer from the Economic Infrastructure Project Fund, and deposit into each of the other funds
 11 described in this subsection, the amounts so allocated. Notwithstanding any other provision of law
 12 governing the funds described in this subsection, the funds described in this subsection may be
 13 credited with moneys transferred from the Economic Infrastructure Project Fund by the director in
 14 accordance with this subsection.

15 (5) The aggregate principal amount of lottery bonds issued pursuant to subsection (1)(c) of this
 16 section for the costs of studies and ecosystem restoration projects in the lower Columbia River
 17 estuary may not exceed the sum of \$750,000 and an additional amount estimated by the State
 18 Treasurer to be necessary to pay bond-related costs. The net proceeds of lottery bonds issued pur-
 19 suant to subsection (1)(c) of this section shall be deposited in the Oregon Business, Innovation and
 20 Trade Fund created by ORS 285A.227 and may be used only for the Oregon nonfederal share of
 21 United States Army Corps of Engineers Columbia River estuary projects authorized by Congress
 22 prior to August 9, 2001. The director may not request the issuance of lottery bonds under subsection
 23 (1)(c) of this section until Congress and Washington have authorized their respective shares of the
 24 costs of the studies and ecosystem restoration projects in the lower Columbia River estuary.

25 (6) The proceeds of lottery bonds issued pursuant to this section may be used only for the pur-
 26 poses set forth in this section and for bond-related costs.

27 **SECTION 2. (1) Net proceeds of lottery bonds issued under ORS 285B.551 during the**
 28 **biennium beginning July 1, 2017, in an amount sufficient to provide \$10 million in net pro-**
 29 **ceeds and interest earnings must be transferred to the Oregon Business Development De-**
 30 **partment for deposit in the Levee Project Subaccount, established in ORS 285B.456, for the**
 31 **purpose of providing financial assistance under ORS 285B.410 to 285B.482 for levee projects,**
 32 **as defined in ORS 285B.410.**

33 **(2) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs,**
 34 **further economic development, finance public education or restore and protect parks,**
 35 **beaches, watersheds and native fish and wildlife, and is authorized based on the following**
 36 **findings:**

37 **(a) Levees are an integral part of the commercial and industrial infrastructure of this**
 38 **state.**

39 **(b) The inspection, accreditation, certification and repair of levees will promote economic**
 40 **development within this state.**

41 **SECTION 3. (1) For the biennium beginning July 1, 2017, at the request of the Oregon**
 42 **Department of Administrative Services, after the department consults with the Oregon**
 43 **Business Development Department, the State Treasurer is authorized to issue lottery bonds**
 44 **pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$4 million in net proceeds**
 45 **and interest earnings for the purposes described in subsection (2) of this section, plus an**

1 additional amount estimated by the State Treasurer to be necessary to pay bond-related
2 costs.

3 (2) Net proceeds of lottery bonds issued under this section in an amount sufficient to
4 provide \$4 million in net proceeds and interest earnings must be transferred to the Oregon
5 Business Development Department for deposit in the Regional Infrastructure Fund estab-
6 lished in section 3, chapter 786, Oregon Laws 2013, to provide grants and loans to local gov-
7 ernments for infrastructure projects, including long-range planning, research and design.
8 The grants and loans are to be allocated based on recommendations of regionally based
9 planning committees designated by the department.

10 (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs,
11 further economic development, finance public education or restore and protect parks,
12 beaches, watersheds and native fish and wildlife, and is authorized based on the following
13 findings:

14 (a) Infrastructure projects will create jobs; and

15 (b) Integrated development of infrastructure will establish a foundation for expanding
16 existing businesses and for developing and attracting new businesses.

17 **SECTION 4.** Section 3, chapter 786, Oregon Laws 2013, as amended by section 3, chapter 812,
18 Oregon Laws 2015, is amended to read:

19 **Sec. 3.** (1) The Regional Infrastructure Fund is established in the State Treasury, separate and
20 distinct from the General Fund. Interest earned on the moneys in the Regional Infrastructure Fund
21 shall be credited to the fund. The Regional Infrastructure Fund consists of moneys deposited in the
22 fund under section 2, chapter 786, Oregon Laws 2013, and section 2 [of this 2015 Act], **chapter 812,**
23 **Oregon Laws 2015, and section 3 of this 2017 Act,** and may include fees, revenues or other income
24 deposited into the fund by the Legislative Assembly.

25 (2) Moneys in the fund are continuously appropriated to the Oregon Business Development De-
26 partment for disbursement to local governments for the purposes set forth in section 2, chapter 786,
27 Oregon Laws 2013, and section 2 [of this 2015 Act], **chapter 812, Oregon Laws 2015, and section**
28 **3 of this 2017 Act.**

29 **SECTION 5.** (1) For the biennium beginning July 1, 2017, at the request of the Oregon
30 Department of Administrative Services, after the department consults with the Water Re-
31 sources Department, the State Treasurer is authorized to issue lottery bonds pursuant to
32 **ORS 286A.560 to 286A.585** in an amount that produces \$20,700,000 in net proceeds and interest
33 earnings for the purposes described in subsection (2) of this section, plus an additional
34 amount estimated by the State Treasurer to be necessary to pay bond-related costs.

35 (2) Net proceeds of lottery bonds issued under this section must be transferred to the
36 Water Resources Department for deposit in the Water Supply Development Account estab-
37 lished in ORS 541.656, in an amount sufficient to provide:

38 (a) \$15 million in net proceeds and interest earnings to provide grants or loans to evalu-
39 ate, plan and develop in-stream and out-of-stream statewide water development projects.

40 (b) \$2.5 million in net proceeds and interest earnings to the City of Carlton to reduce
41 sedimentation and increase water storage capacity at the Panther Creek Reservoir.

42 (c) \$2 million in net proceeds and interest earnings to the City of Carlton to replace the
43 city's finished water supply line and reduce water loss.

44 (d) \$1.2 million in net proceeds and interest earnings to the Santiam Water Control Dis-
45 trict to complete the Mill Creek Corporate Center irrigation conversion and efficiency

1 **project.**

2 **(3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs,**
3 **further economic development, finance public education or restore and protect parks,**
4 **beaches, watersheds and native fish and wildlife, and is authorized based on the following**
5 **findings:**

6 **(a) Having adequate drinking water systems, irrigation, drainage and healthy ecosystems**
7 **enhances community development and supports Oregon's economic growth.**

8 **(b) Assisting local governments to mitigate losses resulting from reduced water supply**
9 **for irrigation and retirement of water rights will enhance community efforts to facilitate and**
10 **promote economic growth.**

11 **SECTION 6. (1) For the biennium beginning July 1, 2017, at the request of the Oregon**
12 **Department of Administrative Services, after the department consults with the Water Re-**
13 **sources Department, the State Treasurer is authorized to issue lottery bonds pursuant to**
14 **ORS 286A.560 to 286A.585 in an amount that produces \$1.5 million in net proceeds and in-**
15 **terest earnings for the purposes described in subsection (2) of this section, plus an additional**
16 **amount estimated by the State Treasurer to be necessary to pay bond-related costs.**

17 **(2) Net proceeds of lottery bonds issued under this section in an amount sufficient to**
18 **provide \$1.5 million in net proceeds and interest earnings must be transferred to the Water**
19 **Resources Department for deposit in the Water Conservation, Reuse and Storage Investment**
20 **Fund, established in ORS 541.576, to be used to pay the qualifying costs of planning studies**
21 **performed to evaluate the feasibility of developing water conservation, reuse or storage**
22 **projects.**

23 **(3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs,**
24 **further economic development, finance public education or restore and protect parks,**
25 **beaches, watersheds and native fish and wildlife, and is authorized based on the following**
26 **findings:**

27 **(a) Having adequate drinking water systems, irrigation, drainage and healthy ecosystems**
28 **enhances community development and supports Oregon's economic growth.**

29 **(b) Assisting local governments to mitigate losses resulting from reduced water supply**
30 **for irrigation and retirement of water rights will enhance community efforts to facilitate and**
31 **promote economic growth.**

32 **SECTION 7. Section 4, chapter 906, Oregon Laws 2009, as amended by section 3, chapter 624,**
33 **Oregon Laws 2011, section 19, chapter 786, Oregon Laws 2013, section 15, chapter 121, Oregon Laws**
34 **2014, section 37, chapter 812, Oregon Laws 2015, and section 4, chapter 66, Oregon Laws 2016, is**
35 **amended to read:**

36 **Sec. 4. (1) Pursuant to ORS 286A.560 to 286A.585, at the request of the Oregon Department of**
37 **Administrative Services, after the department consults with the Housing and Community Services**
38 **Department, the State Treasurer is authorized to issue lottery bonds for the Housing and Community**
39 **Services Department to provide financial assistance to aid in the acquisition, renovation or mainte-**
40 **nance of section 8 housing or other housing with federal rent subsidies.**

41 **(2) The use of lottery bond proceeds is authorized based on the following findings:**

42 **(a) Individuals who are at risk of homelessness or who otherwise pay a disproportionate share**
43 **of income for housing increase their potential for self-sufficiency, and use proportionately fewer**
44 **community-funded resources when they are provided a stable housing environment.**

45 **(b) Having housing for at-risk populations is essential to Oregon's healthy economic growth.**

1 (3) The aggregate principal amount of lottery bonds issued pursuant to subsection (1) of this
2 section may not exceed the amount of [\$33,801,718] **\$58,801,718** plus an additional amount estimated
3 by the State Treasurer to be necessary to pay bond-related costs as defined in ORS 286A.560.

4 **SECTION 8. (1) For the biennium beginning July 1, 2017, at the request of the Oregon**
5 **Department of Administrative Services, in consultation with the Department of Transporta-**
6 **tion, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to**
7 **286A.585 in an amount that produces \$30 million in net proceeds and interest earnings for**
8 **the purpose described in subsection (2) of this section, plus an additional amount estimated**
9 **by the State Treasurer to be necessary to pay bond-related costs.**

10 (2) Net proceeds of lottery bonds issued pursuant to this section and interest earnings
11 must be transferred to the Department of Transportation for deposit in the Connect Oregon
12 Fund established under ORS 367.080 in an amount sufficient to provide \$30 million for the
13 department to finance grants for transportation projects as provided in ORS 367.080 to
14 367.086.

15 (3) Bond-related costs for the lottery bonds authorized by this section must be paid from
16 the gross proceeds of the lottery bonds and from allocations for the purposes of ORS
17 286A.576 (1)(c).

18 (4) The Legislative Assembly finds that issuing lottery bonds to finance transportation
19 projects pursuant to this section is essential to promoting the state's economic development,
20 and the use of lottery bond proceeds is authorized based on the following findings:

21 (a) There is an urgent need to improve and expand publicly owned and privately owned
22 transportation infrastructure to support economic development in this state.

23 (b) A safe, efficient and reliable transportation network supports the long-term economic
24 development and livability of this state.

25 (c) A multimodal network of transportation options moves people and goods efficiently.

26 (d) Local governments and private sector businesses often lack capital and the technical
27 capacity to undertake multimodal transportation projects.

28 (e) Public financial assistance can stimulate industrial growth and commercial enterprise
29 and promote employment opportunities in this state.

30 (f) Public investment in transportation infrastructure will create jobs and further eco-
31 nomic development in this state.

32 (g) The use of lottery bond proceeds as provided in this section will create jobs, further
33 economic development, finance public education or restore and protect parks, beaches,
34 watersheds and native fish and wildlife within Oregon, and issuance of lottery bonds for the
35 purpose described in this section is therefore an appropriate use of state lottery funds under
36 Article XV, section 4, of the Oregon Constitution, and ORS 461.510.

37 **SECTION 9. To the extent that proposed transportation projects meet the qualifications**
38 **established by the Oregon Transportation Commission by rule, the commission shall allocate**
39 **at least 10 percent of the net proceeds of the lottery bonds authorized by section 8 of this**
40 **2017 Act to each region described in this section. For purposes of this section, the regions**
41 **are as follows:**

42 (1) Region one consists of Clackamas, Hood River, Multnomah and Washington Counties.

43 (2) Region two consists of Benton, Clatsop, Columbia, Lane, Lincoln, Linn, Marion, Polk,
44 Tillamook and Yamhill Counties.

45 (3) Region three consists of Coos, Curry, Douglas, Jackson and Josephine Counties.

1 (4) Region four consists of Crook, Deschutes, Gilliam, Jefferson, Klamath, Lake,
2 Sherman, Wasco and Wheeler Counties.

3 (5) Region five consists of Baker, Grant, Harney, Malheur, Morrow, Umatilla, Union and
4 Wallowa Counties.

5 **SECTION 10.** (1) For the biennium beginning July 1, 2017, at the request of the Oregon
6 Department of Administrative Services, after the department consults with the Department
7 of State Lands, the State Treasurer is authorized to issue lottery bonds pursuant to ORS
8 286A.560 to 286A.585 in an amount that produces \$3 million in net proceeds and interest
9 earnings for the purposes described in subsection (2) of this section, plus an additional
10 amount estimated by the State Treasurer to be necessary to pay bond-related costs.

11 (2) Net proceeds of lottery bonds issued under this section in an amount sufficient to
12 provide \$3 million in net proceeds and interest earnings must be transferred to the Depart-
13 ment of State Lands for deposit in the Portland Harbor Cleanup Fund, established in section
14 11 of this 2017 Act, to provide financial assistance to the department for coordination and
15 participation in any contracts or agreements relating to or arising out of the Portland Har-
16 bor Superfund Site. The purposes of the contracts or agreements may include, but are not
17 limited to:

18 (a) Investigation necessary to characterize existing baseline conditions throughout the
19 Portland Harbor Superfund Site, as well as conditions upstream and downstream that may
20 be impacting the Portland Harbor Superfund Site;

21 (b) Investigation of key sediment management areas to update the extent of areas of
22 higher contamination in the Portland Harbor Superfund Site;

23 (c) Investigation of potential infrastructure needs related to contaminated sediments in
24 the Portland Harbor Superfund Site;

25 (d) Development and administration of a comprehensive data management system for the
26 Portland Harbor Superfund Site;

27 (e) Satisfaction of some or all of the department's obligations under any administrative
28 settlement or administrative order on consent in connection with the Portland Harbor
29 Superfund Site; and

30 (f) Work required by the United States Environmental Protection Agency in connection
31 with the Portland Harbor Superfund Site.

32 (3) In executing contracts for the work described in subsection (2) of this section, the
33 Department of State Lands shall, when practicable, contract with regional contractors em-
34 ploying individuals from communities disproportionately impacted by contamination in the
35 Portland Harbor.

36 (4) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs,
37 further economic development, finance public education or restore and protect parks,
38 beaches, watersheds and native fish and wildlife, and is authorized based on the following
39 findings:

40 (a) Having healthy ecosystems supports Oregon's economic growth and restores
41 watersheds and habitat for native fish.

42 (b) The future cleanup of the Portland Harbor will enhance community efforts to facili-
43 tate and promote economic growth.

44 **SECTION 11.** (1) The Portland Harbor Cleanup Fund is established in the State Treasury,
45 separate and distinct from the General Fund. The Portland Harbor Cleanup Fund consists

1 of moneys deposited in the fund under section 10 of this 2017 Act and may include moneys
2 appropriated, allocated, deposited or transferred to the fund by the Legislative Assembly or
3 otherwise and interest earned on moneys in the fund.

4 (2) Moneys in the fund are continuously appropriated to the Department of State Lands
5 for disbursement for the purposes set forth in section 10 of this 2017 Act.

6 (3) Nothing in section 10 or 11 of this 2017 Act waives or limits the department's ability
7 to recover, by way of insurance, cost recovery, contribution, or claim or action relating to
8 or arising out of the Portland Harbor Superfund Site, monies from other parties, including
9 claims for costs incurred by the department. In no event shall anything in section 10 or 11
10 of this 2017 Act be construed as a waiver by the State of Oregon of any form of defense or
11 immunity, whether sovereign immunity, governmental immunity, immunity based on the
12 Eleventh Amendment to the United States Constitution or otherwise.

13 **SECTION 12.** (1) For the biennium beginning July 1, 2017, at the request of the Oregon
14 Department of Administrative Services, after the department consults with the Cascade
15 AIDS Project, the State Treasurer is authorized to issue lottery bonds pursuant to ORS
16 286A.560 to 286A.585 in an amount that produces \$1 million in net proceeds and interest
17 earnings for the purposes described in subsection (2) of this section, plus an additional
18 amount estimated by the State Treasurer to be necessary to pay bond-related costs.

19 (2) Net proceeds of lottery bonds issued under this section in an amount sufficient to
20 provide \$1 million in net proceeds and interest earnings must be transferred to the depart-
21 ment for deposit in the ODAS Economic Development Distributions Fund established under
22 ORS 461.553 for distribution to the Cascade AIDS Project for acquisition and renovation of
23 a primary care and mental health center for the lesbian, gay, bisexual, transgender, queer,
24 and other minority gender identities and sexual orientation community.

25 (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs,
26 further economic development, finance public education or restore and protect parks,
27 beaches, watersheds and native fish and wildlife, and is authorized based on the following
28 findings:

29 (a) Individuals increase their potential for self-sufficiency and use fewer public resources
30 when they have access to health care.

31 (b) Individuals who have mental illnesses increase their potential for self-sufficiency and
32 use fewer public resources when they have access to mental health services.

22 produces \$2 million in net proceeds and interest earnings for the purpose described in subsection (2)
23 of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay
24 bond-related costs.

25 (2) Net proceeds of lottery bonds issued under this section in an amount sufficient to provide
26 \$2 million in net proceeds and interest earnings must be transferred to the department for deposit
27 in the ODAS Economic Development Distributions Fund established under ORS 461.553 for distrib-
28 ution to Wheeler County for the purpose of funding the construction of [*an underground fiber optic*
29 *telecommunication line*] **a telecommunication system**.

30 (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further
31 economic development, finance public education or restore and protect parks, beaches, watersheds
32 and native fish and wildlife, and is authorized based on the finding that construction of a [*fiber optic*
33 *telecommunication line*] **telecommunication system** in Wheeler County will bring telecommuting
34 jobs into the county and will expand future opportunities for economic development in the John Day
35 river basin.

36 **SECTION 35. This 2017 Act being necessary for the immediate preservation of the public**
37 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**
38 **July 1, 2017.**
