

Senate Bill 705

Sponsored by Senator KNOPP (at the request of Robert Jones)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

- Makes resident uniformed services hunting license free.
- Establishes free resident uniformed services angling license for persons who are resident members of uniformed services.
- Declares emergency, effective on passage.

A BILL FOR AN ACT

Relating to resident uniformed services licenses; creating new provisions; amending ORS 497.061 and 497.121; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 497.061, as amended by section 57, chapter 779, Oregon Laws 2015, is amended to read:

497.061. (1) Except as otherwise provided for by law, the State Fish and Wildlife Commission shall charge the fees listed in the fee schedule under this section for the issuance of the specified licenses, tags and permits.

(2) Fee Schedule:

Prices shown include agent fees under ORS 497.022 and dedications of funds collected as otherwise prescribed by law.

SECTION 4. ORS 497.121 is amended to read:

497.121. (1) The State Fish and Wildlife Commission is authorized to issue, upon application, to persons desiring to angle for fish or take shellfish the following licenses and tags and shall charge the applicable fees under the fee schedule in ORS 497.061:

- (a) Resident annual angling license.
- (b) Nonresident annual angling license.
- (c) Nonresident angling license to angle for seven consecutive days.
- (d) Angling license to angle for one day.
- (e) Angling and shellfish license to angle and take shellfish for one day.
- (f) Angling license to angle for two days.
- (g) Angling license to angle for three days.
- (h) Resident annual shellfish license.
- (i) Nonresident annual shellfish license.
- (j) Nonresident three-day shellfish license.
- (k) Two rod angling license for anglers who also hold a valid annual angling license.

1 (L) Resident annual senior citizen angling license for persons 70 years of age or older who have
 2 resided in the state for not less than five years prior to the date of application.

3 (m) Resident disabled veteran angling license for a person who files with the commission written
 4 proof that the last official certification of record by the United States Department of Veterans Af-
 5 fairs or by any branch of the Armed Forces of the United States shows the person to be at least
 6 25 percent disabled.

7 (n) Resident disabled veteran shellfish license for a person who files with the commission written
 8 proof that the last official certification of record by the United States Department of Veterans Af-
 9 fairs or by any branch of the Armed Forces of the United States shows the person to be at least
 10 25 percent disabled.

11 **(o) Resident uniformed services angling license for a person who is a resident member**
 12 **of the uniformed services as defined in ORS 497.006.**

13 [(o)] (p) Resident annual combined angling tag to angle for salmon, steelhead trout, sturgeon and
 14 halibut.

15 [(p)] (q) Nonresident annual combined angling tag to angle for salmon, steelhead trout, sturgeon
 16 and halibut.

17 [(q)] (r) Annual youth combined angling tag for persons under 18 years of age to angle for
 18 salmon, steelhead trout, sturgeon and halibut.

19 [(r)] (s) Renewable tag to angle for hatchery salmon and steelhead.

20 (2) Any person who holds a valid permanent angling license for persons who are blind or a
 21 permanent angling license for persons in a wheelchair issued by the commission before January 1,
 22 2000, need not obtain a resident annual angling license under this section.

23 (3) The annual combined angling tags to angle for salmon, steelhead trout, sturgeon and halibut
 24 referred to in subsection [(1)(o), (p), (q) and (r)] (1)(p), (q), (r) and (s) of this section are in addition
 25 to and not in lieu of the angling licenses required by the wildlife laws. However, an annual combined
 26 angling tag to angle for salmon, steelhead trout, sturgeon and halibut is not required of a person
 27 who holds a valid angling license referred to in subsection (1)(c) to (g) of this section.

28 **SECTION 5. The amendments to ORS 497.061 and 497.121 by sections 1 and 4 of this 2017**
 29 **Act apply to licenses applied for on or after the effective date of this 2017 Act for activities**
 30 **occurring on or after January 1, 2018.**

31 **SECTION 6. This 2017 Act being necessary for the immediate preservation of the public**
 32 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**
 33 **on its passage.**

34
