

Senate Bill 815

Sponsored by Senator HANSELL (at the request of Association of Oregon Counties, Umatilla County)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Land Conservation and Development Commission to request information from state agencies to update state agency coordination program by September 15, 2017. Requires state agencies to provide information requested by commission to Department of Land Conservation and Development.

Requires commission to report progress on update to interim committee on land use by September 15, 2018.

Requires commission to complete update of state agency coordination program by September 15, 2019.

Declares emergency, effective on passage.

A BILL FOR AN ACT

1 Relating to agency coordination; and declaring an emergency.

2 **Be It Enacted by the People of the State of Oregon:**

3 **SECTION 1. (1) Pursuant to ORS 197.180, the Land Conservation and Development Com-**
4 **mission shall request from each state agency the information described in subsection (2) of**
5 **this section for submission to the Department of Land Conservation and Development.**

6 **(2) Upon request by the commission, each state agency shall submit to the department:**

7 **(a) The information described in ORS 197.180 (4);**

8 **(b) A program for coordination with the League of Oregon Cities and the Association of**
9 **Oregon Counties regarding agency rules, plans and programs relating to land use;**

10 **(c) A program for cooperation with land use planners of local governments regarding**
11 **agency rules, plans and programs relating to land use within the jurisdiction of the local**
12 **government; and**

13 **(d) A procedure by which the state agency will provide a local government with notice**
14 **and an opportunity to comment on all agency rules relating to land use and affecting the**
15 **local government.**

16 **(3) Upon receipt of the information described in subsection (2) of this section, the de-**
17 **partment shall update the state agency coordination program, according to the procedure**
18 **described in ORS 197.180, to reflect current state agency plans and programs.**

19 **(4) The commission shall:**

20 **(a) Request the information described in subsection (2) of this section no later than**
21 **September 15, 2017.**

22 **(b) Submit a report on the progress of the updated state agency coordination program**
23 **to the interim legislative committee on land use no later than September 15, 2018.**

24 **(c) Complete the update of the state agency coordination program no later than Sep-**
25 **tember 15, 2019.**

26 **(d) Submit a summary of the updated state agency coordination program to the interim**

1 **legislative committee on land use no later than September 15, 2019.**

2 **SECTION 2. This 2017 Act being necessary for the immediate preservation of the public**
3 **peace, health and safety, an emergency is declared to exist, and this 2017 Act takes effect**
4 **on its passage.**
