

B-Engrossed Senate Bill 952

Ordered by the Senate June 26
Including Senate Amendments dated April 24 and June 26

Sponsored by Senator OLSEN; Senator JOHNSON

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Oregon Energy Commission as policy and rulemaking body for State Department of Energy. Transfers certain duties of State Department of Energy and Director of State Department of Energy to commission.

Modifies state energy policy.

Modifies general duties of department.

Requires department to develop statewide strategic energy report. Requires commission to adopt report no later than January 1, 2020. Requires department to present draft report to Legislative Assembly no later than September 15, 2019. Requires commission to periodically review and update report.

Requires department to provide annual comprehensive energy report to Governor and Legislative Assembly.

Transfers certain State Department of Energy programs to other agencies. Repeals certain State Department of Energy programs.

Extends eligibility period for residential energy tax credits until January 1, 2020.

Reduces, to 0.1 percent, percentage of energy resource supplier's gross operating revenue that annual energy resource supplier assessment may not exceed. **Changes calculated share of annual energy resource supplier assessment below which energy resource supplier is exempt from payment of assessment from \$250 to \$2,500.** Modifies definition of "gross operating revenue" for purposes of energy resource supplier assessment. **Applies to annual fees due on or after July 1, 2018.**

Prohibits transfer of energy-related tax credit held by tax-exempt or government entity. Provides for purchase by Oregon Business Development Department of credit held by tax-exempt or government entity. Applies to tax years beginning on or after January 1, 2017.

Requires State Department of Energy to study further restructuring of department. **Requires study to also include review and recommendations related to public involvement in proceedings of Energy Facility Siting Council.** Requires department to present results of study to interim committees of Legislative Assembly no later than September 15, 2018. Sunsets study requirement on December 31, 2018.

Becomes operative January 1, 2018.

Takes effect on 91st day following adjournment sine die.

10 **Be It Enacted by the People of the State of Oregon:**

12 **ENERGY POLICY**

13
14 **SECTION 1.** ORS 469.010 is amended to read:

15 469.010. The Legislative Assembly finds and declares that[:]

16 [(1) *Continued growth in demand for nonrenewable energy forms poses a serious and immediate,*
17 *as well as future, problem. It is essential that future generations not be left a legacy of vanished or*
18 *depleted resources, resulting in massive environmental, social and financial impact.*]

19 [(2)] it is the goal of Oregon to promote the efficient use of energy resources and to develop
20 permanently sustainable energy resources. The need exists for comprehensive state leadership in
21 energy production, distribution and utilization. It is, therefore, the policy of Oregon:

22 [(a)] (1) That development and use of a diverse array of permanently sustainable energy re-
23 sources be encouraged utilizing to the highest degree possible the private sector of our free enter-
24 prise system.

25 [(b)] (2) That through state government example and other effective communications, energy
26 conservation and elimination of wasteful and uneconomical uses of energy and materials be pro-
27 moted. This conservation must include, but not be limited to, resource recovery and materials re-
28 cycling.

29 [(c)] (3) That the basic human needs of every citizen, present and future, shall be given priority
30 in the allocation of energy resources, commensurate with perpetuation of a free and productive
31 economy [*with special attention to the preservation and enhancement of environmental quality*].

32 [(d) *That state government assist every citizen and industry in adjusting to a diminished avail-*
33 *ability of energy.*]

34 [(e)] (4) That energy-efficient modes of transportation for people and goods shall be
35 encouraged[, *while energy-inefficient modes of transportation shall be discouraged*].

36 [(f)] (5) That cost-effectiveness be considered in state agency decision-making relating to energy
37 sources, facilities or conservation, and that cost-effectiveness be considered in all agency decision-
38 making relating to energy facilities.

39 [(g)] (6) That state government shall provide a source of impartial and objective information in
40 order that this energy policy may be enhanced.

41
42 **PROVISIONS RELATING TO THE OREGON ENERGY COMMISSION**

43
44 **(Establishment)**

1 (3) In accordance with applicable provisions of ORS chapter 183, the commission shall
2 adopt rules and issue orders as necessary for the administration of the laws that the com-
3 mission, the Director of the State Department of Energy and the department are charged
4 with administering.

5 (4) Except as provided in ORS 183.335 (5), the commission shall cause a public hearing to
6 be held on any proposed rule or standard prior to its adoption. The hearing may be before
7 the commission, any designated member thereof or any person designated by and acting for
8 the commission.

9 (5) This section does not limit the authority granted the Energy Facility Siting Council
10 under ORS 469.300 to 469.563, 469.590 to 469.619, 469.930 and 469.992.

12 **TRANSFER OF RULEMAKING AUTHORITY FROM STATE**
13 **DEPARTMENT OF ENERGY TO OREGON ENERGY COMMISSION**

14
15 (Transfer)

16
17 **SECTION 6.** (1) Except as provided in subsection (2) of this section, the duties, functions
18 and powers of the State Department of Energy and the Director of the State Department of
19 Energy relating to the establishment of policy for the operations of the department and the
20 adoption of rules are imposed upon, transferred to and vested in the Oregon Energy Com-
21 mission.

22 (2) Subsection (1) of this section does not affect, alter, transfer or limit the authority
23 granted to the Energy Facility Siting Council under ORS 469.300 to 469.563, 469.590 to 469.619,
24 469.930 and 469.992, or the authority of the director granted under ORS 469.040 (1)(a) in
25 supervising and facilitating the work and research on energy facility siting applications at
26 the direction of the council.

27
28 (Action, Proceeding, Prosecution)

29
30 **SECTION 7.** The transfer of duties, functions and powers to the Oregon Energy Com-
31 mission by section 6 of this 2017 Act does not affect any action, proceeding or prosecution
32 involving or with respect to the duties, functions and powers begun before and pending at
33 the time of the transfer, except that the Oregon Energy Commission is substituted for the
34 State Department of Energy or the Director of the State Department of Energy in the
35 action, proceeding or prosecution.

36
37 (Liability, Duty, Obligation)

38
39 **SECTION 8.** (1) Nothing in sections 2 to 10 or 14 to 17 of this 2017 Act, the amendments
40 to statutes and session law by sections 1, 11, 12, 18 to 21 and 89 to 154 of this 2017 Act or the
41 repeal of ORS 469.060 and 469.070 by section 13 of this 2017 Act relieves a person of a liability,
42 duty or obligation accruing under or with respect to the duties, functions and powers
43 transferred by section 6 of this 2017 Act. The Oregon Energy Commission may undertake the
44 collection or enforcement of any such liability, duty or obligation.

45 (2) The rights and obligations of the State Department of Energy legally incurred under

1 contracts, leases and business transactions executed, entered into or begun before the op-
2 erative date of section 6 of this 2017 Act accruing under or with respect to the duties, func-
3 tions and powers transferred by section 6 of this 2017 Act are transferred to the Oregon
4 Energy Commission. For the purpose of succession to these rights and obligations, the
5 Oregon Energy Commission is a continuation of the State Department of Energy and the
6 Director of the State Department of Energy and not a new authority.

8 (Rules)

9
10 **SECTION 9.** Notwithstanding the transfer of duties, functions and powers by section 6
11 of this 2017 Act, the rules of the State Department of Energy and the Director of the State
12 Department of Energy with respect to such duties, functions or powers that are in effect on
13 the operative date of section 6 of this 2017 Act continue in effect until superseded or repealed
14 by rules of the Oregon Energy Commission. References in the rules of the State Department
15 of Energy to the State Department of Energy or an officer or employee of the State De-
16 partment of Energy with respect to the duties, functions and powers transferred by section
17 6 of this 2017 Act are considered to be references to the Oregon Energy Commission.

18 **SECTION 10.** Whenever, in any statutory or uncodified law or resolution of the Legisla-
19 tive Assembly or in any rule, document, record or proceeding authorized by the Legislative
20 Assembly, in the context of the duties, functions and powers transferred by section 6 of this
21 2017 Act, reference is made to the State Department of Energy, the Director of the State
22 Department of Energy or an officer or employee of the State Department of Energy whose
23 duties, functions or powers are transferred by section 6 of this 2017 Act, the reference is
24 considered to be a reference to the Oregon Energy Commission or an officer or employee of
25 the Oregon Energy Commission who by this 2017 Act is charged with carrying out the duties,
26 functions and powers.

28 **STATE DEPARTMENT OF ENERGY ADMINISTRATION**

29
30 **(Modification of General Duties)**

31
32 **SECTION 11.** ORS 469.030 is amended to read:

33 469.030. [(1) *There is created the State Department of Energy.*]

34 (1) **There is created under the Oregon Energy Commission a department to be known as**
35 **the State Department of Energy. The department shall consist of the Director of the State**
36 **Department of Energy and all personnel employed in the department. The primary purpose**
37 **of the department shall be to provide expert technology- and industry-neutral nonpartisan**
38 **advice to the Governor and the Legislative Assembly on energy-related matters.**

39 (2) **Subject to the policy direction of the Oregon Energy Commission, and in furtherance**
40 **of the purpose stated in subsection (1) of this section, the State Department of Energy shall:**

41 (a) [Be] **Collect, compile and analyze energy data from all available sources and serve as**
42 **the central repository within the state government for [the collection of data on energy resources;]**
43 **energy information, to which all agencies shall send information on all energy-related re-**
44 **search;**

45 (b) **Apply a statewide perspective to the administration of energy programs, while pro-**

1 **viding technical assistance and reporting to the Legislative Assembly, the Governor and**
2 **other agencies;**

3 *[(b) Endeavor to utilize all public and private sources to inform and educate the public about en-*
4 *ergy problems and ways in which the public can conserve energy resources;]*

5 *[(c) Engage in research, but whenever possible, contract with appropriate public or private agencies*
6 *and dispense funds for research projects and other services related to energy resources, except that the*
7 *State Department of Energy shall endeavor to avoid duplication of research whether completed or in*
8 *progress;]*

9 *[(d)]* **(c)** Qualify for, accept and disburse or utilize any private or federal moneys or services
10 available for the administration of ORS [176.820,] 192.501 to 192.505, [192.690,] 469.010 to 469.155,
11 469.300 to 469.563, 469.990, 757.710 and 757.720;

12 *[(e)]* **(d)** Administer federal and state energy allocation and conservation programs and energy
13 research and development programs and apply for and receive available funds [therefor] **for the**
14 **programs;**

15 **(e) Regularly evaluate all energy programs administered by the department and other**
16 **state agencies, applying consistent baselines across all programs, as feasible, for analyzing**
17 **the programs for efficacy, consistency, cost-effectiveness and redundancy, and make evalu-**
18 **ation information available to the Governor and the Legislative Assembly;**

19 *[(f) Be a clearinghouse for energy research to which all agencies shall send information on all*
20 *energy related research;]*

21 *[(g)]* **(f)** Prepare contingent energy programs to include all forms of energy not otherwise pro-
22 vided pursuant to ORS 757.710 and 757.720;

23 *[(h) Maintain an inventory of energy research projects in Oregon and the results thereof;]*

24 *[(i) Collect, compile and analyze energy statistics, data and information;]*

25 *[(j)]* **(g)** Contract with public and private agencies for energy activities consistent with ORS
26 469.010 and this section;

27 *[(k)]* **(h)** Upon request of the governing body of any affected jurisdiction, coordinate a public
28 review of a proposed transmission line according to the provisions of ORS 469.442; and

29 *[(L) Advise the Governor on energy-related matters.]*

30 **(i) Provide staff support to the Oregon Hanford Cleanup Board, the Energy Facility Siting**
31 **Council and the Oregon Global Warming Commission.**

33 **(Director)**
34

35 **SECTION 12.** ORS 469.040 is amended to read:

36 469.040. (1) The State Department of Energy shall be under the supervision of the Director of
37 the State Department of Energy, who shall:

38 *[(a) Supervise the day-to-day functions of the State Department of Energy;]*

39 *[(b)]* **(a)** Supervise and facilitate the work and research on energy facility siting applications at
40 the direction of the Energy Facility Siting Council; **and**

41 **(b) Subject to the direction of the Oregon Energy Commission:**

42 **(A) Supervise the day-to-day functions of the State Department of Energy; and**

43 *[(c)]* **(B)** Hire, assign, reassign and coordinate personnel of the State Department of Energy,
44 prescribe their duties and fix their compensation, subject to the State Personnel Relations Law[;
45 and].

1 report. Revisions of the report shall take effect upon the commission's adoption of the re-
2 vised report by reference in rule.

3 **SECTION 16.** (1) The Oregon Energy Commission shall initially adopt the statewide
4 strategic energy report required by section 15 of this 2017 Act no later than January 1, 2020.

5 (2) The State Department of Energy shall prepare a draft statewide strategic energy re-
6 port, which may include recommendations for legislation. The department shall, no later
7 than September 15, 2019, submit the draft report to the appropriate interim committees of
8 the Legislative Assembly in the manner provided under ORS 192.245.

9 **SECTION 17.** (1) No later than November 1 of each year, the State Department of Energy
10 shall transmit to the Governor and the Legislative Assembly a comprehensive report on en-
11 ergy resources, policies, trends and forecasts in Oregon. The purposes of the report shall be
12 to inform local, state, regional and federal energy policy development, energy planning and
13 energy investments and to identify opportunities to further the energy policies stated in ORS
14 469.010 and 469.310 in conformance with the statewide strategic energy report required under
15 section 15 of this 2017 Act.

16 (2) Consistent with the legislatively approved budget, the report shall include, but need
17 not be limited to:

18 (a) Information on and analysis of the state's progress toward achieving the goals of the
19 statewide strategic energy report required by section 15 of this 2017 Act and on the effec-
20 tiveness of the department's programs in contributing to meeting the goals of the report.

21 (b) Information on the impact of activities carried out by the Oregon Energy Commission
22 and the department on achieving the greenhouse gas emissions reduction goals set forth in
23 ORS 468A.205.

24 (c) Data and information on:

25 (A) The consumption, generation, transmission and production of energy, including fuel
26 energy;

27 (B) Energy costs;

28 (C) Energy sectors, markets, technologies, resources and facilities;

29 (D) Energy efficiency and conservation;

30 (E) The effects of energy use;

31 (F) Local, state, regional and federal regulations, policies and planning activities related
32 to energy; and

33 (G) Emerging energy opportunities, challenges and impacts.

34 (3) The report may include, but need not be limited to:

35 (a) Recommendations for the development and maximum use of cost-effective conserva-
36 tion methods and renewable resources, consistent with the statewide strategic energy report,
37 the energy policies stated in ORS 469.010 and 469.310 and, where appropriate, the energy plan
38 and fish and wildlife program adopted by the Pacific Northwest Electric Power and Conser-
39 vation Planning Council pursuant to P.L. 96-501; and

40 (b) Recommendations for proposed research, development and demonstration projects
41 and programs necessary to further the purposes of the statewide strategic energy report and
42 energy policies stated in ORS 469.010 and 469.310.

43 (4) The report shall be compiled by collecting, organizing and refining data and informa-
44 tion:

45 (a) Acquired by the department in the performance of the department's existing duties;

1 or

2 (b) Required by the commission by rule to be submitted to the department for purposes
3 of compiling the report.

4 (5) Upon request from the department, other agencies shall assist the department in the
5 performance of the department's duties under this section.

6 (6) The department shall seek public input and provide opportunities for public comment
7 during the development of the report.

8
9 (Other State Department of Energy Administrative Provisions)

10
11 **SECTION 18.** ORS 469.085 is amended to read:

12 469.085. (1) Except as otherwise provided in this section, civil penalties under ORS 469.992 shall
13 be imposed as provided in ORS 183.745.

14 (2) Notwithstanding ORS 183.745 (2), the notice to the person against whom a civil penalty is
15 to be imposed shall reflect a complete statement of the consideration given to the factors listed in
16 subsection (7) of this section. The notice may be served by either the [*Director of the State Depart-*
17 *ment of Energy*] **Oregon Energy Commission** or the Energy Facility Siting Council.

18 (3) Notwithstanding ORS 183.745, if a hearing is not requested or if the person requesting a
19 hearing fails to appear, a final order shall be entered upon a prima facie case made on the record
20 of the agency.

21 (4) The provisions of this section are in addition to and not in lieu of any other penalty or
22 sanction provided by law. An action taken by the [*director*] **commission** or the council under this
23 section may be joined by the [*director*] **commission** or the council with any other action against the
24 same person under this chapter.

25 (5) Any civil penalty recovered under this section shall be paid into the General Fund.

26 (6) The [*director*] **commission** or the council shall adopt by rule a schedule of the amount of
27 civil penalty that may be imposed for a particular violation.

28 (7) In imposing a penalty under ORS 469.992, the [*director*] **commission** or the council shall
29 consider:

30 (a) The past history of the person incurring a penalty in taking all feasible steps or procedures
31 necessary or appropriate to correct or prevent any violation;

32 (b) Any prior violations of ORS chapter 469 or rules, orders or permits relating to the alleged
33 violation;

34 (c) The impact of the violation on public health and safety or public interests in fishery, navi-
35 gation and recreation;

36 (d) Any other factors determined by the [*director*] **commission** or the council to be relevant;
37 and

38 (e) The alleged violator's cooperativeness and effort to correct the violation.

39 (8) The penalty imposed under ORS 469.992 may be remitted or mitigated upon such terms and
40 conditions as the [*director*] **commission** or council determines to be proper. Upon the request of the
41 person incurring the penalty, the [*director*] **commission** or council shall consider evidence of the
42 economic and financial condition of the person in determining whether a penalty shall be remitted
43 or mitigated.

44 **SECTION 19.** ORS 469.110 is amended to read:

45 469.110. (1) At the direction of the [*Director of the State Department of Energy*] **Oregon Energy**

1 **Commission**, the State Department of Energy may represent the state's energy-related interests in
2 any matter involving the federal government, its departments or agencies, which is within the scope
3 of the power and duties of the State Department of Energy, and may, upon request, represent the
4 interest of a county, city, state agency, federally recognized Native American or American Indian
5 tribe, special district or owner or operator of an energy facility.

6 (2) At the direction of the [*director*] **commission**, the department may intervene in any pro-
7 ceeding undertaken by an agency for the purpose of expressing its views as to the effect of an
8 agency action, upon state energy resources and state energy policy.

9 **SECTION 20.** ORS 469.120 is amended to read:

10 469.120. (1) The State Department of Energy Account is established.

11 (2) The account shall consist of all funds received by the State Department of Energy pursuant
12 to law. All moneys in the account are continuously appropriated to the State Department of Energy
13 for payment of expenses of the department, **the Oregon Energy Commission** and [*of*] the Energy
14 Facility Siting Council.

15 (3) Moneys collected under ORS 469.421 (8) may be expended only for the purposes of programs
16 and activities that the **commission, the council** and the department are charged with administering
17 and authorized to conduct under the laws of this state, including those enumerated in ORS 469.030.

18 (4) The Director of the State Department of Energy shall keep a record of all moneys deposited
19 in the account. The record shall indicate by special cumulative accounts the source from which
20 moneys are derived and the individual activity or program, including any activities described in ORS
21 469.424, against which each withdrawal is charged. On or after October 1 of each year, the director
22 shall make available, upon request, the record for the prior fiscal year to any energy resource sup-
23 plier that has paid the assessment imposed under ORS 469.421 (8). The director shall make the re-
24 cord available within 30 days of receiving the request.

26 **(Energy Resource Supplier Assessment Modifications)**
27

28 **SECTION 21.** ORS 469.421, as amended by section 71, chapter 117, Oregon Laws 2016, is
29 amended to read:

30 469.421. (1) Subject to the provisions of ORS 469.441, any person submitting a notice of intent,
31 a request for exemption under ORS 469.320, a request for an expedited review under ORS 469.370,
32 a request for an expedited review under ORS 469.373, a request for the State Department of Energy
33 to approve a pipeline under ORS 469.405 (3), an application for a site certificate or a request to
34 amend a site certificate shall pay all expenses incurred by the Energy Facility Siting Council and
35 the department related to the review and decision of the council. Expenses under this subsection
36 may include:

37 (a) Legal expenses;

38 (b) Expenses incurred in processing and evaluating the application;

39 (c) Expenses incurred in issuing a final order or site certificate;

40 (d) Expenses incurred in commissioning an independent study under ORS 469.360;

41 (e) Compensation paid to a state agency, a tribe or a local government pursuant to a written
42 contract or agreement relating to compensation as provided for in ORS 469.360; or

43 (f) Expenses incurred by the council in making rule changes that are specifically required and
44 related to the particular site certificate.

45 (2) Every person submitting a notice of intent to file for a site certificate, a request for ex-

1 exemption or a request for expedited review shall pay the fee required under the fee schedule estab-
2 lished under ORS 469.441 to the department prior to submitting the notice or request to the council.
3 To the extent possible, the full cost of the evaluation shall be paid from the fee paid under this
4 subsection. However, if costs of the evaluation exceed the fee, the person submitting the notice or
5 request shall pay any excess costs shown in an itemized statement prepared by the council. In no
6 event shall the council incur evaluation expenses in excess of 110 percent of the fee initially paid
7 unless the council provides prior notification to the applicant and a detailed projected budget the
8 council believes necessary to complete the project. If costs are less than the fee paid, the excess
9 shall be refunded to the person submitting the notice or request.

10 (3) Before submitting a site certificate application, the applicant shall request from the depart-
11 ment an estimate of the costs expected to be incurred in processing the application. The department
12 shall inform the applicant of that amount and require the applicant to make periodic payments of
13 the costs pursuant to a cost reimbursement agreement. The cost reimbursement agreement shall
14 provide for payment of 25 percent of the estimated costs when the applicant submits the application.
15 If costs of the evaluation exceed the estimate, the applicant shall pay any excess costs shown in an
16 itemized statement prepared by the council. In no event shall the council incur evaluation expenses
17 in excess of 110 percent of the fee initially estimated unless the council provided prior notification
18 to the applicant and a detailed projected budget the council believes is necessary to complete the
19 project. If costs are less than the fee paid, the council shall refund the excess to the applicant.

20 (4) Any person who is delinquent in the payment of fees under subsections (1) to (3) of this
21 section shall be subject to the provisions of subsection (11) of this section.

22 (5) Subject to the provisions of ORS 469.441, each holder of a certificate shall pay an annual fee,
23 due every July 1 following issuance of a site certificate. For each fiscal year, upon approval of the
24 department's budget authorization by an odd-numbered year regular session of the Legislative As-
25 sembly or as revised by the Emergency Board meeting in an interim period or by the Legislative
26 Assembly meeting in special session or in an even-numbered year regular session, the Director of
27 the State Department of Energy promptly shall enter an order establishing an annual fee based on
28 the amount of revenues that the director estimates is needed to fund the cost of ensuring that the
29 facility is being operated consistently with the terms and conditions of the site certificate, any order
30 issued by the department under ORS 469.405 (3) and any applicable health or safety standards. In
31 determining this cost, the director shall include both the actual direct cost to be incurred by the
32 council and the department to ensure that the facility is being operated consistently with the terms
33 and conditions of the site certificate, any order issued by the department under ORS 469.405 (3) and
34 any applicable health or safety standards, and the general costs to be incurred by the council and
35 the department to ensure that all certificated facilities are being operated consistently with the
36 terms and conditions of the site certificates, any orders issued by the department under ORS 469.405
37 (3) and any applicable health or safety standards that cannot be allocated to an individual, licensed
38 facility. Not more than 35 percent of the annual fee charged each facility shall be for the recovery
39 of these general costs. The fees for direct costs shall reflect the size and complexity of the facility,
40 the anticipated costs of ensuring compliance with site certificate conditions, the anticipated costs
41 of conducting site inspections and compliance reviews as described in ORS 469.430, and the antic-
42 ipated costs of compensating state agencies and local governments for participating in site in-
43 spection and compliance enforcement activities at the request of the council.

44 (6) Each holder of a site certificate executed after July 1 of any fiscal year shall pay a fee for
45 the remaining portion of the year. The amount of the fee shall be set at the cost of regulating the

1 facility during the remaining portion of the year determined in the same manner as the annual fee.

2 (7) When the actual costs of regulation incurred by the council and the department for the year,
3 including that portion of the general regulation costs that have been allocated to a particular fa-
4 cility, are less than the annual fees for that facility, the unexpended balance shall be refunded to
5 the site certificate holder. When the actual regulation costs incurred by the council and the de-
6 partment for the year, including that portion of the general regulation costs that have been allo-
7 cated to a particular facility, are projected to exceed the annual fee for that facility, the director
8 may issue an order revising the annual fee.

9 (8)(a) In addition to any other fees required by law, each energy resource supplier shall pay to
10 the department annually its share of an assessment to fund the programs and activities of the
11 council and the department.

12 (b) Prior to filing an agency request budget under ORS 291.208 for purposes related to the
13 compilation and preparation of the Governor's budget under ORS 291.216, the director shall deter-
14 mine the projected aggregate amount of revenue to be collected from energy resource suppliers un-
15 der this subsection that will be necessary to fund the programs and activities of the council and the
16 department for each fiscal year of the upcoming biennium. After making that determination, the di-
17 rector shall convene a public meeting with representatives of energy resource suppliers and other
18 interested parties for the purpose of providing energy resource suppliers with a full accounting of:

19 (A) The projected revenue needed to fund each department program or activity; and

20 (B) The projected allocation of moneys derived from the assessment imposed under this sub-
21 section to each department program or activity.

22 (c) Upon approval of the budget authorization of the council and the department by an odd-
23 numbered year regular session of the Legislative Assembly, the director shall promptly enter an
24 order establishing the amount of revenues required to be derived from an assessment pursuant to
25 this subsection in order to fund programs and activities that the council and the department are
26 charged with administering and authorized to conduct under the laws of this state, including those
27 enumerated in ORS 469.030, for the first fiscal year of the forthcoming biennium. On or before June
28 1 of each even-numbered year, the director shall enter an order establishing the amount of revenues
29 required to be derived from an assessment pursuant to this subsection in order to fund the programs
30 and activities that the council and the department are charged with administering and authorized
31 to conduct under the laws of this state, including those enumerated in ORS 469.030, for the second
32 fiscal year of the biennium. The order shall take into account any revisions to the biennial budget
33 of the council and the department made by the Emergency Board meeting in an interim period or
34 by the Legislative Assembly meeting in special session or in an even-numbered year regular session.

35 (d) Each order issued by the director pursuant to paragraph (c) of this subsection shall allocate
36 the aggregate assessment set forth in the order to energy resource suppliers in accordance with
37 paragraph (e) of this subsection.

38 (e) The amount assessed to an energy resource supplier shall be based on the ratio which that
39 supplier's annual gross operating revenue derived within this state in the preceding calendar year
40 bears to the total gross operating revenue derived within this state during that year by all energy
41 resource suppliers. The assessment against an energy resource supplier shall not exceed [0.375] **0.1**
42 percent of the supplier's gross operating revenue derived within this state in the preceding calendar
43 year. The director shall exempt from payment of an assessment any individual energy resource
44 supplier whose calculated share of the annual assessment is less than [\$250] **\$2,500**.

45 (f) The director shall send each energy resource supplier subject to assessment pursuant to this

1 subsection a copy of each order issued by registered or certified mail or through use of an electronic
 2 medium with electronic receipt verification. The amount assessed to the energy resource supplier
 3 pursuant to the order shall be considered to the extent otherwise permitted by law a government-
 4 imposed cost and recoverable by the energy resource supplier as a cost included within the price
 5 of the service or product supplied.

6 (g) The amounts assessed to individual energy resource suppliers pursuant to paragraph (e) of
 7 this subsection shall be paid to the department as follows:

8 (A) Amounts assessed for the first fiscal year of a biennium shall be paid not later than 90 days
 9 following adjournment sine die of the odd-numbered year regular session of the Legislative Assem-
 10 bly; and

11 (B) Amounts assessed for the second fiscal year of a biennium shall be paid not later than July
 12 1 of each even-numbered year or 90 days following adjournment sine die of the even-numbered year
 13 regular session of the Legislative Assembly, whichever is later.

14 (h) An energy resource supplier shall provide the director, on or before May 1 of each year, a
 15 verified statement showing its gross operating revenues derived within the state for the calendar
 16 or fiscal year that was used by the energy resource supplier for the purpose of reporting federal
 17 income taxes for the preceding calendar or fiscal year. The statement must be in the form prescribed
 18 by the director and is subject to audit by the director. The statement must include an entry showing
 19 the total operating revenue derived by petroleum suppliers from fuels sold that are subject to the
 20 requirements of Article IX, section 3a, of the Oregon Constitution, and ORS 319.020 with reference
 21 to aircraft fuel and motor vehicle fuel, and ORS 319.530. The director may grant an extension of not
 22 more than 15 days for the requirements of this subsection if:

23 (A) The energy supplier makes a showing of hardship caused by the deadline;

24 (B) The energy supplier provides reasonable assurance that the energy supplier can comply with
 25 the revised deadline; and

26 (C) The extension of time does not prevent the council or the department from fulfilling its
 27 statutory responsibilities.

28 (i) As used in this section:

29 (A) "Energy resource supplier" means an electric utility, natural gas utility or petroleum sup-
 30 plier supplying, generating, transmitting or distributing electricity, natural gas or petroleum pro-
 31 ducts in Oregon.

32 (B) "Gross operating revenue" means [*gross receipts from sales or service made or provided*
 33 *within this state*] **the gross receipts of an energy resource supplier from supplying, generating,**
 34 **transmitting or distributing electricity, natural gas or petroleum products in Oregon** during
 35 the regular course of the energy **resource** supplier's business, but does not include:

36 (i) [*either*] Revenue derived from interutility sales within [*the*] **this** state;

37 (ii) [*or*] Revenue received by a petroleum supplier from the sale of fuels that are subject to the
 38 requirements of Article IX, section 3a, of the Oregon Constitution, or ORS 319.020 or 319.530[.]; **or**

39 (iii) **Revenue received by a petroleum supplier for the sale of propane infrastructure.**

40 (C) "Petroleum supplier" has the meaning given that term in ORS 469.020.

41 (j) In determining the amount of revenues that must be derived from any class of energy re-
 42 source suppliers by assessment pursuant to this subsection, the director shall take into account all
 43 other known or readily ascertainable sources of revenue to the council and department, including,
 44 but not limited to, fees imposed under this section and federal funds, and may take into account any
 45 funds previously assessed pursuant to ORS 469.420 (1979 Replacement Part) or section 7, chapter

1 792, Oregon Laws 1981.

2 (k) Orders issued by the director pursuant to this section shall be subject to judicial review
3 under ORS 183.484. The taking of judicial review shall not operate to stay the obligation of an en-
4 ergy resource supplier to pay amounts assessed to it on or before the statutory deadline.

5 (9)(a) In addition to any other fees required by law, each operator of a nuclear fueled thermal
6 power plant or nuclear installation within this state shall pay to the department annually on July
7 1 an assessment in an amount determined by the director to be necessary to fund the activities of
8 the state and the counties associated with emergency preparedness for a nuclear fueled thermal
9 power plant or nuclear installation. The assessment shall not exceed \$461,250 per year. Moneys
10 collected as assessments under this subsection are continuously appropriated to the department for
11 this purpose.

12 (b) The department shall maintain and cause other state agencies and counties to maintain time
13 and billing records for the expenditure of any fees collected from an operator of a nuclear fueled
14 thermal power plant under paragraph (a) of this subsection.

15 (10) Reactors operated by a college, university or graduate center for research purposes and
16 electric utilities not connected to the Northwest Power Grid are exempt from the fee requirements
17 of subsections (5), (8) and (9) of this section.

18 (11)(a) All fees assessed by the director against holders of site certificates for facilities that have
19 an installed capacity of 500 megawatts or greater may be paid in several installments, the schedule
20 for which shall be negotiated between the director and the site certificate holder.

21 (b) Energy resource suppliers or applicants or holders of a site certificate who fail to pay a fee
22 provided under subsections (1) to (9) of this section after it is due and payable shall pay, in addition
23 to that fee, a penalty of two percent of the fee a month for the period that the fee is past due. Any
24 payment made according to the terms of a schedule negotiated under paragraph (a) of this sub-
25 section shall not be considered past due. The director may bring an action to collect an unpaid fee
26 or penalty in the name of the State of Oregon in a court of competent jurisdiction. The court may
27 award reasonable attorney fees to the director if the director prevails in an action under this sub-
28 section. The court may award reasonable attorney fees to a defendant who prevails in an action
29 under this subsection if the court determines that the director had no objectively reasonable basis
30 for asserting the claim or no reasonable basis for appealing an adverse decision of the trial court.

31 **SECTION 21a. The amendments to ORS 469.421 by section 21 of this 2017 Act apply to**
32 **assessments against energy resource suppliers that are due and payable to the State De-**
33 **partment of Energy on or after July 1, 2018.**

35 **SMALL SCALE LOCAL ENERGY PROJECTS**
36 **AND CLEAN ENERGY DEPLOYMENT PROGRAM**

37
38 **(Transfer of Duties, Functions and Powers)**
39

40 **SECTION 22. Except for the duty to establish by rule standards and criteria for small**
41 **scale local energy projects under ORS 470.080 (1), the duties, functions and powers of the**
42 **State Department of Energy related to the issuance of loans for small scale local energy**
43 **projects under ORS chapter 470 and to the clean energy deployment program are imposed**
44 **upon, transferred to and vested in the Oregon Business Development Department.**
45

(Records, Property, Employees)

SECTION 23. (1) The Director of the State Department of Energy shall deliver to the Oregon Business Development Department all records and property within the jurisdiction of the director that relate to the duties, functions and powers transferred by section 22 of this 2017 Act, and the Director of the Oregon Business Development Department shall take possession of the records and property.

(2) The Governor shall resolve any dispute between the State Department of Energy and the Oregon Business Development Department relating to transfers of records and property under this section, and the Governor's decision is final.

(Unexpended Revenues)

SECTION 24. (1) The unexpended balances of amounts authorized to be expended by the State Department of Energy for the biennium beginning July 1, 2017, from revenues dedicated, continuously appropriated, appropriated or otherwise made available for the purpose of administering and enforcing the duties, functions and powers transferred by section 22 of this 2017 Act are transferred to and are available for expenditure by the Oregon Business Development Department for the biennium beginning July 1, 2017, for the purpose of administering and enforcing the duties, functions and powers transferred by section 22 of this 2017 Act.

(2) The expenditure classifications, if any, established by Acts authorizing or limiting expenditures by the State Department of Energy remain applicable to expenditures by the Oregon Business Development Department under this section.

(Action, Proceeding, Prosecution)

SECTION 25. The transfer of duties, functions and powers to the Oregon Business Development Department by section 22 of this 2017 Act does not affect any action, proceeding or prosecution involving or with respect to the duties, functions and powers begun before and pending at the time of the transfer, except that the Oregon Business Development Department is substituted for the State Department of Energy in the action, proceeding or prosecution.

(Liability, Duty, Obligation)

SECTION 26. (1) Nothing in sections 22 to 28 of this 2017 Act or in the amendments to statutes by sections 29 to 33 and 35 to 56 of this 2017 Act or the repeal of ORS 470.100 by section 34 of this 2017 Act relieves a person of a liability, duty or obligation accruing under or with respect to the duties, functions and powers transferred by section 22 of this 2017 Act. The Oregon Business Development Department may undertake the collection or enforcement of any such liability, duty or obligation.

(2) The rights and obligations of the State Department of Energy legally incurred under contracts, leases and business transactions executed, entered into or begun before the operative date of section 22 of this 2017 Act accruing under or with respect to the duties,

1 functions and powers transferred by section 22 of this 2017 Act are transferred to the Oregon
2 Business Development Department. For the purpose of succession to these rights and obli-
3 gations, the Oregon Business Development Department is a continuation of the State De-
4 partment of Energy and not a new authority.

9 development of the proposed small scale local energy project, and whether any other moneys are

13 *to an individual,]* A fee of one-tenth of one percent of the amount of the loan applied for or \$2,500,

15 quired to pay for costs incurred in connection with the application that exceed the application fee
16 and which the Director of the *[State Department of Energy]* **Oregon Business Development De-**

39 (d) Net investment earnings on any funds loaned to municipal corporations but withheld as
 40 provided in ORS 470.230.

41 (e) Costs of issuing the bonds and of obtaining credit enhancement for the bonds.

42 (2) The fund created by subsection (1) of this section shall consist of:

43 (a) Application fees required by ORS 470.060, unless the department requires the applicant to

29 wise made confidential or privileged under Oregon law.

30 (b) Subject to ORS 192.423, paragraph (a) of this subsection does not apply to factual information
31 compiled in a public record when:

32 (A) The basis for the claim of exemption is ORS 40.225;

33 (B) The factual information is not prohibited from disclosure under any applicable state or fed-
34 eral law, regulation or court order and is not otherwise exempt from disclosure under ORS 192.410
35 to 192.505;

36 (C) The factual information was compiled by or at the direction of an attorney as part of an
37 investigation on behalf of the public body in response to information of possible wrongdoing by the
38 public body;

23 including but not limited to records regarding the solicitation, acquisition, deployment, exchange or
24 liquidation of the investments including but not limited to:

25 (A) Due diligence materials that are proprietary to an investment fund, to an asset ownership
26 or to their respective investment vehicles.

27 (B) Financial statements of an investment fund, an asset ownership or their respective invest-
28 ment vehicles.

29 (C) Meeting materials of an investment fund, an asset ownership or their respective investment
30 vehicles.

31 (D) Records containing information regarding the portfolio positions in which an investment
32 fund, an asset ownership or their respective investment vehicles invest.

8 (25) Raster geographic information system (GIS) digital databases, provided by private forestland

10 that is not otherwise required by law to be submitted.

11 (26) Sensitive business, commercial or financial information furnished to or developed by a
12 public body engaged in the business of providing electricity or electricity services, if the information
13 is directly related to a transaction described in ORS 261.348, or if the information is directly related
14 to a bid, proposal or negotiations for the sale or purchase of electricity or electricity services, and
15 disclosure of the information would cause a competitive disadvantage for the public body or its re-
16 tail electricity customers. This subsection does not apply to cost-of-service studies used in the de-

25 people's utility district or the names, dates of birth, driver license numbers, telephone numbers,
26 electronic mail addresses or Social Security numbers of customers who receive water, sewer or
27 storm drain services from a public body as defined in ORS 174.109. The utility or district may re-
28 lease personally identifiable information about a customer, and a public body providing water, sewer
29 or storm drain services may release the name, date of birth, driver license number, telephone num-

19 (34) The information specified in ORS 25.020 (8) if the Chief Justice of the Supreme Court des-
20 ignates the information as confidential by rule under ORS 1.002.

21 (35)(a) Employer account records of the State Accident Insurance Fund Corporation.

22 (b) As used in this subsection, "employer account records" means all records maintained in any
23 form that are specifically related to the account of any employer insured, previously insured or un-

8 agency and the State Department of Energy shall agree to the list of energy conservation measures
9 and alternative energy systems that the energy consumption analysis will include. The energy con-
10 sumption analysis and facility design shall be delivered to the State Department of Energy during
11 the design development phase of the facility design. The State Department of Energy shall review
12 the energy consumption analysis and forward its findings to the authorized state agency within 10
13 working days after receiving the energy consumption analysis, if practicable.

14 (3) The [*State Department of Energy*] **Oregon Energy Commission**, in consultation with au-
15 thorized state agencies, shall adopt rules to carry out the provisions of ORS 276.900 to 276.915.
16 These rules shall:

17 (a) Include a simplified and usable method for determining which energy conservation measures
18 and alternative energy systems are cost-effective. The method shall reflect the energy costs of the

(b) Enter into an energy savings performance contract; or

(c) Perform energy audits, building commissioning, monitoring and verification services and other services related to the operation and management of a facility's energy systems, except for architectural, engineering, photogrammetric mapping, transportation planning or land surveying services as defined in ORS 279C.100.

(8) The State Department of Energy may recover from authorized state agencies the costs associated with administering the provisions of this section, including costs associated with [*adopting rules*] **the adoption of rules by the commission**, maintaining a state energy use database and prequalifying a person under this section.

(9) The State Department of Energy and the Oregon Department of Administrative Services shall jointly prepare a biennial report summarizing the progress toward achieving the goals of this section. The biennial report shall be made available to the public.

SECTION 92. ORS 279C.528 is amended to read:

279C.528. (1) Each contracting agency, in soliciting, awarding and administering public improvement contracts that are subject to ORS 279C.527, is subject to rules **adopted by** the [*State Department of Energy*] **Oregon Energy Commission** [*adopts*] that include, but are not limited to, requirements and specifications for:

(a) Using particular green energy technologies in public improvements;

(b) Determining the cost-effectiveness of green energy technologies;

(2)(a) Each contracting agency shall collect and maintain information concerning the contracting agency's compliance with ORS 279C.527, which must include, at a minimum:

(A) Records that show how the contracting agency spent moneys the contracting agency used in including appropriate green energy technology as part of constructing, reconstructing or performing a major renovation of a public building;

(B) An identification of each public improvement contract for which the contracting agency spent moneys to include appropriate green technology as part of constructing, reconstructing or performing a major renovation of a public building;

(C) An identification of each public improvement contract for which the contracting agency determined that including green technology as part of constructing, reconstructing or performing a major renovation of a public building was not appropriate;

1 (D) The total amount the contracting agency would have spent on each public improvement
2 contract identified in subparagraph (C) of this paragraph and the total aggregated amount that the
3 contracting agency must spend to include green energy technology as part of constructing, recon-
4 structing or performing a major renovation of a future public building; and

5 (E) An identification of each public improvement contract that uses moneys the contracting
6 agency did not spend in a previous public improvement contract for including appropriate green
7 energy technology as part of constructing, reconstructing or performing a major renovation of a
8 public building.

9 (b) Each contracting agency shall compile the information the contracting agency collected un-
10 der paragraph (a) of this subsection and report the information to the department at times, in a

9 renewable portfolio standard for up to 11 average megawatts of electricity generated per calendar
10 year.

11 **SECTION 118.** ORS 469A.025 is amended to read:

12 469A.025. (1) Electricity generated utilizing the following types of energy may be used to comply
13 with a renewable portfolio standard:

- 14 (a) Wind energy.
- 15 (b) Solar photovoltaic and solar thermal energy.
- 16 (c) Wave, tidal and ocean thermal energy.
- 17 (d) Geothermal energy.

18 (2) Except as provided in subsection (3) of this section, electricity generated from biomass and
19 biomass by-products may be used to comply with a renewable portfolio standard, including but not
20 limited to electricity generated from:

- 21 (a) Organic human or animal waste;
- 22 (b) Spent pulping liquor;
- 23 (c) Forest or rangeland woody debris from harvesting or thinning conducted to improve forest
24 or rangeland ecological health and to reduce uncharacteristic stand replacing wildfire risk;
- 25 (d) Wood material from hardwood timber grown on land described in ORS 321.267 (3);
- 26 (e) Agricultural residues;
- 27 (f) Dedicated energy crops; and
- 28 (g) Landfill gas or biogas produced from organic matter, wastewater, anaerobic digesters or
29 municipal solid waste.

30 (3) Electricity generated from the direct combustion of biomass may not be used to comply with
31 a renewable portfolio standard if any of the biomass combusted to generate the electricity includes
32 wood that has been treated with chemical preservatives such as creosote, pentachlorophenol or
33 chromated copper arsenate.

34 (4) Electricity generated by a hydroelectric facility may be used to comply with a renewable
35 portfolio standard only if:

36 (a) The facility is located outside any protected area designated by the Pacific Northwest Elec-
37 tric Power and Conservation Planning Council as of July 23, 1999, or any area protected under the
38 federal Wild and Scenic Rivers Act, P.L. 90-542, or the Oregon Scenic Waterways Act, ORS 390.805
39 to 390.925; or

40 (b) The electricity is attributable to efficiency upgrades made to the facility on or after January
41 1, 1995.

42 (5)(a) Up to 50 average megawatts of electricity per year generated by an electric utility from
43 certified low-impact hydroelectric facilities described in ORS 469A.020 (4)(a) may be used to comply
44 with a renewable portfolio standard, without regard to the number of certified facilities operated
45 by the electric utility or the generating capacity of those facilities. A hydroelectric facility described

1 in this paragraph is not subject to the requirements of subsection (4) of this section.

2 (b) Up to 40 average megawatts of electricity per year generated by certified low-impact hy-
3 droelectric facilities described in ORS 469A.020 (4)(b) may be used to comply with a renewable
4 portfolio standard, without regard to the number of certified facilities or the generating capacity
5 of those facilities. A hydroelectric facility described in this paragraph is not subject to the require-
6 ments of subsection (4) of this section.

7 (6)(a) Direct combustion of municipal solid waste in a generating facility located in this state
8 may be used to comply with a renewable portfolio standard. The qualification of a municipal solid
9 waste facility for use in compliance with a renewable portfolio standard has no effect on the quali-
10 fication of the facility for a tax credit under ORS 469B.130 to 469B.169.

11 (b) The total amount of electricity generated in this state by direct combustion of municipal
12 solid waste by generating facilities that became operational in this state on or after January 1, 1995,
13 may not exceed nine average megawatts per year for the purpose of complying with a renewable
14 portfolio standard.

15 (7) Electricity generated from hydrogen gas, including electricity generated by hydrogen power
16 stations using anhydrous ammonia as a fuel source, may be used to comply with a renewable port-

10 (b) Meets the requirements of ORS 469B.100 to 469B.118; and

11 (c) Pays, subject to subsection (9) of this section, all or a portion of the costs of an alternative

24 (10) Photovoltaic systems installed on recreational vehicles;

25 (11) Conversion of an existing alternative energy device to another type of alternative energy
26 device;

27 (12) Repair or replacement of an existing alternative energy device;

28 (13) A category two alternative energy device, if the equipment or other property that comprises
29 the category two alternative energy device is the basis for an allowed credit for a category one al-
30 ternative energy device under ORS 316.116;

31 (14) A category one alternative energy device, if the equipment or other property that comprises
32 the category one alternative energy device is also the basis for an allowed credit for a category two
33 alternative energy device under ORS 316.116; or

34 (15) Any other device identified by the [*State Department of Energy*] **Oregon Energy Commis-**
35 **sion.** The [*department*] **commission** may adopt rules defining standards for eligible and ineligible
36 devices under this section.

37 **SECTION 122.** ORS 469B.130 is amended to read:

38 469B.130. As used in ORS 469B.130 to 469B.169 and 469B.171:

39 (1) "Alternative fuel vehicle" means a vehicle as defined by the [*Director of the State Department*
40 *of Energy*] **Oregon Energy Commission** by rule that is used primarily in connection with the con-
41 duct of a trade or business and that is manufactured or modified to use an alternative fuel, including
42 but not limited to electricity, ethanol, methanol, gasohol and propane or natural gas, regardless of
43 energy consumption savings.

44 (2) "Car sharing facility" means the expenses of operating a car sharing program, including but
45 not limited to the fair market value of parking spaces used to store the fleet of cars available for

3 to have joint access to a fleet of cars from a common parking area on an hourly basis. "Car sharing

20 (D) Perform a process that obtains energy resources from material that would otherwise be solid
21 waste as defined in ORS 459.005; or

22 (E) Manufacture or distribute alternative fuels, including but not limited to electricity, ethanol,
23 methanol, gasohol or biodiesel.

24 (b) Any acquisition of, addition to, reconstruction of or improvement of land or an existing
25 structure, building, installation, excavation, machinery, equipment or device necessarily erected,
26 constructed, installed or acquired by any person in connection with the conduct of a trade or busi-

28 (c) A necessary feature of a new commercial building or multiple unit dwelling, as dwelling is

33 (6) "Facility" means an energy facility, recycling facility, transportation facility, car sharing

35 erate alternative fuel vehicles, including but not limited to an alternative fuel vehicle refueling
36 station, a high-efficiency combined heat and power facility, a high-performance home or a

38 (7) "High-efficiency combined heat and power facility" means a device or equipment that simul-
39 taneously produces heat and electricity from a single source of fuel and that meets the criteria es-
40 tablished for a high-efficiency combined heat and power facility under ORS 469B.139.

41 (8) "High-performance home" means a new single-family dwelling that:

42 (a) Is designed and constructed to reduce net purchased energy through use of both energy ef-
43 ficiency and on-site renewable energy resources; and

44 (b) Meets the criteria established for a high-performance home under ORS 469B.139.

45 (9) "Homebuilder-installed renewable energy system" means a renewable energy resource system

1 that:

2 (a) Meets the criteria established for a renewable energy resource system under ORS 469B.139;
3 and

4 (b) Is installed in a new single-family dwelling by, or at the direction of, the homebuilder con-
5 structing the dwelling.

6 (10) “Qualified transit pass contract” means a purchase agreement entered into between a
7 transportation provider and a person, the terms of which obligate the person to purchase transit
8 passes on behalf or for the benefit of employees, students, patients or other individuals over a
9 specified period of time.

10 (11) “Recycling facility” means equipment used by a trade or business solely for recycling:

11 (a) Including:

12 (A) Equipment used solely for hauling and refining used oil;

13 (B) New vehicles or modifications to existing vehicles used solely to transport used recyclable
14 materials that cannot be used further in their present form or location such as glass, metal, paper,
15 aluminum, rubber and plastic;

27 (B) A hydroelectric generating facility that obtains all applicable permits and complies with all
28 state and federal statutory requirements for the protection of fish and wildlife and that:

31 (C) A renewable energy storage device as defined by the [*director*] **commission** by rule.

38 building practice baselines in energy, water or other resource usage for comparative purposes for
39 use in determining whether a facility is a sustainable building practices facility.

40 (14) “Transportation facility” means a transportation project that reduces energy use during
41 commuting to and from work or school, during work-related travel, or during travel to obtain med-
42 ical or other services, and may be further defined by the [*department*] **commission** by rule.

43 “Transportation facility” includes, but is not limited to:

44 (a) A qualified transit pass contract or a transportation services contract; or

45 (b) The purchase of efficient truck technology and related truck trailers, as defined in ORS

4 (15) "Transportation provider" means a public, private or nonprofit entity that provides trans-
5 portation services to members of the public.

6 (16) "Transportation services contract" means a contract that is related to a transportation fa-
7 cility, and may be further defined by the [department] **commission** by rule.

8 **SECTION 123.** ORS 469B.136 is amended to read:

9 469B.136. (1) In determining the eligibility of any facility for tax credits, preference shall be
10 given to those projects that:

11 (a) Provide energy savings for real or personal property within the state inhabited as the prin-
12 cipal residence of a tenant, including:

13 (A) Nonowner occupied single family dwellings; and

14 (B) Multiple unit residential housing; or

15 (b) Provide long-term energy savings from the use of renewable resources or conservation of
16 energy resources.

17 (2) The [Director of the State Department of Energy] **Oregon Energy Commission** shall establish
18 by rule a tiered priority system to be used in evaluating applicants for certification of facilities us-
19 ing or producing renewable energy resources. The tier system shall be based upon the projected

41 (o) Third-party review of the applicant's business plan; or

42 (p) Data related to projected return on investment.

43 **SECTION 124.** ORS 469B.139 is amended to read:

44 469B.139. The [State Department of Energy] **Oregon Energy Commission** shall by rule establish
45 all of the following criteria:

1 (1) For a high-performance home, the minimum design and construction standards that must be
2 met or exceeded for a dwelling to be considered a high-performance home, including but not limited
3 to standards for the building envelope, HVAC systems, lighting, appliances, water conservation
4 measures, use of sustainable building materials and on-site renewable energy systems. The criteria
5 must also establish the minimum reduction in estimated net purchased energy that a dwelling must

15 (4) For a facility using or producing renewable energy resources, standards relating to criteria
16 required under ORS 469B.136 (2).

17 (5) Standards, consistent with the definitions in ORS 469B.130, relating to what constitutes a
18 single facility.

19 **SECTION 125.** ORS 469B.145 is amended to read:

20 469B.145. (1) Prior to erection, construction, installation or acquisition of a proposed facility,
21 any person may apply to the State Department of Energy for preliminary certification under ORS
22 469B.157 if:

23 (a) The erection, construction, installation or acquisition of the facility is to be commenced on
24 or after October 3, 1979;

25 (b) The facility complies with the standards or rules adopted by the [*Director of the State De-*
26 *partment of Energy*] **Oregon Energy Commission**; and

27 (c) The applicant meets one of the following criteria:

28 (A) The applicant is a person to whom a tax credit for the facility has been transferred; or

29 (B) The applicant will be the owner, contract purchaser or lessee of the facility at the time of
30 erection, construction, installation or acquisition of the proposed facility, and:

31 (i) The applicant is the owner, contract purchaser or lessee of a trade or business that plans to
32 utilize the facility in connection with Oregon property; or

33 (ii) The applicant is the owner, contract purchaser or lessee of a trade or business that plans

35 (2) An application for preliminary certification shall be made in writing on a form prepared by
36 the department and shall contain:

37 (a) A statement that the applicant or the lessee of the applicant's facility:

38 (A) Intends to convert from a purchased energy source to a renewable energy resource;

39 (B) Plans to acquire, construct or install a facility that will use a renewable energy resource
40 or solid waste instead of electricity, petroleum or natural gas;

35 does not include fines or penalties as authorized by state or federal law.

36 **SECTION 153.** ORS 757.612 is amended to read:

37 757.612. (1) There is established an annual public purpose expenditure standard for electric
38 companies and Oregon Community Power to fund new cost-effective local energy conservation, new
39 market transformation efforts, the above-market costs of new renewable energy resources and new
40 low-income weatherization. The public purpose expenditure standard shall be funded by the public
41 purpose charge described in subsection (2) of this section.

42 (2)(a) Beginning on the date an electric company or Oregon Community Power offers direct ac-
43 cess to its retail electricity consumers, except residential electricity consumers, the electric com-
44 pany or Oregon Community Power shall collect a public purpose charge from all of the retail
45 electricity consumers located within its service area until January 1, 2026. Except as provided in

1 paragraph (b) of this subsection, the public purpose charge shall be equal to three percent of the
2 total revenues collected by the electric company, Oregon Community Power or the electricity ser-
3 vice supplier from its retail electricity consumers for electricity services, distribution, ancillary
4 services, metering and billing, transition charges and other types of costs included in electric rates
5 on July 23, 1999.

6 (b) For an aluminum plant that averages more than 100 average megawatts of electricity use
7 per year, beginning on March 1, 2002, the electric company or Oregon Community Power whose
8 territory abuts the greatest percentage of the site of the aluminum plant shall collect from the alu-
9 minum company a public purpose charge equal to one percent of the total revenue from the sale of
10 electricity services to the aluminum plant from any source.

11 (3)(a) The Public Utility Commission shall establish rules implementing the provisions of this
12 section relating to electric companies and Oregon Community Power.

13 (b) Subject to paragraph (e) of this subsection, funds collected by an electric company or Oregon
14 Community Power through public purpose charges shall be allocated as follows:

15 (A) Sixty-three percent for new cost-effective conservation, new market transformation.

16 (B) Nineteen percent for the above-market costs of constructing and operating new renewable
17 energy resources with a nominal electric generating capacity, as defined in ORS 469.300, of 20
18 megawatts or less.

19 (C) Thirteen percent for new low-income weatherization.

20 (D) Five percent shall be transferred to the Housing and Community Services Department
21 Electricity Public Purpose Charge Fund established by ORS 456.587 (1) and used for the purpose of
22 providing grants as described in ORS 458.625 (2).

23 (c) The costs of administering subsections (1) to (6) of this section for an electric company or
24 Oregon Community Power shall be paid out of the funds collected through public purpose charges.
25 The commission may require that an electric company or Oregon Community Power direct funds
26 collected through public purpose charges to the state agencies responsible for implementing sub-
27 sections (1) to (6) of this section in order to pay the costs of administering such responsibilities.

28 (d) The commission shall direct the manner in which public purpose charges are collected and
29 spent by an electric company or Oregon Community Power and may require an electric company
30 or Oregon Community Power to expend funds through competitive bids or other means designed to
31 encourage competition, except that funds dedicated for low-income weatherization shall be directed
32 to the Housing and Community Services Department as provided in subsection (7) of this section.
33 The commission may also direct that funds collected by an electric company or Oregon Community
34 Power through public purpose charges be paid to a nongovernmental entity for investment in public
35 purposes described in subsection (1) of this section. Notwithstanding any other provision of this
36 subsection:

37 (A) At least 80 percent of the funds allocated for conservation shall be spent within the service
38 area of the electric company that collected the funds; or

39 (B) If Oregon Community Power collected the funds, at least 80 percent of the funds allocated
40 for conservation shall be spent within the service area of Oregon Community Power.

41 (e)(A) The first 10 percent of the funds collected annually by an electric company or Oregon
42 Community Power under subsection (2) of this section shall be distributed to school districts that
43 are located in the service territory of the electric company or Oregon Community Power. The funds
44 shall be distributed to individual school districts according to the weighted average daily member-
45 ship (ADMw) of each school district for the prior fiscal year as calculated under ORS 327.013. The

1 commission shall establish by rule a methodology for distributing a proportionate share of funds
2 under this paragraph to school districts that are only partially located in the service territory of the
3 electric company or Oregon Community Power.

4 (B) A school district that receives funds under this paragraph shall use the funds first to pay
5 for energy audits for schools located within the school district. A school district may not expend
6 additional funds received under this paragraph on a school facility until an energy audit has been
7 completed for that school facility. To the extent practicable, a school district shall coordinate with
8 the State Department of Energy and incorporate federal funding in complying with this paragraph.
9 Following completion of an energy audit for an individual school, the school district may expend
10 funds received under this paragraph to implement the energy audit. Once an energy audit has been
11 conducted and completely implemented for each school within the school district, the school district
12 may expend funds received under this paragraph for any of the following purposes:

13 (i) Conducting energy audits. A school district shall conduct an energy audit prior to expending
14 funds on any other purpose authorized under this paragraph unless the school district has performed
15 an energy audit within the three years immediately prior to receiving the funds.

16 (ii) Weatherization and upgrading the energy efficiency of school district facilities.

17 (iii) Energy conservation education programs.

18 (iv) Purchasing electricity from environmentally focused sources and investing in renewable
19 energy resources.

20 (f) The commission may not establish a different public purpose charge than the public purpose
21 charge described in subsection (2) of this section.

22 (g) If the commission directs funds collected through public purpose charges to a nongovern-
23 mental entity, the entity shall:

24 (A) Include on the entity's board of directors an ex officio member designated by the commis-
25 sion, who shall also serve on the entity's nominating committee for filling board vacancies.

26 (B) Require the entity's officers and directors to provide an annual disclosure of economic in-
27 terest to be filed with the commission on or prior to April 15 of each calendar year for public review
28 in a form similar to the statement of economic interest required for public officials under ORS
29 244.060.

30 (C) Require the entity's officers and directors to declare actual and potential conflicts of interest
31 at regular meetings of the entity's governing body when such conflicts arise, and require an officer
32 or director to abstain from participating in any discussion or vote on any item where that officer
33 or director has an actual conflict of interest. For the purposes of this subparagraph, "actual conflict
34 of interest" and "potential conflict of interest" have the meanings given those terms in ORS 244.020.

35 (D) Arrange for an independent auditor to audit the entity's financial statements annually, and
36 direct the auditor to file an audit opinion with the commission for public review.

37 (E) File with the commission annually the entity's budget, action plan and quarterly and annual
38 reports for public review.

39 (F) At least once every five years, contract for an independent management evaluation to review
40 the entity's operations, efficiency and effectiveness, and direct the independent reviewer to file a
41 report with the commission for public review.

42 (h) The commission may remove from the board of directors of a nongovernmental entity an of-
43 ficer or director who fails to provide an annual disclosure of economic interest or declare actual
44 or potential conflict of interest, as described in paragraph (g)(B) and (C) of this subsection, in con-
45 nection with the allocation or expenditure of funds collected through public purpose charges and

1 directed to the entity.

2 (4)(a) An electric company that satisfies its obligations under this section shall have no further
3 obligation to invest in conservation, new market transformation or new low-income weatherization
4 or to provide a commercial energy conservation services program and is not subject to ORS 469.631
5 to 469.645 and 469.860 to 469.900.

6 (b) Oregon Community Power, for any period during which Oregon Community Power collects
7 a public purpose charge under subsection (2) of this section:

8 (A) Shall have no other obligation to invest in conservation, new market transformation or new
9 low-income weatherization or to provide a commercial energy conservation services program; and

10 (B) Is not subject to ORS 469.631 to 469.645 and 469.860 to 469.900.

11 (5)(a) A retail electricity consumer that uses more than one average megawatt of electricity at
12 any site in the prior year shall receive a credit against public purpose charges billed by an electric
13 company or Oregon Community Power for that site. The amount of the credit shall be equal to the
14 total amount of qualifying expenditures for new energy conservation, not to exceed 68 percent of the
15 annual public purpose charges, and the above-market costs of purchases of new renewable energy
16 resources incurred by the retail electricity consumer, not to exceed 19 percent of the annual public
17 purpose charges, less administration costs incurred under this subsection. The credit may not ex-
18 ceed, on an annual basis, the lesser of:

19 (A) The amount of the retail electricity consumer's qualifying expenditures; or

20 (B) The portion of the public purpose charge billed to the retail electricity consumer that is
21 dedicated to new energy conservation, new market transformation or the above-market costs of new
22 renewable energy resources.

23 (b) To obtain a credit under this subsection, a retail electricity consumer shall file with the
24 State Department of Energy a description of the proposed conservation project or new renewable
25 energy resource and a declaration that the retail electricity consumer plans to incur the qualifying
26 expenditure. The State Department of Energy shall issue a notice of precertification within 30 days
27 of receipt of the filing, if such filing is consistent with this subsection. The credit may be taken after
28 a retail electricity consumer provides a letter from a certified public accountant to the State De-
29 partment of Energy verifying that the precertified qualifying expenditure has been made.

30 (c) Credits earned by a retail electricity consumer as a result of qualifying expenditures that
31 are not used in one year may be carried forward for use in subsequent years.

32 (d)(A) A retail electricity consumer that uses more than one average megawatt of electricity at
33 any site in the prior year may request that the State Department of Energy hire an independent
34 auditor to assess the potential for conservation investments at the site. If the independent auditor
35 determines there is no available conservation measure at the site that would have a simple payback
36 of one to 10 years, the retail electricity consumer shall be relieved of 54 percent of its payment
37 obligation for public purpose charges related to the site. If the independent auditor determines that
38 there are potential conservation measures available at the site, the retail electricity consumer shall
39 be entitled to a credit against public purpose charges related to the site equal to 54 percent of the
40 public purpose charges less the estimated cost of available conservation measures.

41 (B) A retail electricity consumer shall be entitled each year to the credit described in this sub-
42 section unless a subsequent independent audit determines that new conservation investment oppor-
43 tunities are available. The State Department of Energy may require that a new independent audit
44 be performed on the site to determine whether new conservation measures are available, provided
45 that the independent audits shall occur no more than once every two years.

1 (C) The retail electricity consumer shall pay the cost of the independent audits described in this
2 subsection.

3 (6) Electric utilities and retail electricity consumers shall receive a fair and reasonable credit
4 for the public purpose expenditures of their energy suppliers. The [*State Department of Energy*]
5 **Oregon Energy Commission** shall adopt rules to determine eligible expenditures and the method-
6 ology by which such credits are accounted for and used. The rules also shall adopt methods to ac-
7 count for eligible public purpose expenditures made through consortia or collaborative projects.

8 (7)(a) In addition to the public purpose charge provided under subsection (2) of this section, an
9 electric company or Oregon Community Power shall collect funds for low-income electric bill pay-
10 ment assistance in an amount determined under paragraph (b) of this subsection.

11 (b) The **Public Utility** Commission shall establish the amount to be collected by each electric
12 company in calendar year 2008 from retail electricity consumers served by the company, and the
13 rates to be charged to retail electricity consumers served by the company, so that the total antic-
14 ipated collection for low-income electric bill payment assistance by all electric companies in calen-
15 dar year 2008 is \$15 million. In calendar year 2009 and subsequent calendar years, the commission
16 may not change the rates established for retail electricity consumers, but the total amount collected
17 in a calendar year for low-income electric bill payment assistance may vary based on electricity
18 usage by retail electricity consumers and changes in the number of retail electricity consumers in
19 this state. In no event shall a retail electricity consumer be required to pay more than \$500 per
20 month per site for low-income electric bill payment assistance.

21 (c) Funds collected by the low-income electric bill payment assistance charge shall be paid into
22 the Housing and Community Services Department Low-Income Electric Bill Payment Assistance
23 Fund established by ORS 456.587 (2). Moneys deposited in the fund under this paragraph shall be
24 used by the Housing and Community Services Department for the purpose of funding low-income
25 electric bill payment assistance. The department's cost of administering this subsection shall be paid
26 out of funds collected by the low-income electric bill payment assistance charge. Moneys deposited
27 in the fund under this paragraph shall be expended solely for low-income electric bill payment as-
28 sistance. Funds collected from an electric company or Oregon Community Power shall be expended
29 in the service area of the electric company or Oregon Community Power from which the funds are
30 collected.

31 (d)(A) The Housing and Community Services Department shall determine the manner in which
32 funds collected under this subsection will be allocated by the department to energy assistance pro-
33 gram providers for the purpose of providing low-income bill payment and crisis assistance.

34 (B) The department shall investigate and may implement alternative delivery models in consul-
35 tation with electric companies to effectively reduce service disconnections and related costs to retail
36 electricity consumers and electric utilities.

37 (C) Priority assistance shall be directed to low-income electricity consumers who are in danger
38 of having their electricity service disconnected.

39 (D) The department shall maintain records and provide those records upon request to an electric
40 company, Oregon Community Power and the Citizens' Utility Board established under ORS chapter
41 774 on a quarterly basis. Records maintained must include the numbers of low-income electricity
42 consumers served, the average amounts paid and the type of assistance provided. Electric companies
43 and Oregon Community Power shall, if requested, provide the department with aggregate data re-
44 lating to consumers served on a quarterly basis to support program development.

45 (e) Interest on moneys deposited in the Housing and Community Services Department Low-

1 Income Electric Bill Payment Assistance Fund established by ORS 456.587 (2) may be used to pro-
2 vide bill payment and crisis assistance to electricity consumers whose primary source of heat is not
3 electricity.

4 (f) Notwithstanding ORS 757.310, the commission may allow an electric company or Oregon
5 Community Power to provide reduced rates or other payment or crisis assistance or low-income
6 program assistance to a low-income household eligible for assistance under the federal Low Income
7 Home Energy Assistance Act of 1981, as amended and in effect on July 23, 1999.

8 (8) For purposes of this section, "retail electricity consumers" includes any direct service in-
9 dustrial consumer that purchases electricity without purchasing distribution services from the elec-
10 tric utility.

11 (9) For purposes of this section, amounts collected by Oregon Community Power through public
12 purpose charges are not considered moneys received from electric utility operations.

17 **SECTION 155.** (1) **The State Department of Energy shall study and prepare a report de-**
18 **tailing the department's recommendations for restructuring the department to focus only**
19 **on the critical functions of the department in light of the policy stated in ORS 469.010, as**
20 **amended by section 1 of this 2017 Act, and the programs and activities enumerated in ORS**
21 **469.030, as amended by section 11 of this 2017 Act, and in furtherance of the following ob-**
22 **jectives:**

23 (a) **Restructuring the department into the following four sections:**

24 (A) **An information and analysis section that will collect from all available sources, ana-**
25 **lyze and disseminate Oregon energy information, research new technologies and resources**
26 **and apply clear metrics to evaluate all forms of energy using unbiased technical analysis that**
27 **considers the energy source, distribution and cost or savings for all Oregonians;**

28 (B) **A technical assistance section to serve as a resource to the Legislative Assembly,**
29 **energy stakeholders and other state agencies;**

30 (C) **A nuclear safety and emergency management section; and**

31 (D) **The Energy Facility Siting Council;**

32 (b) **Transferring all energy incentive programs and other programs that are not other-**
33 **wise transferred by sections 22 and 65 of this 2017 Act or repealed by sections 63 and 64 of**
34 **this 2017 Act and that do not fit within the four sections outlined in paragraph (a) of this**
35 **subsection to other agencies, with continuing technical support provided by the department**
36 **as necessary; and**

37 (c) **Transferring the authority to conduct contested case hearings related to site certif-**
38 **icates from the Energy Facility Siting Council to the Office of Administrative Hearings es-**
39 **tablished under ORS 183.605.**

40 (2) **The study and report required by this section shall also include a review of the op-**
41 **portunities for public involvement in the proceedings of the Energy Facility Siting Council**
42 **under ORS 469.300 to 469.563, 469.590 to 469.619, 469.930 and 469.992 and recommendations,**
43 **which may include recommendations for legislation, on how to increase transparency, en-**
44 **hance opportunities for public involvement and ensure adequate review and response to**
45 **public comments received in the course of the proceedings of the council.**
