  "(b) A person who holds a certificate of certified alcohol drug
  counselor from the Addiction Counselor Certification Board of Oregon
  or its successor organization must complete the pain management
  education program described in ORS 413.572.
- "(2) The Oregon Medical Board, in consultation with the Pain Management Commission, shall identify by rule physicians licensed under ORS chapter 677 who, on an ongoing basis, treat patients in chronic or terminal pain and who must complete [*one*] **the** pain management education program established under ORS 413.572. The board may identify by rule circumstances under which the requirement under this section may be waived.

"(3) Any state board that regulates a person authorized to practice a profession listed in subsection (1)(a) of this section may impose any form of discipline on the person under the laws of this state for violating this section.".
