**PROPOSED AMENDMENTS TO
HOUSE BILL 2391**

1 In line 2 of the printed bill, after the semicolon delete the rest of the line
2 and insert “creating new provisions; amending ORS 291.055, 731.292, 731.509
3 and 731.840 and sections 1, 2, 3, 5, 7, 9, 10, 12, 13 and 14, chapter 736, Oregon
4 Laws 2003, and section 2, chapter 26, Oregon Laws 2016; repealing section
5 15, chapter 389, Oregon Laws 2015; prescribing an effective date; and pro-
6 viding for revenue raising that requires approval by a three-fifths
7 majority.”.

8 Delete lines 4 through 13 and insert:

10 **“HEALTH INSURANCE PREMIUM AND**
11 **MANAGED CARE ASSESSMENT**

12

13 **“SECTION 1. Sections 2 to 8 of this 2017 Act are added to and made**
14 **a part of the Insurance Code.**

15 **“SECTION 2. (1) The Health System Fund is established in the State**
16 **Treasury, separate and distinct from the General Fund. Interest**
17 **earned by the Health System Fund shall be credited to the fund.**

18 **“(2) Amounts in the Health System Fund are continuously appro-**
19 **riated to the Department of Consumer and Business Services for the**
20 **purposes of:**

21 **“(a) Administering the Oregon Reinsurance Program established in**

1 section 18 of this 2017 Act; and

2 “(b) Transferring moneys to the Oregon Health Authority to:

3 “(A) Provide medical assistance and other health services under
4 ORS chapter 414.

5 “(B) Pay refunds due under section 11 of this 2017 Act.

6 “(C) Pay administrative costs incurred by the authority to admin-
7 ister the assessment described in section 9 of this 2017 Act.

8 **“SECTION 3. (1) As used in this section:**

9 “(a) ‘Insured’ means an eligible employee or family member, as
10 defined in ORS 243.105, who is enrolled in a self-insured health benefit
11 plan under ORS 243.105 to 243.285.

12 “(b) ‘Premium equivalent’ means a claim for reimbursement of the
13 cost of a health care item or service provided to an eligible employee
14 or family member, other than a dental or vision care item or service,
15 and the administrative costs associated with the claim.

16 “(2) No later than 45 days following the end of a calendar quarter,
17 the Public Employees’ Benefit Board shall pay an assessment at the
18 rate of 1.5 percent on the gross amount of premium equivalents re-
19 ceived during the calendar quarter.

20 “(3) The assessment shall be paid to the Department of Consumer
21 and Business Services and shall be accompanied by a verified report,
22 on a form prescribed by the department, together with any informa-
23 tion required by the department.

24 “(4) The assessment imposed under this section is in addition to and
25 not in lieu of any tax, surcharge or other assessment imposed on the
26 board.

27 “(5) If the department determines that the assessment paid by the
28 board under this section is incorrect, the department shall charge or
29 credit to the board the difference between the correct amount of the
30 assessment and the amount paid by the board.

1 “(6) The board is entitled to notice and an opportunity for a con-
2 tested case hearing under ORS chapter 183 to contest an action of the
3 department taken pursuant to subsection (5) of this section.

4 “(7) Moneys received by the department under this section shall be
5 paid into the State Treasury and credited to the Health System Fund
6 established under section 2 of this 2017 Act.

7 “SECTION 4. Section 3 of this 2017 Act applies to premium equiv-
8 alents received by the Public Employees’ Benefit Board, or a third
9 party administrator that contracts with the board to administer a
10 self-insured health benefit plan, during the period from January 1,
11 2018, through December 31, 2019.

12 “SECTION 5. (1) As used in this section:

13 “(a) ‘Gross amount of premiums’ has the meaning given that term
14 in ORS 731.808.

15 “(b) ‘Health benefit plan’ has the meaning given that term in ORS
16 743B.005.

17 “(2) No later than 45 days following the end of a calendar quarter,
18 an insurer shall pay an assessment at the rate of 1.5 percent of the
19 gross amount of premiums earned by the insurer during that calendar
20 quarter that were derived from health benefit plans delivered or issued
21 for delivery in Oregon.

22 “(3) The assessment shall be paid to the Department of Consumer
23 and Business Services and shall be accompanied by a verified form
24 prescribed by the department together with any information required
25 by the department, that reports:

26 “(a) All health benefit plans issued or renewed by the insurer during
27 the calendar quarter for which the assessment is paid; and

28 “(b) The gross amount of premiums by line of insurance, derived
29 by the insurer from all health benefit plans issued or renewed by the
30 insurer during the calendar quarter for which the assessment is paid.

1 “(4) The assessment imposed under this section is in addition to and
2 not in lieu of any tax, surcharge or other assessment imposed on an
3 insurer.

4 “(5) Any rate filed for the department’s approval may include
5 amounts paid by the insurer under this section as a valid element of
6 administrative expense or retention.

7 “(6) Moneys received by the department under this section shall be
8 paid into the State Treasury and credited to the Health System Fund
9 established under section 2 of this 2017 Act.

10 “SECTION 6. (1) If the Public Employees’ Benefit Board or an
11 insurer fails to timely file a verified form or to pay an assessment re-
12 quired under section 3 or 5 of this 2017 Act, the Department of Con-
13 sumer and Business Services shall impose a penalty on the board or
14 insurer of up to \$500 per day of delinquency. The total amount of
15 penalties imposed under this section for a calendar quarter may not
16 exceed five percent of the assessment due for that calendar quarter.

17 “(2) Any penalty imposed under this section is in addition to and
18 not in lieu of the assessment imposed under sections 3 and 5 of this
19 2017 Act.

20 “SECTION 7. (1) If the Department of Consumer and Business Ser-
21 vices determines that the assessment paid by the insurer under section
22 5 of this 2017 Act is incorrect, the department shall charge or credit
23 to the insurer the difference between the correct amount of the as-
24 sessment and the amount paid by the insurer.

25 “(2) An insurer that is aggrieved by an action of the department
26 taken pursuant to subsection (1) of this section shall be entitled to
27 notice and an opportunity for a contested case hearing under ORS
28 chapter 183.

29 “SECTION 8. (1) Section 5 of this 2017 Act applies to premiums
30 earned by an insurer for a period of eight calendar quarters beginning

1 on the date, on or after January 1, 2018, that the policy or certificate
2 for which the premiums are paid is issued or renewed.

3 “(2) Notwithstanding any provision of contract or statute, including
4 ORS 743B.013 and 743.022, insurers may increase their premium rate
5 on policies or certificates that are subject to the assessment under
6 section 5 of this 2017 Act by 1.5 percent. If an insurer increases its
7 rates under this subsection, the insurer may include in its billings for
8 health benefit plans a notice, as prescribed by the Department of
9 Consumer and Business Services, explaining that the increase is due
10 to the assessment under section 5 of this 2017 Act.

11 **“SECTION 9. (1) As used in this section and sections 10 and 11 of
12 this 2017 Act:**

13 **“(a) ‘Managed care organization’ means:**

14 **“(A) A coordinated care organization as defined in ORS 414.025; and**

15 **“(B) A prepaid managed care health services organization as defined
16 in ORS 414.025.**

17 **“(b) ‘Premium equivalent’ means the payments made to the man-
18 aged care organization by the Oregon Health Authority for providing
19 health services under ORS chapter 414.**

20 **“(2) No later than 45 days following the end of a calendar quarter,
21 a managed care organization shall pay an assessment at a rate of 1.5
22 percent of the gross amount of premium equivalents received during
23 that calendar quarter.**

24 **“(3) The assessment shall be paid to the authority in a manner and
25 form prescribed by the authority.**

26 **“(4) Assessments received by the authority under this section shall
27 be paid into the State Treasury and credited to the Health System
28 Fund established under section 2 of this 2017 Act.**

29 **“(5) The assessment imposed under this section is in addition to and
30 not in lieu of any tax, surcharge or other assessment imposed on a**

1 **managed care organization.**

2 **“SECTION 10. (1) If a managed care organization fails to timely pay**
3 **an assessment under section 9 of this 2017 Act, the Oregon Health**
4 **Authority shall impose a penalty on the managed care organization**
5 **of up to \$500 per day of delinquency. The total amount of penalties**
6 **imposed under this section for a calendar quarter may not exceed five**
7 **percent of the assessment due for that calendar quarter.**

8 **“(2) Any penalty imposed under this section is in addition to and**
9 **not in lieu of the assessment imposed under section 9 of this 2017 Act.**

10 **“(3) Penalties received by the authority under this section shall be**
11 **paid into the State Treasury and credited to the Health System Fund**
12 **established under section 2 of this 2017 Act.**

13 **“SECTION 11. (1) A managed care organization that has paid an**
14 **amount that is not required under section 9 of this 2017 Act may file**
15 **a claim for refund with the Oregon Health Authority.**

16 **“(2) Any managed care organization that is aggrieved by an action**
17 **of the authority taken pursuant to subsection (1) of this section shall**
18 **be entitled to notice and an opportunity for a contested case hearing**
19 **under ORS chapter 183.**

20 **“SECTION 12. Sections 9, 10 and 11 of this 2017 Act apply to any**
21 **payments made to a managed care organization by the Oregon Health**
22 **Authority for the period beginning January 1, 2018, and ending De-**
23 **cember 31, 2019.**

24 **“SECTION 13. ORS 731.292 is amended to read:**

25 **“731.292. (1) Except as provided in subsections (2), [and] (3) and (4) of this**
26 **section, all fees, charges and other moneys received by the Department of**
27 **Consumer and Business Services or the Director of the Department of Con-**
28 **sumer and Business Services under the Insurance Code shall be deposited in**
29 **the fund created by ORS 705.145 and are continuously appropriated to the**
30 **department for the payment of the expenses of the department in carrying**

1 out the Insurance Code.

2 “(2) All taxes and penalties paid pursuant to the Insurance Code shall be
3 paid to the director and after deductions of refunds shall be paid by the di-
4 rector to the State Treasurer, at the end of every calendar month or more
5 often in the director’s discretion, for deposit in the General Fund to become
6 available for general governmental expenses.

7 “(3) All premium taxes received by the director pursuant to ORS 731.820
8 shall be paid by the director to the State Treasurer for deposit in the State
9 Fire Marshal Fund.

10 “(4) **Assessments received by the department under sections 3 and**
11 **5 of this 2017 Act and penalties received by the department under sec-**
12 **tion 6 of this 2017 Act shall be paid into the State Treasury and cred-**
13 **ited to the Health System Fund established under section 2 of this 2017**
14 **Act.**

15 “**SECTION 14.** ORS 731.840 is amended to read:

16 “731.840. (1) The retaliatory tax imposed upon a foreign or alien insurer
17 under ORS 731.854 and 731.859, or the corporate excise tax imposed upon a
18 foreign or alien insurer under ORS chapter 317, is in lieu of all other state
19 taxes upon premiums, taxes upon income, franchise or other taxes measured
20 by income that might otherwise be imposed upon the foreign or alien insurer
21 except the fire insurance premiums tax imposed under ORS 731.820, [and] the
22 tax imposed upon wet marine and transportation insurers under ORS 731.824
23 and 731.828 **and the assessment imposed under section 5 of this 2017**
24 **Act.** However, all real and personal property, if any, of the insurer shall be
25 listed, assessed and taxed the same as real and personal property of like
26 character of noninsurers. Nothing in this subsection shall be construed to
27 preclude the imposition of the assessments imposed under ORS 656.612 upon
28 a foreign or alien insurer.

29 “(2) Subsection (1) of this section applies to a reciprocal insurer and its
30 attorney in its capacity as such.

1 “(3) Subsection (1) of this section applies to foreign or alien title insurers
2 and to foreign or alien wet marine and transportation insurers issuing poli-
3 cies and subject to taxes referred to in ORS 731.824 and 731.828.

4 “(4) The State of Oregon hereby preempts the field of regulating or of
5 imposing excise, privilege, franchise, income, license, permit, registration,
6 and similar taxes, licenses and fees upon insurers and their insurance pro-
7 ducers and other representatives as such, and:

8 “(a) No county, city, district, or other political subdivision or agency in
9 this state shall so regulate, or shall levy upon insurers, or upon their in-
10 surance producers and representatives as such, any such tax, license or fee;
11 except that whenever a county, city, district or other political subdivision
12 levies or imposes generally on a nondiscriminatory basis throughout the ju-
13 risdiction of the taxing authority a payroll, excise or income tax, as other-
14 wise provided by law, such tax may be levied or imposed upon domestic
15 insurers; and

16 “(b) No county, city, district, political subdivision or agency in this state
17 shall require of any insurer, insurance producer or representative, duly au-
18 thorized or licensed as such under the Insurance Code, any additional au-
19 thorization, license, or permit of any kind for conducting therein
20 transactions otherwise lawful under the authority or license granted under
21 this code.

22 **“SECTION 15.** ORS 291.055 is amended to read:

23 “291.055. (1) Notwithstanding any other law that grants to a state agency
24 the authority to establish fees, all new state agency fees or fee increases
25 adopted during the period beginning on the date of adjournment sine die of
26 a regular session of the Legislative Assembly and ending on the date of
27 adjournment sine die of the next regular session of the Legislative Assembly:

28 “(a) Are not effective for agencies in the executive department of gov-
29 ernment unless approved in writing by the Director of the Oregon Depart-
30 ment of Administrative Services;

1 “(b) Are not effective for agencies in the judicial department of govern-
2 ment unless approved in writing by the Chief Justice of the Supreme Court;

3 “(c) Are not effective for agencies in the legislative department of gov-
4 ernment unless approved in writing by the President of the Senate and the
5 Speaker of the House of Representatives;

6 “(d) Shall be reported by the state agency to the Oregon Department of
7 Administrative Services within 10 days of their adoption; and

8 “(e) Are rescinded on adjournment sine die of the next regular session of
9 the Legislative Assembly as described in this subsection, unless otherwise
10 authorized by enabling legislation setting forth the approved fees.

11 “(2) This section does not apply to:

12 “(a) Any tuition or fees charged by a public university listed in ORS

18 ORS 656.506.

19 “(c) Fees or payments required for:

20 “(A) Health care services provided by the Oregon Health and Science
21 University, by the Oregon Veterans’ Homes and by other state agencies and
22 institutions pursuant to ORS 179.610 to 179.770.

23 “(B) Assessments imposed by the Oregon Medical Insurance Pool Board
24 under section 2, chapter 698, Oregon Laws 2013.

25 “(C) Copayments and premiums paid to the Oregon medical assistance
26 program.

27 “**(D) Assessments paid to the Department of Consumer and Busi-
28 ness Services under sections 3 and 5 of this 2017 Act.**

29 “(d) Fees created or authorized by statute that have no established rate
30 or amount but are calculated for each separate instance for each fee payer

1 and are based on actual cost of services provided.

2 “(e) State agency charges on employees for benefits and services.

3 “(f) Any intergovernmental charges.

4 “(g) Forest protection district assessment rates established by ORS 477.210
5 to 477.265 and the Oregon Forest Land Protection Fund fees established by
6 ORS 477.760.

7 “(h) State Department of Energy assessments required by ORS 469.421 (8)
8 and 469.681.

9 “(i) Assessments on premiums charged by the Department of Consumer
10 and Business Services pursuant to ORS 731.804 or fees charged by the Divi-
11 sion of Finance and Corporate Securities of the Department of Consumer and
12 Business Services to banks, trusts and credit unions pursuant to ORS 706.530
13 and 723.114.

14 “(j) Public Utility Commission operating assessments required by ORS
15 756.310 or charges paid to the Residential Service Protection Fund required
16 by chapter 290, Oregon Laws 1987.

17 “(k) Fees charged by the Housing and Community Services Department
18 for intellectual property pursuant to ORS 456.562.

19 “(L) New or increased fees that are anticipated in the legislative budget-
20 ing process for an agency, revenues from which are included, explicitly or
21 implicitly, in the legislatively adopted budget or the legislatively approved
22 budget for the agency.

23 “(m) Tolls approved by the Oregon Transportation Commission pursuant
24 to ORS 383.004.

25 “(n) Convenience fees as defined in ORS 182.126 and established by the
26 State Chief Information Officer under ORS 182.132 (3) and recommended by
27 the Electronic Government Portal Advisory Board.

28 “(3)(a) Fees temporarily decreased for competitive or promotional reasons
29 or because of unexpected and temporary revenue surpluses may be increased
30 to not more than their prior level without compliance with subsection (1)

1 of this section if, at the time the fee is decreased, the state agency specifies
2 the following:

3 “(A) The reason for the fee decrease; and

4 “(B) The conditions under which the fee will be increased to not more
5 than its prior level.

6 “(b) Fees that are decreased for reasons other than those described in
7 paragraph (a) of this subsection may not be subsequently increased except
8 as allowed by ORS 291.050 to 291.060 and 294.160.

9 **“SECTION 16.** ORS 291.055, as amended by section 36, chapter 698,
10 Oregon Laws 2013, section 20, chapter 70, Oregon Laws 2015, and section 44b,
11 chapter 807, Oregon Laws 2015, is amended to read:

12 “291.055. (1) Notwithstanding any other law that grants to a state agency
13 the authority to establish fees, all new state agency fees or fee increases
14 adopted during the period beginning on the date of adjournment sine die of
15 a regular session of the Legislative Assembly and ending on the date of
16 adjournment sine die of the next regular session of the Legislative Assembly:

17 “(a) Are not effective for agencies in the executive department of gov-
18 ernment unless approved in writing by the Director of the Oregon Depart-
19 ment of Administrative Services;

20 “(b) Are not effective for agencies in the judicial department of govern-

27 **“OREGON REINSURANCE PROGRAM**

28

29 **“SECTION 17. Sections 18 to 21 of this 2017 Act are added to and**
30 **made a part of the Insurance Code.**

1 **“SECTION 18. The Oregon Reinsurance Program is established in**
2 **the Department of Consumer and Business Services for the purposes**
3 **of stabilizing the rates and premiums for individual health benefit**
4 **plans and providing greater financial certainty to consumers of health**
5 **insurance in this state.**

6 **“SECTION 19. (1) As used in this section:**

7 **“(a) ‘Attachment point’ means the threshold dollar amount,**
8 **adopted by the Department of Consumer and Business Services by**
9 **rule, for claims costs incurred by a reinsurance eligible health benefit**
10 **plan for an insured individual’s covered benefits in a benefit year, af-**
11 **ter which threshold the claims costs for the benefits are eligible for**
12 **reinsurance payments.**

13 **“(b) ‘Coinsurance rate’ means the rate, adopted by the department**
14 **by rule, at which the department will reimburse a reinsurance eligible**
15 **health benefit plan for claims costs incurred for an insured**
16 **individual’s covered benefits in a benefit year after the attachment**
17 **point and before the reinsurance cap.**

18 **“(c) ‘Health benefit plan’ has the meaning given that term in ORS**
19 **743B.005.**

20 **“(d) ‘Reinsurance cap’ means the threshold dollar amount, adopted**
21 **by the department by rule, for claims costs incurred by a reinsurance**
22 **eligible health benefit plan for an insured individual’s covered benefits**
23 **in a benefit year, after which threshold the claims costs for the bene-**
24 **fits are no longer eligible for state reinsurance payments.**

25 **“(e) ‘Reinsurance eligible health benefit plan’ means a health ben-**
26 **efit plan providing individual coverage that:**

27 **“(A) Is delivered or issued for delivery in this state; and**

28 **“(B) Is not a grandfathered health plan as defined in ORS 743B.005.**

29 **“(f) ‘Reinsurance eligible individual’ means an individual who is**
30 **insured in a reinsurance eligible health benefit plan on or after Janu-**

1 ary 1, 2018.

2 “(2) An issuer of a reinsurance eligible health benefit plan becomes
3 eligible for a reinsurance payment when the claims costs for a rein-
4 surance eligible individual’s covered benefits in a calendar year exceed
5 the attachment point. The amount of the payment shall be the product
6 of the coinsurance rate and the issuer’s claims costs for the reinsur-
7 ance eligible individual that exceed the attachment point, up to the
8 reinsurance cap.

9 “(3) After the department adopts by rule the attachment point, re-
10 insurance cap or coinsurance rate, the department may not:

11 “(a) Change the attachment point or the reinsurance cap during
12 that benefit year; or

13 “(b) Increase the coinsurance rate during the benefit year.

14 “(4) The department may adopt rules necessary to carry out the
15 provisions of this section including, but not limited to, rules prescrib-
16 ing:

17 “(a) The amount, manner and frequency of reinsurance payments;
18 and

19 “(b) Reporting requirements for issuers of reinsurance eligible
20 health benefit plans.

21 “SECTION 20. (1) As used in this section:

22 “(a) ‘Health benefit plan’ has the meaning given that term in ORS
23 743B.005.

24 “(b) ‘Oregon Reinsurance Program’ means the program established
25 in section 18 of this 2017 Act.

26 “(c) ‘Reinsurance eligible individual’ has the meaning given that
27 term in section 19 of this 2017 Act.

28 “(2) An insurer that offers a health benefit plan must report to the

11 by the Hospital Quality Assurance Fund shall be credited to the Hospital
12 Quality Assurance Fund.

13 **“(2)** Amounts in the Hospital Quality Assurance Fund are continuously
14 appropriated to the Oregon Health Authority for the purpose of:

15 **“(a)** Paying refunds due under section 6, chapter 736, Oregon Laws 2003;

16 **“(b)** Funding services under ORS 414.631, 414.651 and 414.688 to 414.745,
17 including but not limited to increasing reimbursement rates for inpatient and
18 outpatient hospital services under ORS 414.631, 414.651 and 414.688 to
19 414.745; **and**

20 **“(c)** Making payments described in section 2 (4)(a)(B)(iii), chapter 736,
21 Oregon Laws 2003;

22 **“[(d) Making distributions, as described in section 1 (4), chapter 608,**
23 **Oregon Laws 2013, of an amount of moneys equal to the federal financial**
24 **participation received from one percentage point of the rate assessed under**
25 **section 2 (1), chapter 736, Oregon Laws 2003; and]**

26 **“[(e)] (d)** Paying administrative costs incurred by the authority to ad-
27 minister *[section 1, chapter 608, Oregon Laws 2013, and]* the assessments im-
28 posed under section 2, chapter 736, Oregon Laws 2003.

29 **“(3)** Except for assessments imposed pursuant to section 2 (4)(b), chapter
30 736, Oregon Laws 2003, the authority may not use moneys from the Hospital

1 Quality Assurance Fund to supplant, directly or indirectly, other moneys
2 made available to fund services described in subsection (2) of this section.
