CARRIED OVER FROM THE 02-12-2018 AGENDA: Permits operation of autonomous vehicles on highways in this state under certain circumstances.

CARRIED OVER FROM THE 02-12-2018 AGENDA: Authorizes Department of Transportation to enter into intergovernmental agreement with city having population of 500,000 or more for purpose of removing certain personal property from locations within city's urban growth boundary.

HB 4099 \*\*

CARRIED OVER FROM THE 02-12-2018 AGENDA: Prohibits person from operating motorboat with wakeenhancing device between river mile 30 and river mile 50 on Willamette River.

HB 4130 \*\*

CARRIED OVER FROM THE 02-12-2018 AGENDA: Establishes grant program under which Department of Education awards grants to school districts for percentage of certain student transportation costs for which school district does not receive any amount in distributions from State School Fund.

HB 4138

CARRIED OVER FROM THE 02-12-2018 AGENDA: Authorizes State Marine Board to make special regulations relating to operation of motorboats to minimize and prevent erosion at request of Department of State Lands.
