Re: HJR 201 – Constitutional Amendment to Allow Local Governments to bond for

Affordable Housing – Support

The League of Women Voters of Oregon believes that persons who are unable to work, whose earnings are inadequate, or for whom jobs are not available, have the right to an income and/or services to meet their basic needs for food, shelter and access to health care. State and local governments should assist by establishing effective agencies to aid, promote, coordinate and supplement the housing programs of the federal government and the private sector.

LWVOR supports House Joint Resolution (HJR) 201 and urges its passage. HJR 201 would refer a constitutional amendment (Section 9, Article XI) to the voters that, if passed, would allow municipal corporations to use bonded indebtedness to finance the capital costs of affordable housing with some limitations. If voters adopt the amendment at the next general election, local jurisdictions would be granted the authority to seek voter approval for bonds to be used for the purpose of developing affordable housing in their communities. The bond measure would establish the level of affordability based on local needs.

The amendment further would allow local jurisdictions to access federal, private, and other funding sources when utilizing bond proceeds to develop low-income housing. This currently is not an option. In addition, the municipality would no longer be required to own and operate the housing. The City of Portland recently passed an affordable housing bond and, although local leaders anticipate a positive impact on the affordable housing supply, they regret the inability to access federal, foundation, nonprofit and other resources that would make the bond money go further. The ownership requirement also has complicated the process because the city has limited experience owning or operating housing projects. Smaller jurisdictions have even less capacity in this area.

LWVOR urges you to pass HJR 201. It would offer local jurisdictions the flexibility they need to address Oregon's housing crisis. The voters in those jurisdictions will have the final voice. Families and individuals throughout the state are making difficult choices on a daily basis because housing costs have increased so dramatically. Please give communities this additional tool that would help them meet the challenge.
