Dear Chairman Clem, Vice Chairs Mclain, and Sprenger, and members of the Committee on Agriculture and Natural Resources,

I writing to ask you for your support of House Bill 4029. The proposed bridge would have devastating effects on the now protected area of the State Scenic Waterway and Federal Wild and Scenic River.

The wildlife is abundant and flourishes due to the <u>existing administrative rule - OAR 736-040-0073 - which was put in place more than 20 years ago</u>, and the legislature should uphold the intent by adopting HB 4029 and ensuring this stretch of river can be protected for many more years. The wildlife that lives in this protected corridor are the following but not limited to, Bald Eagles, Golden Eagles, Deer, Elk, Coyotes, Red-tail Hawks, Bobcats, River otters, Beaver, Trout, and the Spotted frog.

I am resident of Bend and a wildlife photographer. I live near the <u>Helen M. Thompson Wildlife</u> <u>Sanctuary</u> and have the privilege to photographing these animals first hand and it is my opinion that the wildlife would be displaced by the constant foot traffic of people and their pets that would be encroaching or destroying their breeding, and nesting territory. There are no shortages of trails and foot bridges in Bend, and as a outdoor enthusiast myself I appreciate the great the abundance of trails that the area offers, but there has to be a balance, and I feel the addition of the proposed foot bridge in this sensitive area is going too far and would be not upholding the protections put in place years ago to protect the wildlife of this precious small stretch of the Deschutes river.
