

SAIP project Timeline and SAIP Phase II Funding Plan

2013 -2015 Trillium was awarded a \$2 million-dollar grant from the Oregon Health Authority (OHA). The funds were then used as leverage for foundation and individuals to invest in a public private partnership that would result in the building of a replacement facility for the Secure Adolescent Inpatient Program located at Children's Farm Home in Corvallis, Oregon.

To complete the fundraising individuals participated in giving and Trillium secured a construction loan that allowed for the completion of the 6.5 million- dollar project. In September **2015** The SAIP program officially began serving youth in the new facility.

2015-2017 At the conclusion of the 2015 Legislative Session, Trillium Family Services was authorized a \$3 million capital grant in the 2015-2017 Lottery Bond bill. The funds were not released in the recent disbursement, were instead placed on the "carry forward project list" and then removed from funding consideration.

The grant is a vital component of the funding needed to construct the second of three planned state-of-the-art buildings that house the State's Secure Adolescent Inpatient Program (SAIP). Existing facilities are inadequate and no longer provide the level of safety and security required to serve teenagers at the highest level of psychiatric need in Oregon.

The total cost of this second phase is approximately \$8 million. Trillium is currently conducting a capital fundraising campaign and is confident it will raise \$5 million in private funds by late 2018 or early 2019. As such, it is absolutely critical that the Lottery Bond grant be issued in 2017-2019 to ensure the completion of the second building.

The fund -raising model Trillium envisions for this second phase is to replicate our process for the successful phase one plan which focused on leveraging the State's \$2 million-dollars (\$3 million in phase II) as a lead investment and a public - private collaboration opportunity for foundations and individuals.

We anticipate nearly the same level of foundation participation in phase II as we experienced in phase 1. We have been in conversation with the 4 of the larger foundations listed above and all are still supportive of this critical project. Grant applications and letters of inquiry, are on hold as funders want to know that the state is still funding this project in the amount of \$3 million-dollars.

We would appreciate your support of the re-authorization for this critical funding.
