Subject: SB 5701 – Capital Construction

Work Session Recommendations

SB 5701 is the budget bill for capital construction projects. The bill establishes authority for the acquisition of land and the planning, design, repair, and construction of projects with costs over \$1 million. Projects are funded with proceeds of bonds authorized in SB 5702, as well as other revenues and federal grants received by agencies.

The -1 amendment replaces the bill and establishes additional Other Funds capital construction expenditure limitation of \$90.2 million and Federal Funds capital construction expenditure limitation of \$12.5 million for the 2017-19 biennium. Capital construction expenditure limitation for the 2015-17 biennium is also increased by \$436,658 Other Funds and \$521,380 Federal Funds.

A list of the six-year capital construction expenditure limitation approved for projects in SB 5701 is attached.
