- Not engaged in teaching or participate in the administration or operation of any school
- Can serve no more than two full consecutive terms.
- May be removed by the Governor for cause after notice and public hearing

DUTIES AND AUTHORITY: ORS 326.041, 326.051, 326.075

- Elect chairperson
- Adopt rules setting standards for public kindergartens, elementary, and secondary schools
- Establish rules for general governance of public kindergartens, elementary and secondary schools and public community colleges
- Prescribe required or minimum courses of study
- Adopt rules regarding school and interscholastic activities
- Accept money or property, apply for federal funds for educational purposes, and enter into contracts or agreements for receipt of funds
- Cooperate with, and provide data as appropriate to, the Oregon Office of Educational Policy and Planning in the development of a comprehensive state education plan
