- Members serve four-year terms at the pleasure of the Governor

DUTIES AND AUTHORITY: ORS 390.117, 390.121, 390.124, 390.127

- Promote policy of state toward outdoor recreation resources
 - Establish policies for operation of the State Parks and Recreation Department
 - Acquire real property deemed necessary for the development of state parks, roads, trails, and campgrounds
 - Construct, maintain and operate facilities
 - Appoint State Parks and Recreation Director
 - Delegate powers and duties other than rule-making to State Parks and Recreation Director
 - Adopt rules necessary to carry out its powers
 - Adopt rules to assess reasonable charges for the use of areas established and maintained by the department.
- The commission shall report biennially to the Legislative Assembly on any fee reductions, waivers or exemptions adopted by rule
