# House Bill 4055

Sponsored by Representatives OLSON, BARKER; Representatives POST, SMITH DB (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies laws related to vehicular hit and run.

A BILL FOR AN ACT 1 Relating to vehicles; creating new provisions; and amending ORS 801.026, 807.072, 807.252, 810.415,  $\mathbf{2}$ 3 811.230, 811.235, 811.483, 811.700, 811.705, 811.707 and 811.710. Be It Enacted by the People of the State of Oregon: 4 SECTION 1. ORS 811.700 is amended to read:  $\mathbf{5}$ 811.700. (1) A [person] driver of a vehicle that is involved in a collision that results in 6 7 **damage to property** commits the offense of failure to perform the duties of a driver when property 8 is damaged if the *[person is the driver of any vehicle and the person]* driver does not perform duties required under any of the following: 9 10 (a) Except as provided in paragraph (b) or (c) of this subsection, if the [person is the driver 11 of any vehicle] driver knows or has reason to believe that the driver's vehicle has been involved 12 in [an accident that results only in damage to a vehicle that is driven or attended by any other person] a collision, the [person must] driver shall perform all of the following duties: 13 (A) Immediately stop the **driver's** vehicle at the scene of the [accident] collision or as close 14 15[thereto] to the scene of the collision as possible and reasonably investigate what the driver's vehicle struck. Every stop required under this subparagraph [shall] must be made without ob-16 structing traffic more than is necessary. 1718 (B) Remain at the scene of the [accident] collision until the driver has fulfilled all of the re-19 quirements under this paragraph. (C) Give to the other driver or passenger: 20 (i) The driver's name and address, the owner's name and address [of the driver and the reg-2122 istration number of the vehicle that the driver is driving,] and the name and address of any other 23occupants of the driver's vehicle; and 24 (ii) If the driver's vehicle is a motor vehicle, the registration number of the motor vehicle, the name of the insurance carrier [and] covering the motor vehicle, the insurance policy number 2526 of the insurance policy insuring the motor vehicle and the phone number of the insurance car-27rier. (D) Upon request and if available, exhibit and give to the occupant of or person attending any 2829 vehicle damaged and to any police officer investigating the collision the number of any [docu-30 *ments*] **document** issued as evidence of driving privileges granted to the driver. 31(b) If the [person is the driver of any vehicle that collides with] driver's vehicle has been in-32 volved in a collision resulting in damage to any vehicle that is unattended, the [person] driver

shall immediately stop and: 1

2 (A) Locate [and notify] the operator or owner of the unattended vehicle and notify the operator or owner of: 3

(i) The name and address of the driver and owner of the vehicle striking the unattended vehicle 4 [and,]; and  $\mathbf{5}$ 

(ii) If the driver's vehicle is a motor vehicle, the registration number of the motor vehicle, 6 the name of the insurance carrier [and] covering the motor vehicle, the insurance policy number 7 of the insurance policy insuring the motor vehicle and the phone number of the insurance car-8 9 rier: or

10 (B) Leave in a conspicuous place in the **unattended** vehicle [struck] a written notice giving:

(i) The name and address of the driver and [of the] owner of the vehicle [doing the] striking the 11 12 unattended vehicle and a statement of the circumstances [thereof] of the collision; and

13 (ii) If the driver's vehicle is a motor vehicle, the registration number of the motor vehicle, the name of the insurance carrier [and] covering the motor vehicle, the insurance policy number 14 15 of the insurance policy insuring the motor vehicle and the phone number of the insurance car-16 rier.

(c) If the *[person is the driver of any]* driver's vehicle has been *[vehicle]* involved in *[an* 1718 accident] a collision resulting only in damage to fixtures or property legally upon or adjacent to a highway, the [person] driver shall [do] perform all of the following: 19

(A) Immediately stop the driver's vehicle at the scene of the collision or as close to the 20scene of the collision as possible and reasonably investigate what the driver's vehicle struck. 2122Every stop required under this subparagraph must be made without obstructing traffic more 23than is necessary.

[(A)] (B) Take reasonable steps to notify the owner or person in charge of the property of [such 24 fact] the collision and of the driver's name and address, the owner's name and address and, if the 25driver's vehicle is a motor vehicle, the registration number of the vehicle, the name of the in-2627surance carrier [and] covering the motor vehicle, the insurance policy number of the insurance policy insuring the motor vehicle and the phone number of the insurance carrier [and of the 28registration number of the vehicle the driver is driving]. 29

30 [(B)] (C) Upon request and if available, exhibit any document issued as [official] evidence of [a 31 grant of] driving privileges granted to the driver.

(d) If the driver discovers only after leaving the scene of the collision that the driver's 32vehicle may have been involved in a collision that resulted in damage to another vehicle, 33 34 fixture or property, immediately comply as nearly as possible with the requirements of par-35agraph (a) of this subsection.

(2) The offense described in this section, failure to perform the duties of a driver when property 37 is damaged, is a Class A misdemeanor and is applicable on any premises open to the public.

SECTION 2. ORS 811.705 is amended to read:

811.705. (1) A [person commits the offense of failure to perform the duties of a driver to injured 39 persons if the person is the driver of any] driver of a vehicle involved in [an accident] a collision 40 that results in injury or death to any person [and does not do all] commits the offense of failure 41 to perform the duties of a driver to injured persons if the driver does not perform all duties 42 required under any of the following: 43

(a) If the driver knows or has reason to believe that the driver's vehicle has been involved 44 in a collision, immediately stop the driver's vehicle at the scene of the [accident] collision or as 45

1 close [thereto] to the scene of the collision as possible and reasonably investigate what the

2 **driver's vehicle struck**. Every stop required under this paragraph [*shall*] **must** be made without 3 obstructing traffic more than is necessary.

4 (b) If the driver knows or has reason to believe that the collision resulted in the injury 5 or death of another person, remain at the scene of the [accident] collision until the driver has 6 fulfilled all of the requirements under this subsection.

7 (c) Give to the other driver or **a** surviving passenger or any person not a passenger who is in-8 jured as a result of the [accident] collision:

9 (A) The driver's name and address, the owner's name and address, [of the driver and the 10 registration number of the vehicle that the driver is driving,] and the name and address of any other 11 occupants of the driver's vehicle; and

(B) If the driver's vehicle is a motor vehicle, the registration number of the motor vehicle, the name of the insurance carrier [and] covering the motor vehicle, the insurance policy number of the insurance policy insuring the motor vehicle and the phone number of the insurance carrier.

(d) Upon request and if available, exhibit and give to the persons injured, to any police officer
investigating the collision and [or] to the occupant of or person attending any vehicle damaged
the number of any document issued as official evidence of [a grant of] driving privileges granted
to the driver.

(e) Render to any person injured in the [accident] collision reasonable assistance, including the conveying, or the making of arrangements for the conveying, of [such] an injured person to a physician, surgeon or hospital for medical or surgical treatment, if it is apparent that such treatment is necessary or if such conveying is requested by any injured person.

(f) Remain at the scene of [an accident] a collision until a police officer has arrived and has 94 received the required information, if all persons required to be given information under paragraph 25(c) of this subsection are killed in the [accident] collision or are unconscious or otherwise incapable 2627of receiving the information. The requirement of this paragraph to remain at the scene of [an accident] a collision until a police officer arrives does not apply to a driver who needs immediate 28medical care, who needs to leave the scene in order to secure medical care for another person in-2930 jured in the [accident] collision or who needs to leave the scene in order to report the [accident] 31 collision to the authorities, [so] as long as the driver who leaves takes reasonable steps to return to the scene or to contact the nearest police [agency] officer. 32

(g) If the driver discovers only after leaving the scene of the collision that the driver's vehicle may have been involved in a collision that resulted in injury or death to any person, immediately comply as nearly as possible with the requirements of this subsection. The driver shall immediately contact 9-1-1 and provide to the dispatcher any identifying information requested by the dispatcher and the location and approximate time of the collision.

(2)(a) Except as otherwise provided in paragraph (b) of this subsection, the offense described in
this section, failure to perform the duties of a driver to injured persons, is a Class C felony and is
applicable on any premises open to the public.

(b) Failure to perform the duties of a driver to injured persons is a Class B felony if a person
suffers serious physical injury as defined in ORS 161.015 or dies as a result of the [accident]
collision.

45 811.707. The Oregon Criminal Justice Commission shall classify the crime of failure to perform

the duties of a driver to injured persons as crime category 8 of the sentencing guidelines grid of the 1 2 commission if a person suffers serious physical injury as defined in ORS 161.015 or dies as a result of the [accident] collision that forms the basis of the conviction. 3 SECTION 4. (5) Devices moved exclusively on stationary rail tracks are exempt from the vehicle code.

5 (6) Devices that are powered exclusively by human power are not subject to those provisions 6 of the vehicle code that relate to vehicles. Notwithstanding this subsection, bicycles are generally 7 subject to the vehicle code as provided under ORS 814.400.

8 (7) The exemptions in subsection (3) of this section do not apply to the persons and vehicles 9 when traveling to or from the facilities or construction project.

(1) The Department of Transportation, by rule, may waive any examination, test or 12 demonstration required under ORS 807.065 (1)(b) or 807.070 (2) or (3) if the department receives 13 satisfactory proof that the person required to take the examination, test or demonstration has 14 passed an examination, test or demonstration approved by the department that:

(a) Is given in conjunction with a traffic safety education course certified by the department
 under ORS 336.802;

(b) Is given in conjunction with a motorcycle rider education course established under ORS802.320;

(c) Is given in conjunction with a course conducted by a commercial driver training school
 certified by the department under ORS 822.515; or

(d) Is given in conjunction with an application for a special limited vision condition learner's
 permit under ORS 807.359.

(2) The department, by rule, may waive the actual demonstration required under ORS 807.070

30 (d) Driving while under the influence of intoxicants, as defined in ORS 813.010.

31 (e) Failure to perform the duties of a driver involved in [an accident or] **a** collision, as described

32 in ORS 811.700 or 811.705.

33 (f) Criminal driving while suspended or revoked, as defined in ORS 811.182.

34 (g) Fleeing or attempting to elude a police officer, as defined in ORS 811.540.

35 <u>SECTION 12.</u> The amendments to ORS 811.700, 811.705, 811.707 and 811.710 by sections 1
 36 to 4 of this 2018 Act apply to conduct occurring on or after the effective date of this 2018
 37 Act.
