1 On <u>page 1</u> of the printed A-engrossed bill, line 2, after the second semicolon delete the rest of 2 the line and insert "amending ORS 825.610; and repealing ORS 825.615.".

3 Delete lines 4 through 27.

4 Delete page 2.

5 On page 3, delete lines 1 through 13 and insert:

"SECTION 1. ORS 825.610 is amended to read:

7 "825.610. (1) ORS 825.605 does not apply to a commercial vehicle if it is necessary to idle the 8 primary engine of the commercial vehicle:

9 "[(1)] (a) Due to traffic, a traffic control device or mechanical difficulties over which the operator has no control or at the direction of a law enforcement official or road authority.

"[(2)] (b) Due to the need to operate defrosters, heaters or air conditioners or installing equipment necessary to comply with manufacturers' operating requirements, specifications and warranties or with federal, state or local safety regulations.

"[(3)] (c) Because the commercial vehicle is a police, fire, ambulance, public safety, military, utility service or road authority vehicle, or any other vehicle being used to respond to an emergency or for other public safety purposes, or being actively used for training for emergencies or public safety.

"[(4)] (d) For maintenance, service, repair or diagnostic purposes or for particulate matter trap
regeneration.

"[(5)] (e) For a state or federal inspection to verify that all equipment is in good working order.

21 "[(6)] (f) To power work-related mechanical, safety, electrical or construction equipment in-22 stalled on the vehicle that is not used for propulsion.

23 "[(7)] (g) Because the commercial vehicle is an armored vehicle and a person must remain inside 24 the vehicle to guard the contents or while the vehicle is being loaded or unloaded.

25"[(8)] (h) To maintain the comfort of commercial bus passengers while passengers are on board. "[(9)] (i) In a commercial vehicle with a gross vehicle weight rating of more than 26,000 pounds, 26 27for purposes of air conditioning or heating during a rest or sleep period and the outside temperature 28is less than 50 degrees or greater than 75 degrees Fahrenheit at any time during the rest or sleep 29period. This subsection applies to a commercial vehicle with a sleeper berth compartment that is parked in any place that a commercial vehicle is legally permitted to park, including, but not limited 30 31 to, a fleet trucking terminal, commercial vehicle stop or designated rest area. This exemption does 32not apply if the commercial vehicle is equipped with an auxiliary power unit or other suitable idle 33 reduction technology, if the commercial vehicle is parked at a location equipped with suitable sta-34 tionary idle reduction technology that is available for use, or during a rest or sleep period when the 35commercial vehicle is parked on or adjacent to a public or private educational institution offering

education in all or part of kindergarten through grade 12, unless the outside temperature is greater 1 2 than 75 degrees Fahrenheit and the auxiliary power unit provides heating only, in which case the person may idle the primary engine to provide air conditioning. 3

4 "[(10)] (j) In a commercial vehicle with a gross vehicle weight rating of more than 26,000 pounds, for purposes of air conditioning or heating while waiting to load or unload the commercial vehicle 5 or while actually loading or unloading the commercial vehicle, and the outside temperature is less 6 7 than 50 degrees or greater than 75 degrees Fahrenheit at the time. This exemption does not apply 8 if the commercial vehicle is equipped with an auxiliary power unit or other suitable idle reduction technology, or if the commercial vehicle is parked at a location equipped with suitable stationary 9 10 idle reduction technology that is available for use, unless the outside temperature is greater than 11 75 degrees Fahrenheit and the auxiliary power unit provides heating only, in which case the person 12may idle the primary engine to provide air conditioning.

13"[(11)] (k) For a maximum of 30 minutes while waiting to load or unload the commercial vehicle [or while actually loading or unloading the commercial vehicle] during a single loading or unloading 14 event. This paragraph applies only to a commercial vehicle that has a gross vehicle weight 15rating of more than 26,000 pounds. 16

"(2)(a) ORS 825.605 does not apply to a commercial vehicle when the engine manufacturer 1718 has certified that a new 2008 or subsequent model year commercial vehicle diesel engine 19 which is primarily responsible for propelling the commercial vehicle meets an optional nitrogen oxides idling emission standard of 30 grams per hour while not affecting the associ-2021ated emissions of carbon monoxide, particulate matter and nonmethane hydrocarbons.

22"(b) A manufacturer that certifies that its engine meets the standard specified in para-23graph (a) of this subsection shall provide a sticker to be affixed to the commercial vehicle to demonstrate compliance with the idling emission standard. 24

"SECTION 2. ORS 825.610, as amended by section 1 of this 2018 Act, is amended to read:

26 "825.610. (1) ORS 825.605 does not apply to a commercial vehicle if it is necessary to idle the 27primary engine of the commercial vehicle:

"(a) Due to traffic, a traffic control device or mechanical difficulties over which the operator 2829 has no control or at the direction of a law enforcement official or road authority.

30 "(b) Due to the need to operate defrosters, heaters or air conditioners or installing equipment necessary to comply with manufacturers' operating requirements, specifications and warranties or 3132with federal, state or local safety regulations.

33 "(c) Because the commercial vehicle is a police, fire, ambulance, public safety, military, utility 34service or road authority vehicle, or any other vehicle being used to respond to an emergency or 35 for other public safety purposes, or being actively used for training for emergencies or public safety.

36 "(d) For maintenance, service, repair or diagnostic purposes or for particulate matter trap re-37 generation.

"(e) For a state or federal inspection to verify that all equipment is in good working order.

"(f) To power work-related mechanical, safety, electrical or construction equipment installed on 39 40 the vehicle that is not used for propulsion.

41 "(g) Because the commercial vehicle is an armored vehicle and a person must remain inside the 42vehicle to guard the contents or while the vehicle is being loaded or unloaded.

"(h) To maintain the comfort of commercial bus passengers while passengers are on board.

44 "(i) In a commercial vehicle with a gross vehicle weight rating of more than 26,000 pounds, for

45 purposes of air conditioning or heating during a rest or sleep period and the outside temperature is less

1 than 50 degrees or greater than 75 degrees Fahrenheit at any time during the rest or sleep period. 2 This subsection applies to a commercial vehicle with a sleeper berth compartment that is parked in any place that a commercial vehicle is legally permitted to park, including, but not limited to, a fleet 3 4 trucking terminal, commercial vehicle stop or designated rest area. This exemption does not apply if the commercial vehicle is equipped with an auxiliary power unit or other suitable idle reduction technology, 5 if the commercial vehicle is parked at a location equipped with suitable stationary idle reduction tech-6 7 nology that is available for use, or during a rest or sleep period when the commercial vehicle is parked 8 on or adjacent to a public or private educational institution offering education in all or part of 9 kindergarten through grade 12, unless the outside temperature is greater than 75 degrees Fahrenheit 10 and the auxiliary power unit provides heating only, in which case the person may idle the primary 11 engine to provide air conditioning.]

"(j)] (i) In a commercial vehicle with a gross vehicle weight rating of more than 26,000 pounds, 1213for purposes of air conditioning or heating while waiting to load or unload the commercial vehicle or while actually loading or unloading the commercial vehicle, and the outside temperature is less 14 15than 50 degrees or greater than 75 degrees Fahrenheit at the time. This exemption does not apply 16 if the commercial vehicle is equipped with an auxiliary power unit or other suitable idle reduction 17technology, or if the commercial vehicle is parked at a location equipped with suitable stationary 18 idle reduction technology that is available for use, unless the outside temperature is greater than 19 75 degrees Fahrenheit and the auxiliary power unit provides heating only, in which case the person 20may idle the primary engine to provide air conditioning.

21"[(k)] (j) For a maximum of 30 minutes while waiting to load or unload the commercial vehicle 22during a single loading or unloading event. This paragraph applies only to a commercial vehicle that 23has a gross vehicle weight rating of more than 26,000 pounds.

24 "(2)(a) ORS 825.605 does not apply to a commercial vehicle when the engine manufacturer has 25certified that a new 2008 or subsequent model year commercial vehicle diesel engine which is pri-26marily responsible for propelling the commercial vehicle meets an optional nitrogen oxides idling 27emission standard of 30 grams per hour while not affecting the associated emissions of carbon 28monoxide, particulate matter and nonmethane hydrocarbons.

29 "(b) A manufacturer that certifies that its engine meets the standard specified in paragraph (a) of this subsection shall provide a sticker to be affixed to the commercial vehicle to demonstrate 30 compliance with the idling emission standard. 31

"SECTION 3. The amendments to ORS 825.610 by section 2 of this 2018 Act become op-3233 erative on January 1, 2020.

"(2) The amendments to ORS 825.610 by section 2 of this 2018 Act apply to conduct occurring 37 38 on and after January 1, 2020.".
