#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires Department of Human Services to establish minimum training standards for home care workers and personal support workers and to provide training. Directs department and Home Care Commission to maximize federal funding available to pay for training. Becomes operative January 1, 2020.

The workers and navigators shall work as part of a multidisciplinary team under the direction of a licensed or certified health care professional. The commission shall recruit qualified home care workers and personal support workers who desire to be trained and certified as community health workers or personal health navigators.

(5) The commission shall ensure that each coordinated care organization honors all of the terms and conditions of employment established by the commission with respect to the community health workers and personal health navigators referred by the commission. This subsection does not require a coordinated care organization to employ or contract with community health workers and personal health navigators certified by the commission so long as the community health workers and personal health navigators employed or otherwise retained by the organization meet competency standards established by the authority under ORS 414.665.

When the claim is closed because 14 15 the accepted injury is no longer the major contributing cause of the worker's combined or consequential condition or conditions, and there is sufficient information to determine permanent disabil-16 ity, the likely permanent disability that would have been due to the current accepted condition shall 17 18 be estimated;

19 (c) Without the approval of the attending physician or nurse practitioner authorized to provide compensable medical services under ORS 656.245, the worker fails to seek medical treatment for a 20period of 30 days or the worker fails to attend a closing examination, unless the worker 2122affirmatively establishes that such failure is attributable to reasons beyond the worker's control; or 23(d) An insurer or self-insured employer finds that a worker who has been receiving permanent total disability benefits has materially improved and is capable of regularly performing work at a 94 gainful and suitable occupation. 25

(2) If the worker is enrolled and actively engaged in training according to rules adopted pursu-26ant to ORS 656.340 and 656.726, the temporary disability compensation shall be proportionately re-27duced by any sums earned during the training. 28

(3) A copy of all medical reports and reports of vocational rehabilitation agencies or counselors 2930 shall be furnished to the worker, if requested by the worker.

31 (4) Temporary total disability benefits shall continue until whichever of the following events 32first occurs:

(a) The worker returns to regular or modified employment; 33

34 (b) The attending physician or nurse practitioner who has authorized temporary disability ben-35efits for the worker under ORS 656.245 advises the worker and documents in writing that the worker 36 is released to return to regular employment;

37 (c) The attending physician or nurse practitioner who has authorized temporary disability ben-38 efits for the worker under ORS 656.245 advises the worker and documents in writing that the worker is released to return to modified employment, such employment is offered in writing to the worker 39 and the worker fails to begin such employment. However, an offer of modified employment may be 40 refused by the worker without the termination of temporary total disability benefits if the offer: 41

(B) Is at a work site more than 50 miles one way from where the worker was injured unless the

4 (C) Is not with the employer at injury;

5 (D) Is not at a work site of the employer at injury;

6 (E) Is not consistent with the existing written shift change policy or is not consistent with 7 common practice of the employer at injury or aggravation; or

8 (F) Is not consistent with an existing shift change provision of an applicable collective bar-9 gaining agreement;

(d) Any other event that causes temporary disability benefits to be lawfully suspended, withheld
 or terminated under ORS 656.262 (4) or other provisions of this chapter; or

12(e) Notwithstanding paragraph (c)(C), (D), (E) and (F) of this subsection, the attending physician or nurse practitioner who has authorized temporary disability benefits under ORS 656.245 for a home 13 care worker or a personal support worker who has been made a subject worker pursuant to ORS 14 15 656.039 advises the home care worker or personal support worker and documents in writing that the home care worker or personal support worker is released to return to modified employment, 16 appropriate modified employment is offered in writing by the Home Care Commission or a designee 17 18 of the commission to the home care worker or personal support worker for any client of the De-19 partment of Human Services who employs a home care worker or personal support worker and 20the [home care] worker fails to begin the employment.

(5)(a) Findings by the insurer or self-insured employer regarding the extent of the worker's dis ability in closure of the claim shall be pursuant to the standards prescribed by the director.

(b) The insurer or self-insured employer shall issue a notice of closure of the claim to the worker, to the worker's attorney if the worker is represented, and to the director. If the worker is deceased at the time the notice of closure is issued, the insurer or self-insured employer shall mail the worker's copy of the notice of closure, addressed to the estate of the worker, to the worker's last known address and may mail copies of the notice of closure to any known or potential beneficiaries to the estate of the deceased worker.

29 (c) The notice of closure must inform:

30 (A) The parties, in boldfaced type, of the proper manner in which to proceed if they are dissat-31 isfied with the terms of the notice of closure;

32 (B) The worker of:

(i) The amount of any further compensation, including permanent disability compensation to be

(iii) The right of the worker or beneficiaries of the worker who were mailed a copy of the notice

2 (C) Any beneficiaries of death benefits to which they may be entitled pursuant to ORS 656.204 3 and 656.208.

4 (d) If the insurer or self-insured employer has not issued a notice of closure, the worker may 5 request closure. Within 10 days of receipt of a written request from the worker, the insurer or 6 self-insured employer shall issue a notice of closure if the requirements of this section have been 7 met or a notice of refusal to close if the requirements of this section have not been met. A notice 8 of refusal to close shall advise the worker of:

9 (A) The decision not to close;

(B) The right of the worker to request a hearing pursuant to ORS 656.283 within 60 days of the
 date of the notice of refusal to close;

12 (C) The right to be represented by an attorney; and

13 (D) Any other information as the director may require.

(e) If a worker, a worker's beneficiary, an insurer or a self-insured employer objects to the no-14 15 tice of closure, the objecting party first must request reconsideration by the director under this section. If the worker is deceased at the time the notice of closure is issued, a request for 17 18 reconsideration by a beneficiary of the worker who was mailed a copy of the notice of closure under paragraph (b) of this subsection must be made within 60 days of the date of the notice of closure. 19 20 A request for reconsideration by a beneficiary to the estate of a deceased worker who was not mailed a copy of the notice of closure under paragraph (b) of this subsection must be made within 2122one year of the date the notice of closure was mailed to the estate of the worker under paragraph 23(b) of this subsection. A request for reconsideration by an insurer or self-insured employer may be based only on disagreement with the findings used to rate impairment and must be made within 94 25seven days of the date of the notice of closure.

(f) If an insurer or self-insured employer has closed a claim or refused to close a claim pursuant to this section, if the correctness of that notice of closure or refusal to close is at issue in a hearing on the claim and if a finding is made at the hearing that the notice of closure or refusal to close was not reasonable, a penalty shall be assessed against the insurer or self-insured employer and paid to the worker in an amount equal to 25 percent of all compensation determined to be then due the claimant.

(g) If, upon reconsideration of a claim closed by an insurer or self-insured employer, the director 32orders an increase by 25 percent or more of the amount of compensation to be paid to the worker 33 34 for permanent disability and the worker is found upon reconsideration to be at least 20 percent 35permanently disabled, a penalty shall be assessed against the insurer or self-insured employer and paid to the worker in an amount equal to 25 percent of all compensation determined to be then due 36 37 the claimant. If the increase in compensation results from information that the insurer or self-38 insured employer demonstrates the insurer or self-insured employer could not reasonably have known at the time of claim closure, from new information obtained through a medical arbiter ex-39 amination or from a determination order issued by the director that addresses the extent of the 40 worker's permanent disability that is not based on the standards adopted pursuant to ORS 656.726 41 (4)(f), the penalty shall not be assessed. 42

43 (6)(a) Notwithstanding any other provision of law, only one reconsideration proceeding may be
44 held on each notice of closure. At the reconsideration proceeding:

45 (A) A deposition arranged by the worker, limited to the testimony and cross-examination of the

worker about the worker's condition at the time of claim closure, shall become part of the recon-1 2 sideration record. The deposition must be conducted subject to the opportunity for cross-examination by the insurer or self-insured employer and in accordance with rules adopted by the director. 35(e) The period for completing the reconsideration proceeding described in paragraph (d) of this subsection begins upon receipt by the director of a worker's or a beneficiary's request for recon-36 37 sideration pursuant to subsection (5)(e) of this section. If the insurer or self-insured employer re-38 quests reconsideration, the period for reconsideration begins upon the earlier of the date of the request for reconsideration by the worker or beneficiary, the date of receipt of a waiver from the 39 worker or beneficiary of the right to request reconsideration or the date of expiration of the right 40 of the worker or beneficiary to request reconsideration. If a party elects not to file a separate re-41 quest for reconsideration, the party does not waive the right to fully participate in the reconsider-42 ation proceeding, including the right to proceed with the reconsideration if the initiating party 43 withdraws the request for reconsideration. 44

(f) Any medical arbiter report may be received as evidence at a hearing even if the report is

1 not prepared in time for use in the reconsideration proceeding.

(g) If any party objects to the reconsideration order, the party may request a hearing under ORS

4 (7)(a) The director may delay the reconsideration proceeding and toll the reconsideration 5 timeline established under subsection (6) of this section for up to 45 calendar days if:

(c) At the request of either of the parties, the director shall appoint a panel of as many as three

(d) The arbiter, or panel of medical arbiters, must be chosen from among a list of physicians

(e)(A) The medical arbiter or panel of medical arbiters may examine the worker and perform

(B) If the director determines that the worker failed to attend the examination without good cause or failed to cooperate with the medical arbiter, or panel of medical arbiters, the director shall postpone the reconsideration proceedings for up to 60 days from the date of the determination that the worker failed to attend or cooperate, and shall suspend all disability benefits resulting from this or any prior opening of the claim until such time as the worker attends and cooperates with the examination or the request for reconsideration is withdrawn. Any additional evidence regarding good cause must be submitted prior to the conclusion of the 60-day postponement period.

45 (C) At the conclusion of the 60-day postponement period, if the worker has not attended and

1 cooperated with a medical arbiter examination or established good cause, the worker may not attend

a medical arbiter examination for this claim closure. The reconsideration record must be closed, and the director shall issue an order on reconsideration based upon the existing record.

4 (D) All disability benefits suspended under this subsection, including all disability benefits 5 awarded in the order on reconsideration, or by an Administrative Law Judge, the Workers' Com-6 pensation Board or upon court review, are not due and payable to the worker.

7 (f) The insurer or self-insured employer shall pay the costs of examination and review by the 8 medical arbiter or panel of medical arbiters.

(h) After reconsideration, no subsequent medical evidence of the worker's impairment is admissible before the director, the Workers' Compensation Board or the courts for purposes of making

(i)(A) If the basis for objection to a notice of closure issued under this section is a disagreement with the impairment used in rating the worker's disability, and the director determines that the worker is not medically stationary at the time of the reconsideration or that the closure was not made pursuant to this section, the director is not required to appoint a medical arbiter before completing the reconsideration proceeding.

(B) If the worker's condition has substantially changed since the notice of closure, upon the
consent of all the parties to the claim, the director shall postpone the proceeding until the worker's

(9) No hearing shall be held on any issue that was not raised and preserved before the director
at reconsideration. However, issues arising out of the reconsideration order may be addressed and

(12) Any notice of closure made under this section may include necessary adjustments in compensation paid or payable prior to the notice of closure, including disallowance of permanent disability payments prematurely made, crediting temporary disability payments against current or future

permanent or temporary disability awards or payments and requiring the payment of temporary
 disability payments which were payable but not paid.

3 (13) An insurer or self-insured employer may take a credit or offset of previously paid workers' compensation benefits or payments against any further workers' compensation benefits or payments 4 due a worker from that insurer or self-insured employer when the worker admits to having obtained 5 the previously paid benefits or payments through fraud, or a civil judgment or criminal conviction 6 is entered against the worker for having obtained the previously paid benefits through fraud. Bene-7 fits or payments obtained through fraud by a worker may not be included in any data used for 8 9 ratemaking or individual employer rating or dividend calculations by an insurer, a rating organization licensed pursuant to ORS chapter 737, the State Accident Insurance Fund Corporation or the 10 11 director.

(b) An insurer or self-insured employer may suspend and offset any compensation payable to the beneficiary of the worker, and recover an overpayment of permanent total disability benefits caused by the failure of the worker's beneficiaries to notify the insurer or self-insured employer about the death of the worker.

(15) Conditions that are direct medical sequelae to the original accepted condition shall be included in rating permanent disability of the claim unless they have been specifically denied.

SECTION 30. ORS 657.730 is amended to read:

657.730. (1) As used in this section, unless the context requires otherwise:

(a) "Labor market area" means an economically integrated geographic area within which indi-25viduals can reside and find employment within a reasonable distance or can readily change em-2627ployment without changing their place of residence. Such areas shall be identified in accordance with criteria used by the Bureau of Labor Statistics of the United States Department of Labor in 28defining such areas or similar criteria established by the Director of the Employment Department. 2930 The boundaries depend primarily on economic and geographic factors. The State of Oregon is di-31 vided into labor market areas, including local workforce areas, which usually include a county or 32group of contiguous counties.

(b) "Workforce and labor market information" means the body of information generated from measurement and evaluation of the socioeconomic factors and variables influencing the employment process in the state and specific labor market areas. These socioeconomic factors and variables include:

(A) Labor force information, which includes but is not limited to employment, unemployment,
 labor force participation and characteristics of the population and labor force;

(B) Occupational information, which includes but is not limited to occupational supply and de mand estimates and projections, characteristics of occupations, skill requirements, wage levels, job
 duties, training and education requirements, conditions of employment, unionization, retirement
 practices and training opportunities;

43 (C) Economic information, which includes but is not limited to number of business starts and
44 stops by industry and labor market area, information on employment growth and decline by industry
45 and labor market area, employment projections by industry, employer establishment data and num-

1 ber of union disputes and strikes by industry and labor market area; and

2 (D) Program information, which includes but is not limited to program participant or student 3 information gathered in cooperation with other state and local agencies along with related labor 4 market information to evaluate the effectiveness, efficiency and impact of state and local employ-5 ment, training, education and job creation efforts in support of planning, management, implementa-6 tion and evaluation.

(2) The Director of the Employment Department shall have the following duties:

8 (a) Overseeing, operating and managing a statewide comprehensive workforce and labor market
9 information system.

10 (b) Supporting Oregon's state and local workforce boards by providing foundational workforce 11 data and special studies in support of state and local employment, training, education and job cre-12 ation programs, especially activities that prevent job loss, reduce unemployment and create jobs.

(c) Supporting other Oregon customers of workforce and labor market information, including,
 but not limited to, businesses, job seekers, policy makers, educational agencies and students, and
 providing foundational workforce data and analysis of trends at the state and local levels.

(d) Coordinating with state workforce agencies and other federal, state and local government
 partners to improve workforce and labor market information products and services.

(e) Producing workforce and labor market information and economic analysis needed to facilitate the efficient and effective matching of the supply and demand of labor critical to an effective
labor exchange in Oregon.

(f) Administering other appropriate workforce and labor market information activities including support of efforts by local workforce development boards, as defined in ORS 660.300, to align economic development, education and training with workforce development investments and services for job seekers and businesses to efficiently address local labor market needs and statewide workforce development priorities.

(3) To implement this section, the director shall have authority to:

(a) Establish rules and procedures to recover reasonable costs incurred in producing and pro-viding:

(A) Workforce and labor market information products developed by the Employment Department in the ordinary course of business when the request results in costs over and above the ordinary costs of production including, but not limited to, special publication runs, photocopying or supplying the copy in some other medium; and

(B) Special workforce and labor market information products in response to individual requests that incur costs beyond the ordinary costs of doing business including, but not limited to, computer time, staff costs, preparation and distribution of surveys, electronic scanning, and special data collection, formatting and analysis. The director may enter into agreements with other public agencies to provide special workforce and labor market information products in a quid pro quo arrangement.
