"(2) Not later than December 31, 2019, the board shall approve the
 examinations for licensure as a residential care facility administrator
 described in section 3 of this 2018 Act.

23 "SECTION 28. (1) Not later than July 1, 2019, an individual who is 24 employed in Oregon as a residential care facility administrator, as 25 defined in ORS 678.710, shall apply to the Health Licensing Office on 26 a form created by the office for a residential care facility administra-27 tor license. The office may issue a license under this section to an 28 applicant who:

29 "(a) Is at least 21 years of age;

30 "(b) Has earned at least a high school diploma or its equivalent;

"(c) Has been employed in Oregon as a residential care facility administrator for at least five years;

"(d) Has continually met the requirements for training and continuing education established by the office by rule;

"(e) Is in good standing with the office, and with the Department
of Human Services for any facilities regulated by the department for
which the individual is responsible;

"(f) Has not been convicted of a crime described in ORS 443.004; and
"(g) Pays the licensure fee established by the office by rule.

"(2) The office may issue a provisional residential care facility administrator license to an individual who applies for licensure under this section and who is employed in Oregon as a residential care facility administrator but who does not meet all the requirements of subsection (1)(c) to (e) of this section. An individual described in this subsection must earn a passing score on an examination described in section 3 of this 2018 Act on or before December 31, 2021.

"(3) The office may issue a provisional residential care facility administrator license to an individual who is not employed in Oregon as a residential care facility administrator but who meets the requirements of section 2 (1) to (5) of this 2018 Act. An individual described in this subsection must earn a passing score on an examination described in section 3 of this 2018 Act on or before December 31, 2021.

"(4) An individual who applies for a provisional license under sub section (2) or (3) of this section must pay the provisional licensure fee
 established by the office by rule.

"(5) An individual issued a provisional license under this section
 shall:

"(a) Submit to the office sufficient proof that the individual has
 completed a tuberculosis screening with a satisfactory result; and
 "(b) Meet the requirements for training and continuing education

established by the office by rule. 1

"(6) A provisional residential care facility administrator license is- $\mathbf{2}$ sued under this section is not renewable and expires on the earlier of 3 December 31, 2021, or the date upon which the holder is issued a li-4 cense under section 2 of this 2018 Act.  $\mathbf{5}$ 

"(7) Moneys collected under this section shall be paid into the 6 General Fund and credited to the Health Licensing Office Account es-7 tablished under ORS 676.625. 8

"(8) The office may adopt rules to carry out the requirements of 9 this section, and may consult with the department in establishing any 10 standards under this section. 11

"SECTION 29. (1) Section 27 of this 2018 Act is repealed on January 12 2, 2020. 13

"(2) Section 28 of this 2018 Act is repealed on January 2, 2022. 14
