## PROPOSED AMENDMENTS TO HOUSE BILL 4018

The task force shall present the 29 concept to the interim committees of the Legislative Assembly related 30

1 to health no later than December 31, 2018.

"(4) A majority of the voting members of the task force constitutes
a quorum for the transaction of business.

4 "(5) Official action by the task force requires the approval of a
5 majority of the voting members of the task force.

6 **"(6)** The task force shall elect one of its members to serve as 7 chairperson.

"(7) If there is a vacancy for any cause, the appointing authority
shall make an appointment to become immediately effective.

"(8) The task force shall meet at places specified by the chairperson
 or by a majority of the voting members of the task force.

"(9) The task force may adopt rules necessary for the operation of
 the task force.

"(10) The Oregon Health Authority shall provide staff support to the
 task force.

"(11) Members of the task force who are not members of the Leg islative Assembly or a state agency are entitled to compensation and
 reimbursement as provided in ORS 292.495.

"(12) All agencies of state government, as defined in ORS 174.111, are directed to assist the task force in the performance of the task force's duties and, to the extent permitted by laws relating to confidentiality, to furnish information and advice the members of the task force consider necessary to perform their duties.
