PROPOSED AMENDMENTS TO HOUSE BILL 4093

"(b) 'Amateur sports organization' means a group or association
 that fosters amateur sports activities and competitions for amateur
 athletes and is organized under a regional, national or international
 certifying authority.

20 "(2)(a) On or before January 1 of each year, an amateur sports or-21 ganization shall submit to the Director of the Department of Consumer and Business Services a report that includes the following
 information:

"(A) A list of the names, addresses and any other contact information for the regional, national and international certifying authority
that has certified the organization as an amateur sports organization;
and

"(B) A roster that lists the names, addresses and other contact information for each team, league, club and association that is affiliated
with or governed by the amateur sports organization and that participates in amateur sports activities, events or competitions in this
state.

"(b) Upon request, an amateur sports organization shall make
 copies of the report available to interested persons.

"(3) The director of the department shall make available to the
 public the reports submitted to the department under subsection (2)
 of this section.

"(4) For the purposes of section 8 of this 2018 Act, the provisions of ORS chapters 652 and 653 and ORS 656.027, an individual is an amateur athlete during the time in which the individual is actively engaged in training or conditioning for, or participating in, amateur sports activities, events or competitions.".
