"(2) Notwithstanding any other law limiting expenditures, the limi-10 tation on expenditures established by section 2 (1), chapter 545, Oregon 11 Laws 2017, for the biennium ending June 30, 2019, as the maximum 12limit for payment of expenses from fees, moneys or other revenues, 13 including Miscellaneous Receipts, tobacco tax receipts, recreational 14 marijuana tax receipts, provider taxes, Medicare receipts and federal 15 funds for indirect cost recovery, Supplemental Security Income re-16 coveries, Women, Infants and Children Program food rebates, the Co-17 ordinated School Health Program, the Edward Byrne Memorial State 18 and Local Law Enforcement Assistance Grant Program and emergency 19 preparedness and response services, but excluding lottery funds and 20federal funds not described in section 2, chapter 545, Oregon Laws 2017, 21

"(4) Notwithstanding any other law limiting expenditures, the limi-19 tation on expenditures established by section 4 (1), chapter 545, Oregon 20Laws 2017, for the biennium ending June 30, 2019, as the maximum 21limit for payment of expenses from federal funds, excluding federal 22funds described in section 2, chapter 545, Oregon Laws 2017, collected 23or received by the Oregon Health Authority, for programs, is increased 24by \$45,946 for the purpose of carrying out the provisions of sections 2 25and 3 of this 2018 Act.". 26
