7 "(b) Has earned at least a high school diploma or its equivalent;

8 "(c)(A) For at least two of the last five years has been employed in a 9 professional or managerial capacity in a field related to health or social 10 service, or has a combination of experience and education deemed sufficient 11 by the office; or

"(B) Has earned at least a bachelor's degree in a field related to health
 or social service;

"(d) Has completed at least 40 hours of training approved by the Depart ment of Human Services by rule;

"(e) Has met any applicable continuing education requirements established by the department by rule for the lesser of the three years immediately
preceding the date of application or the duration of employment or qualification in Oregon as a residential care facility administrator;

"(f) Is in good standing with the office, and has not been responsible for any residential care facility that has been subject to conditions imposed by the department while the person was responsible for the residential care facility, for the lesser of the four years immediately preceding the date of application or the duration of employment or qualification in Oregon as a residential care facility administrator; and
