HB 2098 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes that recreational marijuana licensure renewal fees are nonrefundable if applicant is conditionally or unconditionally authorized to operate marijuana establishment.

HB 3386

Identifies types of businesses eligible to deliver distilled liquor, malt beverages, wine or cider to person taking possession for personal or social use.

HB 3395

Allows person responsible for marijuana grow site who is designated to grow marijuana by more than three registry identification cardholders to transfer usable marijuana to additional registry identification cardholders.

HB 2053 \*\*

\*\*Subsequent Referral(s) to Revenue

CARRIED OVER FROM THE 4/1/19 AGENDA: Modifies provisions related to employment and employee compensation for Oregon Business Retention and Expansion Program, enterprise zones, long term incentives for rural enterprise zones and business development income tax exemption.

HB 2054

Makes program changes to Oregon Innovation Council statutes.

HB 2181

Requires State Workforce and Talent Development Board to conduct study and analyze how to best implement recommendations developed by Task Force on Maritime Sector Workforce Development.

HB 2243

Defines "public library" as public facility providing free and equal access to library and information services for all residents of local government unit.

HB 2310 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes Prosperity 1,000 Pilot Program to provide career coaching, occupational training and job placement services for at least 1,000 low-income job seekers residing in areas of concentrated poverty.

HB 2320 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Provides that fixed percentage of certain forecasted video lottery revenues, adjusted for certain allocations to Regional Solutions Program, be transferred to counties for economic development.

HB 2454

Allows out-of-state applicant seeking occupational license in Oregon more time to meet Oregon standards if applicant is already licensed in another state and is seeking to work in Eastern Oregon Border Economic Development Region. HB 2900 \*\* \*\*Subsequent Referral(s) to Revenue

Extends sunset of exemption from property taxation for qualified machinery and equipment that is used in food processing.

HB 2909

Allows delivery of marijuana items, pursuant to bona fide orders, to consumers within city or county in which marijuana retailer is located and to consumers in cities or counties that have adopted ordinances allowing for delivery of marijuana items from adjacent cities or counties.

HB 2933

Clarifies, for purposes of Eastern Oregon Border Economic Development Board activities, that "workforce development" includes development of residential housing necessary to attract and keep employees in Eastern Oregon Border Economic Development Region.

HB 3061

Allows political subdivision to convey real property to nonprofit, municipal or private corporation for purpose of providing broadband service.

HB 3251 \*\*

\*\*Subsequent Referral(s) to Ways and Means Authorizes Oregon Business Development Department to make loans and award matching grants to membership organizations and business accelerators in outdoor recreation industry.
