HB 2023

Directs State Board of Education to ensure that academic content standards for certain subjects include sufficient instruction on histories, contributions and perspectives of certain classifications of individuals. **Subsequent Referral(s) to Student Success

HB 2224 **

Directs Department of Education to distribute grants for improving student outcomes by supporting social, emotional, mental and physical health needs of students.

HB 2441 **

**Subsequent Referral(s) to Student Success Requires school districts to provide coordinated comprehensive school counseling program. **Subsequent Referral(s) to Student Success

HB 2940 **

Establishes pilot program for purpose of increasing number of public school students who are served by school social workers

HB 2026 **

**Subsequent Referral(s) to Student Success

Extends sunset on pilot program to decrease rates of school absenteeism by using trauma-informed approaches to education, health services and intervention strategies.

**Subsequent Referral(s) to Student Success

Provides grants to counties that received Secure Rural Schools Program payments in calendar year 2008 equal to at least 30 percent of all moneys deposited into county general fund.
