Public Hearing

SB 534 A

Requires local governments to allow single-family dwellings within urban growth boundary of city with population greater than 25,000 in residential lots platted and zoned for such uses.

Possible Work Session

SB 8 A

Requires Land Use Board of Appeals to award local governments and applicants their expenses and attorney fees against petitioners if affirming local government's approval of publicly supporting housing.

SB 167

Aligns definitions in mental health services bill of rights with definitions applicable to reporting of abuse of persons with mental illness.

SB 176 A

Requires certain filling stations, service stations, garages and other dispensaries that dispense Class 1 flammable liquids to provide equal access to persons with disabilities.

- SB 278 A
Extends eligibility for Rent Guarantee Program to individuals between 16 and 26 years of age who were wards within past 10 years.
- SB 586 A
Renames "Office of Manufactured Dwelling Park Community Relations" to "Manufactured and Marina Communities Division" and "Mobile Home Parks Account" to "Manufactured and Marina Communities Account." Extends division's duties and account's uses to marinas and floating home tenants.
- SB 813 A
Directs Office of Child Care to make reasonable attempt to identify any child care facility, or person or place providing child care, about which it receives complaint if certain information is provided.
- SB 970 A
Limits applicable screening criteria for residential landlords.
