HB 2013

CARRIED OVER FROM 4/8/19 AGENDA: Provides that person subject to certain court protective orders is prohibited from possessing firearms if person had opportunity to be heard on order and did not request hearing or withdrew request before hearing occurred.

HB 2849

HB 3201
