CARRIED OVER FROM 5/21/2019 5:30 PM AGENDA: Requires defendant to file notice of intent to introduce evidence of mental defense at least 45 days before trial.

SB 420 A

CARRIED OVER FROM 5/21/2019 5:30 PM AGENDA: Establishes procedures for persons with qualifying marijuana convictions to file motion requesting court to enter order setting aside conviction.

SB 474

CARRIED OVER FROM 5/21/2019 5:30 PM AGENDA: Modifies length of time of parental desertion or abandonment of child resulting in forfeiture of parent's intestate share of child's estate and parent's interest in property transferred from child to parent by transfer on death deed.

SB 478 A

CARRIED OVER FROM 5/21/2019 5:30 PM AGENDA: Prohibits campaign moneys and public moneys from being used to make payments in connection with nondisclosure agreement relating to workplace harassment .

SB 479 A

CARRIED OVER FROM 5/21/2019 5:30 PM AGENDA: Requires public employers to adopt policies to prevent workplace harassment.

SB 495 A

Prohibits use of dog to extract inmate from cell in correctional facilities .

SB 498 A

Prohibits Department of Corrections from entering into contract with inmate telephone services provider that authorizes department to receive fee or commission other than reimbursement for expenses.

SB 810

CARRIED OVER FROM 5/21/2019 5:30 PM AGENDA: Modifies definition of "vulnerable user of a public way" to include persons operating or riding on moped or motorcycle.

SB 962 A

Directs certifying agencies to certify to United States Citizenship and Immigration Services, within specified time, victim helpfulness in detecting, investigating or prosecuting qualifying criminal activity.

SB 975 A

CARRIED OVER FROM 5/21/2019 5:30 PM AGENDA: Establishes procedures for persons with marijuana convictions to file motion requesting court to reduce offense classification if, since entry of judgment of conviction, offense classification has been reduced.

SB 999 A

CARRIED OVER FROM 5/21/2019 5:30 PM AGENDA: Modifies provisions requiring person to be informed about rights and consequences relating to driving under the influence of intoxicants.

SB 1011 A

Provides that obligee spouse's conviction for attempted murder or conspiracy to commit murder of obligor spouse is change of circumstances for purposes of spousal support modification.

SB 1040 A

CARRIED OVER FROM 5/21/2019 5:30 PM AGENDA: Makes owner, operator or lessee of quarry or mine located on property adjacent to Willamette River in Polk County and across river from City of Keizer liable for injuries resulting from bullets that stray outside boundaries of property if, after being notified that bullets have strayed, owner, operator or lessee fails to take reasonable measures to prevent additional bullets from straying.
