Public Hearing

HB 2495

FOR PURPOSES OF CONSIDERING AMENDMENT(S) THAT REPLACE BILL Makes privilege taxes on merchantable forest products harvested on forestlands permanent and increases rate of tax levied for payment of benefits related to fire suppression.

Work Session

HB 3197

Extends time for filing of estate tax return as applicable to estate owing no federal estate tax.

SB 837

Authorizes, during five assessment years following correction of real market value by Department of Revenue or tribunal, change to real market value indicated by subsequent sale of property.

SB 81

Changes due date for forest products harvest tax and western and eastern Oregon small tract severance tax to April 15.

SB 79 A

Provides that Department of Revenue may assist certain public bodies in collecting delinquent accounts, subject to certain limitations.

SB 80 A

Authorizes certain tax-related documents to be delivered or made available by method other than regular mail.

HB 2390

CARRIED OVER FROM THE 5-28-2019 MEETING Directs State Treasurer to study and make recommendations on provisions of state law relating to depositories of public funds.

HB 2128

CARRIED OVER FROM THE 5-28-2019 MEETING Modifies definition of "tax expenditure" applicable to automatic tax expenditure sunset provisions by excluding provisions required by federal law.

HB 2429

CARRIED OVER FROM THE 5-28-2019 MEETING Provides that machinery and equipment used to compress and bale harvested straw, hay, grass or other plants for purpose of storage or shipment is tangible personal property exempt from ad valorem property taxation.

HB 2449 A

CARRIED OVER FROM THE 5-28-2019 MEETING Increases rate of tax for emergency communications.

HB 2978

CARRIED OVER FROM THE 5-28-2019 MEETING Creates tax credit for short line railroad rehabilitation projects.
