Work Session SB 155 **

**Subsequent Referral(s) to Judiciary

CARRIED OVER FROM THE 4/3/2019 AGENDA: Requires all investigations involving suspected abuse or sexual conduct by school employees to be conducted by Teacher Standards and Practices Commission.

SB 158

CARRIED OVER FROM THE 4/3/2019 AGENDA: Directs Higher Education Coordinating Commission to develop and implement pilot program to assist foster youth transitioning from community colleges to public universities.

SB 496

CARRIED OVER FROM THE 4/3/2019 AGENDA: Requires school districts to ensure that all students of school district have equal access to educational facilities.

SB 731

CARRIED OVER FROM THE 4/3/2019 AGENDA: Authorizes recognized student government of community college or public university, or member of recognized student government, to make statement or issue resolution to promote or oppose gathering of signatures on initiative or referendum petition or adoption of ballot measure. 844 ** ** Subsequent Referral(s) to Ways and Means

SB 844 **

CARRIED OVER FROM THE 4/3/2019 AGENDA: Appropriates moneys to Higher Education Coordinating Commission for 2019-2021 biennium for use by Oregon State University to develop, implement and operate website for providing public with information related to plant pest solutions.

SB 852 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/3/2019 AGENDA: Provides that part-time faculty member at public institution of higher education who qualifies for health care benefits will pay 10 percent of insurance premiums, with remaining 90 percent paid by state.

Establishes refundable credit against personal income taxes for contributions to higher education savings network account.

SB 905

Allows individual voluntarily placed in foster care to be resident of school district where individual resides due to placement by public or private agency if placement agreement provides that individual will no longer be considered resident of school district of origin.

SB 283 **

Directs Department of Education to prepare and make available statement that discloses potential health risks of wireless network technology and requires public and private schools to distribute statement to employees, students and parents or guardians of students.

SB 266 **

**Subsequent Referral(s) to Ways and Means

Appropriates moneys from General Fund to Higher Education Coordinating Commission for Community College Support Fund for distribution to community colleges and community college service districts.

SB 153

Directs Department of Education to conduct study on adequacy of education in state and report to interim committee of Legislative Assembly by September 15, 2020.
