SB 943  
CARRIED OVER FROM THE 4-1-2019 AGENDA: Allows development of parsonage on land where nonresidential place of worship is allowed use.

#### Public Hearing and Work Session

SB 8 \*\* \*\*Subsequent Referral(s) to Judiciary  
CARRIED OVER FROM THE 4-1-2019 AGENDA: Requires petitioners to pay costs and attorney fees, including on appeal, to prevailing intervening developers of affordable developments that were approved by local government.  
SB 586  
CARRIED OVER FROM THE 4-1-2019 AGENDA: Renames "Office of Manufactured Dwelling Park Community Relations" to "Manufactured and Marina Communities Division," "Mobile Home Parks Account" to "Manufactured and Marina Communities Account" and "Mobile Home Parks Purchase Account" to "Residential Dwelling Facilities Purchase Account." Extends division's duties and accounts' uses to marinas and floating home tenants.

#### Public Hearing and Possible Work Session

SB 334  
Requires city to expand its urban growth boundary to include land designated as urban reserve that supports workforce housing and commercial development supportive of workforce housing if urban services are or can be made available.  
SB 534  
Requires city to allow single-family dwellings in residential lots platted and zoned for such uses.  
SB 820  
Updates form, style and references within Housing Authorities Law.  
SB 821  
Makes form and style edits to definitions used in visibility development requirements for subsidized rental housing.  
SB 1024  
Authorizes Housing and Community Services Department to provide grants to nonprofit to develop infrastructure for new manufactured dwelling park in Springfield, Oregon.
