- Elimination of training requirements for screeners
- Elimination of time limits for Protective Actions without a judicial order
- Elimination of contacting collateral contacts and reviewing screening history
- Elimination of requirements to do notifications as required in SB 1515 and SB 243
- Elimination of requirement to notify caseworker when new abuse report is received on an open case
- Change of required response timeline for assigned case from 5 calendar days to 10 business days
