Public Hearing and Work Session

- SB 606 ** **Subsequent Referral(s) to Ways and Means
Establishes Domestic Violence Committee within Oregon Criminal Justice Commission to study and make recommendations on ways to improve criminal justice system response to domestic violence in state.
- SB 873
Allows defendant in eviction action to apply for order setting aside judgment.
- SB 924 ** **Subsequent Referral(s) to Ways and Means
Modifies juvenile code to prohibit placement of children and wards taken into protective custody in detention facilities.
- SB 992
Directs Department of Corrections to conduct study on adequacy of funding for counties for community corrections programs and present report on findings to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.

Work Session

- SB 24
Modifies procedures related to criminal defendants lacking fitness to proceed.
- SB 299
Prohibits denial of medical assistance on basis that individual under 18 years of age is in detention pending adjudication.
- SB 318
Creates rebuttable presumption that equal parenting time is in best interests of child.
- SB 321
Modifies procedures by which person convicted of felony initiates proceedings to obtain DNA testing.
- SB 373
Exempts from public records disclosure medical records of individuals under jurisdiction of Psychiatric Security Review Board that are maintained by board.

- SB 498
Requires Department of Corrections to adopt rules that prohibit correctional facilities, and requires cities and counties to adopt ordinances that prohibit local correctional facilities, from having contract with provider of telephone services under which department, city, county or facility receives payment for telephone services provided to inmates of facility.
- SB 577 ** **Subsequent Referral(s) to Ways and Means
Directs Department of Justice to study topics relating to bias crimes and report results to interim committees of Legislative Assembly related to judiciary on or before September 15, 2020.
- SB 597
Authorizes use of pseudonym, initials or other signifier instead of name of witness or victim in indictment when specified requirements are met.
- SB 725 ** **Subsequent Referral(s) to Human Services
Specifies charges or convictions that may not be considered in fitness determinations.
- SB 763
Defines "dangerous to self or others" for purposes of civil commitment proceedings.
- SB 1011
Provides that obligee spouse's conviction for attempted murder or conspiracy to commit murder of obligor spouse is change of circumstances for purposes of spousal support modification.
