- SB 678 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Appropriates moneys from General Fund to Oregon Department of Administrative Services for distribution to Salvage Chief (LSM380) Foundation for purpose of repairing and upgrading salvage vessel.
- SB 938 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Authorizes issuance of general obligation bonds under Article XI-Q of Oregon Constitution for construction of veterans' home in Roseburg, Oregon.

- SB 234  
Directs Department of Veterans' Affairs to submit report to interim legislative committees, no later than July 1, 2020, regarding provision of veterans' services.
- SB 462
