DOJ's statutory billing authority

• 180.160 Charges for services to public agencies; rules.

 Provides that DOJ may charge agencies and other public bodies for rendering legal assistance.

• 180.170 Billing for services to public agencies.

 Provides that DOJ shall estimate biennial expenses in advance and invoice agencies and other public bodies for their share of these expenses. Provides for adjusting future invoices for prior differences between actual and estimated expenses.

• The hourly billing rate is not set in statute. It is developed in conjunction with the development of the biennial budget.

• The rate is not final until the end-of-session omnibus budget bill.

 - Appellate (including Defense of Criminal Convictions)
 - Trial (including Defense of Criminal Convictions)
 - General Counsel
 - Attorney General's Office
 - Civil Enforcement Legal
 - Criminal Justice Legal
- Non-Legal Divisions:
 - Child Support
 - Crime Victims' Services
 - Civil Enforcement Non-Legal
 - Criminal Justice Non-Legal
 - Administrative Services

What is the Legal Fund?

The Legal Fund is an internal service fund which records the revenues and expenses for providing Legal Services to state government.

Examples of Other Internal Service Funds: Motor Pool, Copy Machines — each with a user fee.



Department of Justice – Legal Fund Description

Legal Fund Budget Model:

- Other Funds expenditure limitation to hire employees and pay operating costs.
- The legal rate billed to client agencies has to be adequate to fund:
 - The attorney
 - Contribute to division operating costs for supplies, services, technology, capital items and costs charged to divisions for rent, payroll, accounting, human resources, etc.

Department of Justice – Legal Rate

Legal Rate – Two Components

Direct Cost of the Hours of Work

Plus

Operating Costs and Assessments for Agency & State Overhead *

 * - Overhead includes non-billable hours, division operating costs, administrative assessments the department receives for technology, telecommunications, rent, insurance, accounting and human resources.





Department of Justice – Legal Rate

Calculation of Attorney General Rate

Total projected biennial legal service costs

Rate * =

Projected number of biennial billable hours

* - Rate is actually assigned in the end-of-session omnibus budget bill.







Calculating the billing rate needed to provide legal services

- 2017-19 Legislatively Adopted Budget (LAB)
- Changes to 2017-19 LAB (e.g., short session and E-boards)
- Changes to 2019-21 (base adjustments and essential packages such as inflation and phase-outs)
- Assumptions related to compensation (COLAs, flexible benefits, PERS rates)
- Policy packages and working capital adjustment
- = 2019-21 expenditures

Divided by projected billable hours = 2019-21 billing rate



Department of Justice – Billing Process

Recent History of the Legal Rate

• The AG billing rate is the dollar amount charged to DOJ's client agencies and internal accounts for one hour of legal work.

•	Biller Type	2015-17	2017-19	2019-21ARB
•	Assistant Attorneys General	\$175/hr	\$182/hr	\$223/hr
•	Paralegals	90/hr	91/hr	98/hr
•	Investigators	116/hr	125/hr	126/hr
•	Law Clerks	55/hr	55/hr	55/hr
•	Clerical	47/hr	49/hr	49/hr

• The billing rate is calculated to generate revenue that will match the projected expenditures and working capital need.

Costs Affecting the Legal Rate

Direct Costs

Salaries and benefits for Legal Divisions Services and supplies for Legal Divisions Capital outlay for Legal Divisions

Central Service Costs

Administrative services related to Legal Divisions

External Fixed Costs

Costs assessed by State Government Service Charges attributable to the Legal Divisions



Factors Affecting the Legal Rate

Decreases to the Hourly Rate:

Add an Attorney or any billable position.

Reduce non-billable positions.

Reduce other costs and administrative assessments.

Increases to the Hourly Rate:

Reduce Attorney or any billable positions.

Increase non-billable positions.

Increase other costs or administrative assessments.





Legal Rate Parallels the State Budget Process

- Agency Request Budget Legal Rate is an estimate of the ARB with all budgetary requests made by the Department of Justice.
- Governor's Budget Legal Rate recalculated to represent Current Service Level plus adopted Policy Option Packages and other components of Governor's Budget.
- Legislatively Adopted Budget Legal Rate recalculated for each legislative budget decision affecting Department of Justice.
