### **Summary of Revenue Changes**

The Health-Related Licensing Boards (HRLB) are comprised of six independent licensing boards supported by Other Funds revenues primarily derived from examination, application and licensing fees. The boards are combined into one agency for the ease of budgetary reporting; however, each has a separate limitation within the bill that is approved by the Legislature.

### Oregon Mortuary and Cemetery Board

The Subcommittee approved an additional \$1,376,107 in Other Funds revenue to reflect the transfer of the administration of the Indigent Disposition Program in House Bill 3243 (2015) from the Oregon Health Authority (OHA) to the Board. In addition, the Subcommittee approved an increase of \$31,302 to the intrafund transfer-in amount to update the cost allocation for the accountant position shared by all HRLBs.

### **Board of Naturopathic Medicine**

The Subcommittee approved an increase of \$6,626 to the intrafund transfer-out to update the cost allocation for the accountant position shared by all HRLBs. In addition, the Subcommittee included an \$8,000 transfer-out to OHA for the workforce database fee.

### Occupational Therapy Licensing Board

The Subcommittee approved a \$45,700 increase in licensing revenues to better reflect actuals. The Subcommittee also approved an increase of \$12,244 to the intrafund transfer-out to update the cost allocation for the accountant position shared by all HRLBs and an \$8,640 transfer-out to OHA for the workforce database fee.

### **Board of Medical Imaging**

The Subcommittee approved a \$1,200 increase in revenues to reflect the additional licensing revenue from Bone Densitometry Certification approved in House Bill 2267 (2017). In addition, the Subcommittee approved a \$211 increase to the intrafund transfer-out amount to update the cost allocation for the accountant position shared by all HRLBs and a \$25,100 transfer-out to OHA for the workforce database fee.

### State Board of Examiners for Speech-Language Pathology and Audiology

The Subcommittee approved a \$10,400 transfer-out to OHA for the workforce database fee. In addition, the Subcommittee approved an increase of \$15,999 to the intrafund transfer-out to update the cost allocation for the accountant position shared by all HRLBs.

### Oregon Veterinary Medical Examining Board

The Subcommittee approved a \$3,356 decrease to the intrafund transfer-out amount to update the cost allocation for the accountant position shared by all HRLBs.

### **Summary of Education Subcommittee Action**

### Oregon Mortuary and Cemetery Board

The Oregon Mortuary and Cemetery Board regulates the individuals and facilities engaged in the care, preparation, and processing, transportation and final disposition of human remains through licensing, inspection and disciplinary programs. The Subcommittee approved a budget of \$2,173,299 Other Funds and seven positions (7.00 FTE). The budget reflects a 2.6 percent increase from the 2015-17 Legislatively Approved Budget and provides the Board with an ending balance of \$902,988, which is approximately 10.0 months of operation expenses.

The Subcommittee approved the following:

• Package 801, LFO Analyst Adjustment: increases non-license revenue and eliminates a revenue transfer-in from OHA to reflect the Board's administration of the Indigent Disposition Program approved in House Bill 3243 (2015). This package also updates the cost allocation model for the accountant position shared by the HRLBs, while increasing professional services by \$56,038 and reducing Other Services and Supplies by \$16,577.

### **Budget Note:**

The Health-Related Licensing Boards are directed to work with the Office of the State Chief Information Officer and other licensing boards as appropriate, to assess the information technology needs and requirements for licensing databases, as well as support for desktop, hardware and software, and any other IT systems. A report on this assessment, including any request for additional resources, is to be presented to the Joint Committee on Ways and Means during the 2018 Legislative Session.

### **Board of Naturopathic Medicine**

The Oregon Board of Naturopathic Medicine regulates naturopathic physicians through licensing and disciplinary programs. The Subcommittee approved a budget of \$812,660 Other Funds and three positions (3.00 FTE), which is a 10.7 percent increase from the 2015-17 Legislatively Approved Budget and provides the Board with an ending balance of \$271,487, which is approximately 8.0 months of operating expenses.

The Subcommittee approved the following:

- Package 110, Improving Customer Service: increases the Board's existing Investigator 2 position from part-time to full-time in order to address an investigative caseload that is increasing both in number and in complexity of cases.
- Package 801, LFO Analyst Adjustment: includes a transfer-out to OHA of \$8,000 for the workforce database fee and updates the cost allocation model for the Board's portion of the shared accountant position by changing the following budget categories: increase the total transfer-out intrafund by \$6,626, increase Professional Services by \$18,679, and reduce Other Services and Supplies by \$24,566.

### Occupational Therapy Licensing Board

The Occupational Therapy Licensing Board regulates the practice of occupational therapy through licensing and disciplinary programs. The Subcommittee approved a budget of \$490,830 Other Funds and two positions (1.50 FTE), which is a 3.5 percent increase from 2015-17 Legislatively Approved Budget and provides the Board with an ending balance of \$207,471, which is approximately 10.1 months of operating expenses.

The Subcommittee approved the following:

• Package 801, LFO Analyst Adjustment: includes an update to the cost allocation model for the Board's portion of the shared accountant position by changing the following budget categories: increase the total transfer-out intrafund by \$12,244 and increase Professional Services by \$10,896. The package also reduces personal services costs by \$29,200 to better reflect actuals.

### **Board of Medical Imaging**

The Oregon Board of Medical Imaging licenses and regulates radiographers, radiation therapists, limited x-ray machine operators, nuclear medicine technologists, sonographers, MRI technologists and has now expanded to Bone Densitometry Certification through House Bill 2267 (2017). The Subcommittee approved a budget of \$900,268 Other Funds and three positions (3.00 FTE), which is a 4.6 percent decrease from the 2015-17 Legislatively Approved Budget and provides the Board with an ending balance of \$192,303, which is approximately 5.1 months of operating expenses.

The Subcommittee approved the following:

- Package 126, Bone Densitometry Certification: increases revenue for the establishment of a fee to obtain a limited permit to practice bone densitometry in Oregon, approved in House Bill 2267 (2017). The Board estimates 10 applicants will apply for the \$120 biennial permit during 2017-19, for a total revenue of \$1,200 Other Funds.
- Package 801, LFO Analyst Adjustment: includes a transfer-out to OHA of \$25,100 for the workforce database fee and updates the cost allocation model for the Board's portion of the shared accountant position by changing the following budget categories: increase the total transfer-out intrafund by \$211 and reduces Other Services and Supplies by \$32,997. Additionally, the package removes excess limitation in instate travel (\$7,363), office expenses (\$10,000), rent (\$7,000), and Agency Program Related Services and Supplies (\$14,715) to reflect actuals.

### State Board of Examiners for Speech-Language Pathology and Audiology

The Board of Examiners for Speech-Language Pathology and Audiology regulates Speech-Language Pathologists, Speech-Language Pathology Assistants and Audiologists through licensing and disciplinary programs. The Subcommittee approved a budget of \$626,713 Other Funds and two positions (2.00 FTE), which is a 7.9 percent decrease from the 2015-17 Legislatively Approved Budget and provides the Board with an ending balance of \$254,643, which is approximately 9.8 months of operating expenses.

The Subcommittee approved the following:

Package 801, LFO Analyst Adjustment: includes a transfer-out to OHA of \$10,400 for the workforce database fee and updates the cost allocation model for the Board's portion of the shared accountant position by changing the following budget categories: increase the total transfer-out intrafund by \$15,999, increase Professional Services by \$12,453, and reduces Other Services and Supplies by \$19,619. This package also eliminates an Investigator position (0.50 FTE) that had been approved as limited duration in House Bill 5023 (2015) for a reduction of \$83,621 in Personal Services costs.

### **Budget Note:**

The State Board of Speech-Language Pathology and Audiology is directed to conduct a review of its complaint and investigation process and workload, and report to the Joint Committee on Ways and Means during the 2018 Legislative Session.

### Oregon Veterinary Medical Examining Board

The Oregon Veterinary Medical Examining Board regulates the veterinary professions in Oregon through enforcement of the Veterinary Practice Act. The Subcommittee approved a budget of \$990,407 Other Funds and four positions (3.75 FTE), which is a 6.6 percent increase from 2015-17 Legislatively Approved Budget and provides the Board with an ending balance of \$627,840, which is approximately 15.2 months of operating expenses.

The Subcommittee approved the following:

• Package 801, LFO Analyst Adjustment: includes an update to the cost allocation model for the Board's portion of the shared accountant position by changing the following budget categories: reduce the total transfer-out intrafund by \$3,356, increase Professional Services by \$26,462, and reduce Other Services and Supplies by \$26,861. In addition, this package adjusts the Investigator position FTE approved as permanent full-time in House Bill 5023 (2015) from 0.75 FTE to 1.00 FTE, with a corresponding increase of \$25,079 to Personal Services.

## 1.b. Mission Statement and Statutory Authority

The Board of Examiners for Speech-Language Pathology and Audiology (BSPA) seeks to protect the public by regulating the practices of speechlanguage pathology and audiology and by licensing and regulating speech-language pathologists (SLPs), speech-language pathology assistants (SLPAs) and audiologists.

681.420 Powers and duties; rules. The State Board of Examiners for Speech-Language Pathology and Audiology shall:

- (1) Administer, coordinate and enforce the provisions of this chapter;
- (2) Evaluate the qualifications of applicants for any license as issued under this chapter and supervise the examination of such applicants;
- (3) Investigate persons engaging in practices which violate the provisions of this chapter;
- (4) Conduct hearings and keep records and minutes as the board deems necessary to an orderly dispatch of business;
- (5) Adopt rules and regulations, including but not limited to governing ethical standards of practice under this chapter; and

(6) Adopt a seal by which the board shall authenticate its proceedings. Copies of the proceedings, records and acts of the board, signed by the executive director or chairperson of the board and stamped with the seal, shall be prima facie evidence of the truth of such documents. [Formerly 694.465; 1995 c.280 §18; 2005 c.698 §18]

The authority and responsibilities of the Board are contained in the Oregon Revised Statutes (ORS) 681.205 through 681.605, and in Oregon Administrative Rules (OAR) 335-001-0000 through 335-095-0065.

### 1.c. Agency Two-Year Strategic/Business Plans

The mission and program of BSPA supports:

- A Seamless System of Education Audiologists and Speech-Language Pathologists are critical professionals in Oregon's education system. Their work in Early Intervention, Early Childhood Special Education programs and in private practice help students enter Kindergarten "ready-to-learn." Students with Individualized Education Plans (IEP) including autism and communication, language and hearing disorders must receive their IEP evaluations and treatment from licensed Audiologists and Speech-Language Pathologists.
- A Thriving Oregon Economy Speech-Language Pathologists, Audiologists, and Speech-Language Pathology Assistants are in demand in Oregon and contribute to our economy.
- **Excellence in State Government** The Board values and practices transparency in its work and updates its public information and transparency policies annually. BSPA goals include excellent customer service, processing licenses in a timely manner, conducting

investigations and closing cases in a timely manner, participating in Board member training and other courses for staff and board members offered through ilearn and other organizations.

• Safer, Healthier Communities – The Board is responsible for oveseeing the practices of speech-language pathology and audiology in all settings. Speech, language and communication disorders are the most prevalent health issues of young children, and these professionals help ensure children enter school ready to learn. They also help our seniors with hearing, swallowing, communication after stroke, and feeding issues.

SLPs, SLPAs, and audiologists provide services to children, seniors, and disabled and/or vulnerable adults. SLPs treat swallowing disorders in patients with traumatic brain injury or stroke, and their clinical judgment can mean life or death for these patients at risk for aspiration. Incompetent hearing and speech professionals can have a significant negative impact on the appropriate development or rehabilitation of patients in their care. Any licensee exhibiting inappropriate behavior such as client abuse, boundary issues, and professional impairment can endanger or otherwise victimize Oregonians.

BSPA's mission is to protect the public as it relates to the practice of speech-language pathology and audiology. Board functions address professional competence and professional conduct, and Board actions focus on remediation and prevention.

The Board's overall strategic goals include the following:

- Continuously improve administrative efficiency and effectiveness through identifying, developing and implementing best practices for customer service, licensing, investigation, disciplinary actions, and administration
- Improve licensee and administrator understanding of Board policies and processes
- Maintain or increase access to high quality speech and hearing services provided through licensed professionals
- Further develop partnerships with other licensing and regulatory agencies to achieve mutual objectives

In 2019-21, the Board has six major strategic priorities, which relate to its public protection mission:

1. *Implement new rules for telepractice:* Services can be provided via telehealth in order to reach more Oregonians. The new rules are due to take effect on July 1, 2019, and Board staff will prepare training modules to be available online, and will also travel as needed to conduct training sessions.

- 2. *Implement revised rules regarding the use of Speech-Language Pathology Assistants (SLPAs):* The Board has almost completed its thorough review of the SLPA rules, and expects to implement new rules on July 1, 2019. The Board will also prepare training on these rules for SLPAs, SLPs and their administrators.
- 3. Get current on investigations: Hire a full time investigator, get current by May, 2020 and remain current thereafter.
- 4. *Information Technology: Move to a new provider for basic I.T. services, and convert to a modern, windows-based licensing and enforcement database:* The Board's database is grossly outdated. We will work with our five "sister" Health Related Licensing Boards (HRLB) as well as the Physical Therapy Board to move to a new database. We are also working with this group to move away from our long-time I.T. contractor.
- 5. *Expand partnerships with ODE, the Oregon School based Medicaid program,* and other agencies as needed to work together on common issues including training of school administrators on the appropriate use of SLPs and SLPAs.
- 6. *Explore additional partnerships and resource-sharing with our sister boards at HRLB:* work with other boards on ways of increasing efficiency and redundancy such as cross-train licensing staff, share investigative resources, and improve other shared administrative functions.

### Agency Programs

The Agency is comprised of one program that regulates the practice of speech-language pathology and audiology and licenses speech-language pathologists, speech-language pathology assistants, and audiologists in the state of Oregon. The Board's functions are entirely supported by Other Funds; specifically by licensing fees and related administrative charges (such as delinquent fees, civil penalties, and sales of licensee mailing lists).

The Board regulates the professional practice of speech-language pathology and audiology through reviewing credentials for licensure, ongoing monitoring of licensees through compliance audits, and investigating complaints regarding professional competence and conduct. BSPA issues licenses to qualified applicants on an ongoing basis, and renews licenses biennially. All regular licenses must be renewed by December 31<sup>st</sup> of odd numbered years to be considered timely. This creates a very uneven revenue cycle, with 90% of BSPA's revenue historically realized in November/ December/January of each new biennium.

BSPA references national standards developed by the American Speech-language Hearing Association (ASHA) regarding scope of practice, required education and training, and professional and ethical standards. BSPA also solicits input from the Oregon Academy of Audiology (OAA) and Oregon Speech-language Hearing Association (OSHA) regarding issues important to licensees.

The Board regulates the professional practice of speech-language pathology and audiology through ongoing monitoring of licensees, including investigations regarding professional competence and conduct. The Board receives complaints and reviews them to determine whether the complaints fall within the Board's authority, and, if so, obtains information to establish whether a violation of statutes or rules has occurred. Investigative reports prepared by staff and paid and volunteer clinical experts are reviewed, and Board members themselves may also interview licensees during an investigation. The Board functions as a "committee of the whole" to determine if a violation has occurred and take appropriate disciplinary action. The Assistant Attorney General (AAG) assigned to the Board is consulted for legal advice on disciplinary and related administrative matters.

### Volume

Workload is tracked by two measures—licensee counts and disciplinary/compliance caseload. Licensee counts in July over the past 4 years were:

Conditional Licenses are a one-year license issued to SLPs completing their post-graduate supervised clinical experience. Provisional SLPA Licenses are a temporary license issued for 6 months to SLPA candidates completing their clinical fieldwork. Limited Licenses are a result of disciplinary action taken by the Board to preclude practice on certain age or diagnostic groups. Probation is also a result of disciplinary action; the licensee may practice but must complete certain requirements before reinstatement.

The total number of licensees this year is up 7.2% over the same time in 2016. The total licensee count in 2017 was up 11.4% from 2015. It is most relevant to compare to two years ago at the same point in time, because of the biennial renewal cycle.

### Staffing & Budget Highlights

The Board is currently staffed by three positions including a full time Executive Director, full time Administrative Assistant (Administrative Specialist 2) and half time Investigator 2. This budget proposal includes a policy package to increase the investigator position to full-time. (Note, we are still trying to hire an investigator and have been using contractors).

**No General Funds are used to fund the Board program or functions.** Licensing fees provide 99% of Board revenue; the remainder comes from civil penalties or delinquent fees for violations of Board statutes and rules, interest income and sales of mailing lists. These are all Other Funds.

For the 2019-2021 Governor's Budget, projected revenue (all Other Funds) is \$689,263. Total expenditures are \$956,379 and the ending balance is projected at \$343,729, or about 8 months of operating reserve. The projected ending balance is expected to sustain agency operations throughout the

revenue cycle and through 2019-21 without fee increases. However, the Board will re-evaluate cash flow and the possible need for a fee increase on February 1, 2020, after completion of the next license renewal cycle.

### **Environmental Factors**

- Growth and aging of the state population is increasing the demand for speech, language, communication and audiology services. According to the *U.S. Occupational Outlook*, the number of audiologists is expected to grow 10% during 2006-2016, and the number of SLPs is projected to increase 11%.
- Pacific University has added graduate programs in audiology and SLP, and PSU has increased its SLP graduate program capacity by 50%. These changes increased the number of Oregon graduates qualified for licensing beginning in 2013.
- A shortage of qualified SLPs has existed in all geographical areas of the state; particularly in rural areas. This appears to be subsiding with increased in-migration, the slow economic recovery, and the increased capacity of the Oregon training programs and a dramatic increase in the provision of services via telepractice. There remains a problem in recruitment and retention of SLPs in rural areas.
- Increased awareness of the law requiring speech-language pathology assistant (SLPA) certification and use of SLPAs due to the shortage of SLPs has contributed to the use of SLPAs. The Board responded in September 2013 by creating a Provisional SLPA license to allow individuals *not* enrolled in a university program to legally complete clinical fieldwork required for SLPA certification.
- SLPAs are required to be supervised by a SLP licensed by the Board, or by an SLP certified by TSPC who has agreed to follow the supervision rules adopted by the Board. This maintains supervision standards and provides the Board with jurisdiction over all aspects of SLPA practice.
- Improved awareness of the Board's role in consumer protection has resulted in increased administrative and legal costs associated with investigations and disciplinary actions. From 1989-2006, the Board received only 2-3 outside complaints per year. The Board now engages in more compliance investigations and communicates regularly with other jurisdictions regarding complaints filed elsewhere. Recent statistics demonstrate a striking increase in caseload to about 80-100 cases per year.
- The number of SLPs licensed by Teacher Standards and Practices Commission (TSPC) has declined from 1,007 in November 2009 to 512 in July 2014. As of 2018, only about 250 individuals still hold that license. In 2015, the legislature passed a bill that continues to allow those individuals to work if they currently have that license, but no new licenses are being granted by TSPC as of January 1, 2016. Slowly, individuals are

becoming licensed with BSPA in lieu of renewing their TSPC license, since BPSA governs the practice of speech-language and communication services in all settings in Oregon.

- In ORS 694 and OAR 333-025, the State of Oregon requires hearing aid dealers to be licensed through the Oregon Health Licensing Agency. Legislative changes in 2009 recognized hearing aid dispensing as part of the scope of practice of audiologists. Board-licensed audiologists are no longer required to be licensed by OHLA; regulation of this function is now under the aegis of this Board. However, there remain issues of mutual interest and cooperation between BSPA and OHLA regarding these related license types. A recent example is the need to clarify scope of practice issues regarding tinnitus evaluation and treatment.
- Workforce Data: The Board implemented the workforce data requirement during the last renewal and now has a better idea about the breakdown of the workforce including demographics, populations served and work sites.

### Agency Initiatives & Accomplishments

### 2013-15

- Collaboration with TSPC and other stakeholders let to development of a "universal licensure" Legislative Concept eliminating exemption from Board licensure for SLPs licensed by TSPC on or after July 1, 2016.
- General clean-up of statutes and rules including adding authority to perform fingerprint background checks.

### 2015-17

- Successful transition to new Executive Director
- Legislature passed the universal licensure legislation removing the exemption for TSPC licensure (current licensees were grandfathered). Now, anybody working in the field of speech-language pathology must be licensed through BSPA in order to work in Oregon at all work locations including health care and school based settings.
- Implemented new website with the state "look and feel."
- Implemented fingerprint background checks on all new licensees, and conducted LEDS checks on all current licensees.

### 2017-19

• Implemented WebLEDS so that background check reports can be accessed online.

- Successful implementation of Board IPADS meetings are now paperless. As such, our copier usage went down by 64.8% from 2017 as compared to 2018.
- Updated our emergency preparedness plans.
- Conducted a series of meetings with stakeholders and creating new rules for Telepractice that we plan to take effect 7/1/19.
- Reviewed all SLPA rules with stakeholders and plan to finish rulemaking so that the new rules take effect 7/1/19.
- Implemented the Workforce Data program with OHA during the 2017 renewal process.
- Started collaboration with ODE and OHA's school based Medicaid program.
- Executive Director serves on national Compact Licensure Advisory Committee.

## 1. Revenue Forecast Narrative

**Source:** The Board of Examiners for Speech-Language Pathology & Audiology is supported solely by Other Funds. Licensing fees are about 99% of revenue, with the remainder provided through delinquent fees, civil penalties, interest income, and sales of mailing lists. **Matching Funds:** None

Agency Programs Funded with Revenue: This agency has one program: regulating speech pathology and audiology practice.

**General Limits on Use of Funds:** Funds are appropriated for administration and enforcement of ORS 681.205 through 681.991, and OAR 335-001-0000 through 335-070-0095.

### **Basis for 2019-21 Estimates:**

Agency revenue is almost exclusively driven by licensing fees and volume. Licensing volume is affected by the supply and demand for SLPs, SLPAs, and audiologists in Oregon.

Adequate revenue is needed to provide funding for both operations and cash flow. Approximately 90% of the Board's revenue is derived from license renewals, which are tied to the license expiration date of January 30<sup>th</sup> of each even-numbered year. Total expenses in the Governor's Budget are \$956,379 and the ending balance is projected at \$343,729, or about 8 months of operating reserve. The projected ending balance is expected to sustain agency operations throughout the revenue cycle and through 2019-21 without fee increases.

When projecting needed ending balance, it is prudent to include an amount to cover extraordinary case costs, for which BSPA is self-insured. A reasonable estimate would be \$20,000 per year or \$40,000 per biennium. While this amount has not been included the ending balance projections in this budget request, it is important to recognize that this business risk is uncovered. On the other hand, the Board participates in the DOJ flat fee program which spreads extraordinary costs across six years. Because the Board had a case that went all the way through the appeals court (the Board prevailed), we have two-three years of significant legal costs which has increased our six year average. Between that, and the 23% increase in DOJ hourly rates, our flat fee increased by 73% over the prior biennium.

As the volume and complexity of cases has increased, legal and investigative costs have grown. BSPA is totally supported by licensing fees paid by licensees, with no "reinsurance" provided by the General Fund or any third party policy. The Board must have sufficient reserves to cover actions it takes to protect the public. In one recent case, the Board discovered that another state did not revoke an individual's license because they lacked funds. We want to avoid similar poor public policy.

### **Proposed Changes in Revenue Sources or Fees**

The Board has statutory authority in ORS 681.340 to impose fees for license fees and renewal thereof.

*The agency is not requesting a fee increase in 2019-21*, although it is may be necessary in 2021-23 to support projected CSL. It is reasonable to expect that fees will be raised about every 4 years to accommodate inflation and increased workload. Fees have not been increased in six years.

## **Types of Licenses and Who Pays**

- Licensing fees are paid on a biennial basis by active speech-language pathologists (SLPs), speech-language pathology assistants (SLPAs), and audiologists (AUDs). Individuals dually licensed in both SLP and AUD pay only a single fee.
- Delinquent fees are levied on licensees who are late in renewing, re-activating after a lapse, and for other reasons specified in our rules (including late or inadequate reporting of professional development).
- The application fee is a one-time, non-refundable fee for initial licenses of all types.
- The conditional license fee is for a special one-year license for newly graduated SLPs during their clinical fellowship year which is renewable for one year if needed while the individual completes their fellowship requirements.
- Miscellaneous fees are charged for sales of mailing lists to licensees or members of the public.

Temporary license fees were approved as part of the 2013-15 budget process. The Board adopted OAR 335-085-0010 to implement this license category, effective July 1, 2013. Temporary licenses are valid for up to 6 months, and its current uses are:

- To allow an applicant to be licensed while awaiting final transcripts to be issued in the event that all degree requirements have been met, but the university only confers degrees at certain dates in the year.
- To allow applicants who are licensed after May 1<sup>st</sup> of odd-numbered years to be issued a lower-cost limited term initial license, since they will need to renew it by December 31<sup>st</sup>. This makes the initial costs fairer for licensees applying within a short time before the renewal deadline.
- Effective September 13, 2013, the Board created a new temporary Provisional SLPA license. This license allows an SLPA candidate to complete their clinical fieldwork outside of an academic practicum course without engaging in unlicensed practice.

### 2.d. Program (Agency) Overview

The Oregon State Board of Examiners for Speech-Language Pathology & Audiology (BSPA) is the agency that protects the public through the regulation of the practice of speech-language pathologists (SLPs), speech-language pathology assistants (SLPAs) and audiologists in Oregon. The agency comprises one

program. The Board has seven members who are appointed by the Governor, and consist of two audiologists, two SLPs, one physician specializing in otolaryngology, and two public members. The agency has two full-time staff: an Executive Director and an Administrative Assistant. The Board is currently recruiting for a full time investigator, and utilizes contract investigators currently.

### 2.e. <u>Program Funding Request</u>

BSPA is asking for funds to maintain the current program, and is also asking for a full time investigator (up from half time) as well as an investment in I.T. This will fund the existing full-time executive director and full-time administrative assistant, and a full time investigator to carry out BSPA's licensing,

### 2.f. <u>Program Description</u>

BSPA regulates the professional practice of speech-language pathology and audiology through reviewing credentials for licensure, ongoing monitoring of licensees through compliance audits, and investigating complaints regarding professional competence and conduct. BSPA issues licenses to qualified applicants on an ongoing basis, and renews licenses biennially.

BSPA references national standards developed by the American Speech-language Hearing Association (ASHA) regarding scope of practice, required education and training, and professional and ethical standards. BSPA also solicits input from the Oregon Academy of Audiology (OAA) and Oregon Speech-language Hearing Association (OSHA) regarding issues important to licensees.

### Cost Drivers

- Licensee Volume: The number of licensees continues to increase by about 11-14% per biennium. The number of licensees has increased by more than 48% in the last six years (since 2012). This impacts licensing, customer service, and investigation/compliance workload.
- Volume of Complaints & Disciplinary Actions: Complaints are investigated by the Executive Director, a contract investigator, and with input from clinical consultants as needed. The Board is in the process of hiring a full time investigator. The Board reviews the investigative report and relevant records, and may vote to revoke, suspend, reprimand, or deny a license, and/or to impose a civil penalty. The Board also is authorized to impose legal costs on a licensee. Investigative cases have increased five-fold since 2008, due to improved public education and awareness of the Board's role in public protection, increased utilization of speech-language pathology assistants, and increased Board-initiated compliance activities. This has increased investigative, administrative and legal costs, and slowed down the time to complete investigations and issue disciplinary notices. Implementation of enhanced criminal background checks in 2016 further increased the investigative caseload.



- **Statewide Initiatives:** Efforts such as information security and other planning and budgeting processes require significant agency administrative resources.
- Policy Initiatives: Researching and adopting best practices in the regulation of these professions requires administrative and legal resources.

### Stakeholders and Partners

BSPA works with applicants, licensees, national and state professional associations, other Oregon health professional regulatory boards, licensing boards in other states, members of the public, professional training programs, insurance companies, and state Medicaid representatives. Collaboration with these partners helps inform the Board's policy decisions, rule-making and compliance activities, and adoption of best practices. Since many Board licensees work in public schools, BSPA also works regularly with Oregon's Teacher Standards and Practices Commission (TSPC) and Department of Education (ODE) on issues of mutual interest. Significantly, BSPA is worked with the legislature to pass a bill in 2015 to eliminate the exemption from Board licensure for TSPC-

licensed SLPs who are initially licensed after June 30, 2016. This was the culmination of 5 years of policy work to standardize the licensure and professional development requirements for SLPs licensed in Oregon.

### **Professional Competence**

The Board has established educational and training standards for initial and renewed licensure for all licensees and audits the professional supervision of SLPAs by SLPs. Board rules also require licensees to accurately represent their credentials to their clients and the public.

BSPA has adopted ASHA standards for licensing SLPs and audiologists, who must hold graduate degrees (a master's for SLPs and a clinical doctorate for audiologists), complete a year of supervised clinical experience, and pass a national examination. Holders of the ASHA credential experience streamlined processing of their Oregon license application. ASHA has developed national guidelines for SLP and Audiology practice, and the Board frequently refers to ASHA policy statements and scope of practice when determining whether licensees meet the Board rule requiring that licensees perform all services competently. There is no national credential for SLPAs. SLPA licensure began in Oregon in 2003 as a response to SLP workforce and recruiting concerns, especially in rural areas. Oregon SLPA certification standards include the equivalent of an associate's degree, plus a 100-hour supervised clinical practicum. These measures support Strategy 5 by coordinating state regulations with national guidelines to improve mobility of the workforce.

Ongoing competence is addressed through Board rules for professional development (PD) for all licensees. SPA monitors compliance through random biennial audits. Licensees failing an audit are sanctioned and re-audited. Also, licenses are not renewed unless licensees attest to required PD. Competence is also addressed through Board rules regarding the SLPA scope of practice and ongoing professional supervision of SLPAs by qualified SLPs. Compliance is monitored through an annual audit, and violations are subject to disciplinary action.

### **Professional Conduct**

Board rules define unprofessional conduct and prohibit acts that abuse, defraud, mislead, or endanger clients or the public. BSPA monitors professional conduct by screening applicants for criminal or disciplinary history and by investigating complaints against licensees. BSPA conducts a rudimentary background check based on self-reported behavior of applicants for initial or renewed licenses, and the verification of good standing from other reported licensing jurisdictions for new applicants. No independent verification occurs. Raising Board standards for background checks through fingerprint based checks and verification of Oregon law enforcement history is a priority to improve the Board's role in public protection.

### Education/Outreach Efforts

A complaint form is available on line for members of the public, patients, or professionals to complete. Frequently concerns are reported via phone, then documented in writing and submitted to the Board. During 2019, the Board will prepare training materials on the SLPA and telepractic rules and "hit the road" to train administrators and licensees to ensure compliance. Board members and staff regularly table and speak at professional association meetings such

as the Oregon Audiology Association and the Oregon Speech-Language & Hearing Association. Staff also speak at the professional training programs of Portland State University and Pacific University in order to educate prospective licensees about their need to become licensed, and the Board's standards and its role in public protection. The Executive Director publishes a newsletter for all licensees and stakeholders 3-4 times per year to educate interested parties about policy matters and to help prevent violations of Board rules.

### 2.i. Enabling Legislation/Program Authorization

Statutory authority for this regulation is provided in ORS Chapter 681 and ORS Chapter 676 (for Health Professions Generally), and implemented through OAR Chapter 335.

### 2.j. <u>Funding Streams</u>

**BSPA's functions are entirely supported by Other Funds.** Licensing fees provide 99% of agency revenue; the remainder is from delinquent/late fees, civil penalties, interest income, and sales of licensee mailing lists.

## **Essential Packages**

**010** Non-PICS Personal Services/ Vacancy Factor—This package reflects an increase in Public Employees' Retirement System pension obligation bond payment calculated by the state, and an adjustment to the mass transit tax. These items total \$1,290. Vacancy savings is not anticipated.

**031 Standard Inflation and State Government Service Charges**—This package increases most Service and Supplies costs by amounts allowed by the state.

Attorney General fees have gone up by 43% and Total State Government Service Charges are projected to increase significantly as well.

## *Policy Package* 111—Investigative Workload & Background Checks SCR 83300-028-00-01-00000 – increase Investigator 2 position from half to full time.

*Purpose*—To conduct timely and professional investigations of complaints and compliance issues, and to implement enhanced criminal background checks, the Board needs to have trained professional investigative staff that is knowledgeable about Board and other State rules and expectations. This work is intrinsic to the Board's mission of public protection.

**Increased Caseload**—The Board's investigative caseload based on complaints and compliance issues, as well as criminal history reported on application, has increased dramatically over the past several years:

This increase is attributed to the public being better educated in consumerism, professionals being more diligent about reporting practice concerns, and licensees becoming more aware of their obligations to self-report incidents. It is also higher because the overall licensing volume has increased significantly since 2006. BSPA's investigative workload is expected to further increase over the next biennium.

Not only have the number of investigations increased, but several cases have addressed serious patient care and safety issues. At the same time, the Board has become more diligent about compliance with Board regulations that most impact public safety, such as appropriate SLPA supervision, ongoing professional development, and unlicensed practice.

Currently a significant amount of investigative work is performed by the Executive Director. Contracted SLP and audiologist clinical consultants are called upon for their professional expertise to assess the severity of complaints involving patient care, review patient records and assess clinical competence. Since October 2013, BSPA has also contracted with a licensed private investigator with health regulatory experience, but the resources available for these services are limited. Sometimes BSPA has been able to "piggy-back" on investigations conducted by other agencies to achieve Board goal, although confidentiality laws limit the amount of inter-agency collaboration possible. Increased workload and limited resources have caused delays in investigating complaints, implementing Board actions, and monitoring compliance with Board orders.

## Dedicated, trained investigative staff is needed to manage this caseload efficiently and effectively.

## How achieved—

This policy package includes funds requested to:

• Increase the 0.5 FTE Investigator 2 position to a full time 1.0 FTE position. Cost: \$53,282

## Affirmative Action Policy Statement:

It is the policy of BSPA that no person shall be discriminated against because of race, religion, national origin, gender, age, marital status, sexual preference or identity or disability.

## Affirmative Action 2017-19 Objectives and progress:

For 2017-19 the Board has worked to ensure diversity of its staff, contractors and Board. The Board has two full time staff persons and is led by a female Executive Director supported by a white male assistant who recently earned his Master's degree in Public Administration and is expected to move on to a management position in state government in the near future. The Executive Director is committed to following all affirmative action guidelines if and when that vacancy occurs. This current assistant is thoroughly committed to diversity and the Executive Director has encouraged and provided him the time to serve as a member of the Oregon Cultural Competency Committee. He has attended several meetings of this group which is implementing the new law encouraging health professionals take courses on the subject. For most of this biennium, the Board has been made up of seven women, one of whom is Asian American, and two whom are retired senior citizens. Two months ago a vacancy allowed the Board to add a young white male audiologist who also was born with a hearing loss and has worn hearing aids since he was a small child. The Board works with a contract investigator who is an African American and owns his own business. The Board's legal counsel from the Attorney General's office is African American. Although BSPA is a small organization, it has demonstrated a commitment to creating a diverse staff and Board, and works to ensure that day to day interactions with licensees and the general public are free of discrimination of all types.

## Affirmative Action 2019-21 Objectives:

The Board will continue to work to ensure diversity of its staff, Board and contractors during the 2019-21 Biennium. Speech-Language Pathologists and Audiologists work with a wide range of individuals in education and healthcare, so the Board's objective is to look more like the communities served by the professions. As such we hope to add at least one person to the Board who is fluent in Spanish as well as underserved communities in Portland and rural areas of the state. We look forward to working with the Governor's staff on increasing the Board member applicant pool through outreach and recruitment.
