On behalf of the member organizations listed below, the Oregon Revenue Coalition respectfully opposes these proposals to reduce or eliminate Oregon's estate tax. This tax on only the wealthiest estates should be protected.

In the coming biennium, repeal of the estate tax would cost Oregon \$341 million. These are funds that could be invested in affordable housing, senior services, or any number of other state priorities. Efforts to eliminate or scale back the estate tax would undermine funding for these services by leaving the dollars in the pockets of Oregon's wealthiest heirs. With just \$1 million of those \$341 million, Oregon could fund a full-time trauma-informed coordinator at 10 schools for a year or assist 50 families with down payment assistance for an affordable home.

The Oregon Revenue Coalition has adopted a set of principles that includes equity and progressivity (attached). The estate tax is one of the most progressive taxes in Oregon because it doesn't start until \$1 million, and then its rate rises, scaled to the size of the estate. White households are far more likely to have significant levels of wealth than are households of color. Thus, a tax on wealth, such as the estate tax, is one of the most important tools Oregon has to address equity in its tax code.

Thank you for considering our opposition to any bills weakening Oregon's estate tax, including Senate Bills 188, 304, 319, 674, and 701.
