## Criteria for Assessing Tax Breaks

In determining which of Oregon's approximately 368 tax expenditures ought to remain in law and which ought to be cancelled, as well as in formulating a position on new tax expenditure proposals, the 2019 Revenue Coalition has updated its criteria for assessing appropriateness. Among our recommendations to legislators is that the body should scrutinize tax-expenditure proposals first to determine whether a direct subsidy or budget allocation would more efficiently serve the desired ends.

Assuming that the answer is "no" to that preliminary question, tax expenditure proposals may be considered but ought to accomplish one of the following purposes:

- Promote public education and job training
- Fight poverty, hunger
- Break down barriers for communities of color
- Make housing more affordable [reasonably priced primary residences]
- Promote child welfare
- Make health care more affordable and accessible
- Help workers and the self-employed save for retirement
- Create good jobs
- Protect the environment, save energy
- Help victims of disasters and theft
- Promote charitable giving
- Assist people with disabilities (needs-based)
- Help military personnel and veterans (needs-based)
- Help low- and moderate-income seniors make ends meet
- Assist those of lower income to engage in the political process.

The evidence in support of these outcomes must be a part of the analysis for a tax expenditure – existing or proposed – to meet these criteria. Finally, the Coalition recommends that no new tax expenditure or expansion of an existing one be adopted without removing an existing tax break of equal cost but lesser policy value, thus making such a change at least revenue-neutral.

As the Revenue Coalition has evolved in its 18 years of existence, advocating for progressive revenue policies, it has adopted a set of values through which its members evaluate all tax-change proposals. Our analysis of policies looks for evidence of adequacy, equity, progressivity, and viability, and we embrace a secondary set of values, as well. These are stability, simplicity, horizontal fairness, and neutrality (that is, a change should not reward an entity for economic activity it would otherwise engage in without the tax break).

We hope that the Oregon Legislature keeps these, the criteria and values of Coalition members, in mind as you address Oregon's revenue system in 2019 and beyond.
