In 2017, the Vietnam War Memorial Fund was founded by the Committee on Memorials and Remembrance, a committee of the Vietnam Veterans of America Chapter 271 in Salem.

This non-profit corporation was established for the sole purpose of designing and building a Vietnam War Memorial on the Oregon State Capitol Grounds. Officers were elected and a Steering Committee was established.

The VWMF received its 501(c)3 tax exempt determination letter from the Internal Revenue Service in January, 2018.

The Steering Committee met during 2018 and reviewed various concepts for the proposed memorial. In December, 2018, the Steering Committee completed the review process and by consensus adopted concepts for the memorial.
