Dear Portland Area CSA Coalition,

I am the Farm Office and CSA Manager at Winter Green Farm in Noti, OR, and I am writing to express our support for **SB 727 and HB 2837**. This legislation is important to Oregon's CSA farms because it supports the expansion of Double Up Food Bucks Oregon (DUFB). This dollar-to-dollar SNAP matching program has proven to be successful across the state and has been very impactful for our own farm.

I have been the CSA Manager for the farm for 15 years now. We have an on Financial Asst. Fund with which we can help those in need have access to healthy food. Some folks still needed additional financing and would inquire about whether we could accept SNAP to help cover the cost of the share. For many years I called SNAP and tried to find a way to make that happen and finally, in 2013, I was able to make a breakthrough. We were able to accept SNAP for our low income members and that ability made all the difference in their lives and health.

By 2016, many CSA farms were accepting SNAP for payment. When the grant for the DUFB subsidy came about that year, that added assistance enabled even more low income families to be able to access the vegetable programs and visit Farmers' Markets. I heard over and over how grateful the families were, and how the programs have changed their lives, their health, and their overall outlook on life.

Here are some of the things that our community had to say about how this program has benefited their lives:

"I just want to say that we so greatly appreciate the help we received with funding last year. It was a godsend. The generous donation we received allowed us to afford the full, regular share and we went on to get the additional fall share. It helped us eat healthy and right, a goal we've been striving to achieve for a while. Additionally, we were able to avoid our individual food intolerances/allergies because we knew we were only consuming the best, most nutritious whole foods! Thank you!"
