STATUTORY QUALIFICATIONS: ORS 342.930

- Twenty-four members appointed by the Governor; serving at the pleasure of the Governor:
 - Six administrators in common or union high school districts (KLEWITZ, MISHRA, PERRY, RICHARDSON)
 - Six contract teachers (HUMPHRIES, SCONCE, STRATTON, PELLICCI)
 - Six school board members in common or union high school districts at time of appointment (CASSIDY, GALLINAT, HARTSOCK)
 - Six persons not affiliated with common or union high school districts (JOHNSON, KHAN, MOYER, PURVINE)
- One member from each category may be retired prior to appointment if member had been previously employed as administrator or contract teacher in Oregon.
- At least one member from each category above shall be a resident of a district under 1,500 students:
 - COSGROVE – school board member; JOHNSON, PURVINE – not affiliated
- One from each category above shall be a resident of a district with 1,500 - 4,500 students:
 - PERRY, RICHARDSON – administrator; HUMPHRIES, PELLICI – teacher; CASSIDY – school board member
- One from each category above shall be a resident of a district over 4,500 students:
 - SCONCE, STRATTON – teacher; CASSIDY, GALLINAT, HARTSOCK – school board member; MOYER – not affiliated
- Members may serve beyond expired term for purposes specified in ORS 342.930(3)(a)

DUTIES AND AUTHORITY: ORS 342.815 to 342.937

- Elect chair and vice-chair
- Adopt rules
- Hear appeals from teachers dismissed by employing school district, to be heard by panel of three members appointed by the Superintendent of Public Instruction
- Conduct contested case hearings in accordance with ORS 183.310 to 183.550; issue subpoenas
