**TERM:** Franco Richardson completing unexpired 3-year term (March 1, 2019 – May 31, 2019)  
and then to serve 3-year term (June 1, 2019 – May 31, 2022)  
Sullivan 3-year term: March 15, 2019 – March 14, 2022

**APPOINTMENT/CONFIRMATION AUTHORITY:** ORS 673.410

**STATEMENT OF ECONOMIC INTEREST REQUIRED (ORS 244.050):** Not required

**STATUTORY QUALIFICATIONS:** ORS 673.410

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Seven members appointed by the Governor to three-year terms:
  - Four members holding CPA permits and actively engaged in public accountancy (FRONK, SULLIVAN, WRIGHT, YOUNG-OLIVER)
  - One member holding CPA permit for five years and employed in private industry, education or government or actively engaged in public accountancy practice (BRINK)
  - One public member (FRANCO RICHARDSON)
  - One public accountant licensed for five years and actively engaged in public accountancy (MORRIS)
- No more than three consecutive three-year terms until a period at least equal to the appointed terms has elapsed

**DUTIES AND AUTHORITY:** ORS 673.010 – 673.475

- Regulate the practice of public accounting
- Grant certificates to CPAs; license public accountants
- Adopt professional code of conduct for CPAs and public accountants
- Rulemaking
- Take disciplinary action against licensees
- Institute injunction proceedings to halt violations; appoint hearings officer
- Appoint Peer Review Committee; approve applications for operation of alternative peer review programs
- Allow holder of a license in another state (verified as being substantially equivalent in requirements or skills) to practice public accountancy in Oregon if the holder maintains a valid certificate and license in good standing as a certified public accountant
