STATEMENT OF ECONOMIC INTEREST REQUIRED (ORS 244.050): Not required

### **STATUTORY QUALIFICATIONS:** ORS 835.102

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Seven members; four year terms; eligible for reappointment
  - Members appointed with consideration of the different geographic regions of the state, with one member being a resident of the area east of the Cascade Range (FERGUSON)
  - No more than four members may belong to the same political party (CASE R), (FERGUSON R), (GRANATO D), (MEEKER R), (PETERS D), (PEREYO NAV), (WASHINGTON-I)
- Board membership shall represent diverse aviation interests from both the private and public sectors
- Governor appoints chair and vice-chair

#### **DUTIES AND AUTHORITY: ORS Chapter 835**

- Shall incorporate in its program a definite plan for the development of airports, state airways, airplane industries and aviation generally
- Cooperate with and assist the federal government, state municipalities, and other persons in the development of aviation activities
- May perform such acts, adopt or amend and issue such orders, rules and regulations, and make, promulgate and amend minimum standards as necessary to perform its duties
- Rules and regulations shall be in conformance with and limited as nearly as possible to federal regulations
- Meet at least once quarterly
- May provide an official seal
