OFFICE: Marine Board, State

APPOINTEE: Laura Jackson of Portland; New appointment and reappointment

TERM: Completing unexpired 4-year term (March 1, 2019 – June 30, 2019) and then to serve a 4-year term (July 1, 2019 – June 30, 2023)

APPOINTMENT/CONFIRMATION AUTHORITY: ORS 830.105

STATEMENT OF ECONOMIC INTEREST (ORS 244.050): Required.

STATUTORY QUALIFICATIONS: ORS 830.105

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Five members, appointed to four-year terms and serving at the pleasure of the Governor (CASTRONOVO, EARLY, JACKSON, TONNESON, WITHEE)
- Must be U.S. citizens and residents of Oregon for at least one year

DUTIES AND AUTHORITY: ORS 830.110

- Appoint State Marine Director;
- General rulemaking;
- Devise boat identification numbers;
- Cooperate with agencies to promote uniformity;
- Advise and assist county sheriffs and other peace officers in the enforcement of laws relating to boating;
- Study, plan and recommend the development of boating facilities throughout the state which will promote the safety and pleasure of the public through boating;
- Publicize the advantage of safe boating;
- Exempt from any provisions of this chapter any class of boats if it determines that the safety of persons and property will not be materially promoted by the applicability of those provisions to the class of boats;
- Appoint and require the bonding of agents to issue a temporary permit to operate a boat. In addition to the prescribed fees, the agents may charge the following for their services in issuing the temporary permit:
 - \$2.50 per transaction for calendar years 2008, 2009 and 2010;
 - \$3.75 per transaction for calendar years 2011, 2012 and 2013; and
 - Beginning in 2014, and every three years thereafter, the board shall issue an order revising the fee specified in paragraph (b) of this subsection on January 1, based on changes in the Portland-Salem, OR-WA, Consumer Price Index for All Urban Consumers for All Items, as published by the Bureau of Labor Statistics of the United States Department of Labor.

- Publish and distribute to the interested public the boating laws of this state and resumes or explanations of those laws; any application required under this chapter and require the use of such forms;
- Adopt rules for the following:
 - Uniform navigational marking of the waters of this state;
 - Marine toilets and their use consistent with the prevention and control of pollution of the waters of this state and not in conflict with the rules of the Oregon Health Authority or the Environmental Quality Commission.
 - Regulation of water ski course markers, ski jumps and other special use devices placed in the waters of this state. Such rules may regulate the installation and use of the devices and may require a permit.
 - Necessary to carry out and enforce the provisions of ORS 830.950 and 830.955.
 - Establishment of a Safe Boating Education Course to be made available to courts and law enforcement agencies within this state for use as a sentencing option for those individuals convicted of boating offenses
- Institute proceedings to enjoin unlawful obstructions injuring free navigation on the waters of this state.
