- Eleven members
  - Two legislators appointed by the President of the Senate and the Speaker of the House for twoyear terms (SEN. GELSER, REP. ALONSO LEON) – Not subject to Senate confirmation
  - Nine members appointed by the Governor for three-year terms (CASTILLO, CHAVEZ BAEZ, ESPINOZA VALDEZ, GALLEGOS, LOPEZ-CEVALLOS, MORALES, SALINAS, vacant, vacant)
- Appointments shall be made to insure representation of Hispanics in Oregon
- Appointments, to the extent possible, shall provide for representation from all areas of the state

## <u>DUTIES AND AUTHORITY:</u> ORS 185.320 – 185.330

- Elect a chairperson and vice-chairperson
- Monitor existing programs and legislation designed to meet the needs of Hispanics
- Recommend actions to the Governor and Legislative Assembly following research of problem areas
- Maintain a liaison between the Hispanic community and government entities
- Encourage Hispanic representation on state boards and commissions
- Meet at least annually in a joint meeting of the Commission on Hispanic Affairs, the Commission on Black Affairs, the Commission for Women, and the Commission on Asian and Pacific Islander Affairs
