

Dear Members of the Health Committee:

Creating a mandate on vaccines to attend school is discriminatory and a form of negligence on the part of the legislature because you obviously are only listening to what the pharmaceutical industry lobbyists are telling you. In 1986, Congress passed the National Childhood Vaccine Injury Act of 1986 which stated that "no vaccine manufacturer shall be liable in a civil action for damages arising from a vaccine-related injury or death. <https://www.congress.gov/bill/99th-congress/house-bill/5546>

The 1986 Act established the Vaccine Adverse Events Reporting System (VAERS) operated by HHS and co-sponsored by the CDC and FDA. VAERS is a passive, not mandatory, reporting system. Less than 1% of adverse events are reported because most people, or consumers of the vaccine products, know NOTHING about it.

As part of the 1986 Act, HHS is required to create a task force and submit bi-annual reports to Congress detailing actions taken to ensure vaccine safety.
